### NYPD's Proposed Revisions

•November 5, 2021 the NYPD issued proposed revisions to the Matrix for public comment.

•6 page document updates 4 sections.

# NYPD's Proposed Revisions

Abuse of Authority

- •5 additional allegations of misconduct
  - Stop & Question or Question of a person
  - Refuse to show arrest/search warrant
  - Improper/wrongful question of person's immigration status
  - Fail to provide language interpretation service
    Improper/wrongful damage person's property

## NYPD's Proposed Revisions

Progressive DisciplineClarifying language

## **CCRB's Proposed Revisions**

CCRB submitted the following proposed revisions:

Clarifying language of Progressive Discipline
One-time penalty deviation option for junior officers
7 additional allegations for Abuse of Authority
1 additional allegation for Improper Use of Force
Training and compliance by DCT Trial Commissioners

# Progressive Discipline Calculation

- •Confusing
- •Discretionary Ranges
- Calculations based on penalties imposed pre-Matrix
  Offensive Language
- •NYPD attempted to address with footnote
- •CCRB suggests that days enhance recommended penalty for current act of misconduct

One-Time Penalty Reduction for Junior Officers

MOS on the force for less than 2 years; and
Commits an act of misconduct where the mitigated is a penalty of a CD-A

One-time penalty reduction to Training

 Question incorporated into Stop
 Penalty will always run concurrent with a Stop

• Unlike Stop, Frisk, Search which all run consecutive

 Lower penalties than requested (10/20/5) Body Cavity Search
