**UPDATED ADVISORY: The Civilian Complaint Review Board to Hold
Monthly Public Board Meeting in Brooklyn**

New York, NY – The Civilian Complaint Review Board (CCRB) will hold its monthly Board Meeting at Medgar Evers Oasis Beacon Program located at P.S./I.S. 323, on July 12, 2017 at 6:30 p.m.

Community leaders, NYPD officials, and members of the public will be in attendance for a discussion on civilian oversight. CCRB policy staff will highlight complaint trends in the 73rd Precinct and neighboring areas, as well as information from CCRB's newest [report](#) on officer interference in civilian recordings of police. Community leaders and advocates will share their experiences with police-community interactions including questions surrounding the rollout of body-worn cameras.
