**CCRB to Convene Panel Discussion on Future of Oversight in New York City**

*The panel will provide recommendations for the City's policing reform plan*

**New York, NY** – The New York City Civilian Complaint Review Board (CCRB) will convene a panel discussion of New York City oversight agencies **on Wednesday, December 16 at 5:30 p.m.** The discussion is being held in response to Governor Cuomo's Executive Order 203, "[New York State Police Reform and Reinvention Collaborative](#)", and will provide recommendations on how New York City can strengthen civilian oversight of the NYPD.
