## CCRB to Hold Public Hearing on Proposed Rules like Investigating Bias-Based Policing and Self-Initiating Complaints

The CCRB will allow for public comment on its proposed rule changes during its July board meeting.

**NEW YORK** – Tomorrow, the Civilian Complaint Review Board (CCRB) will host its monthly board meeting updating the public on Agency news. The meeting will also consist of a section dedicated to public comment on the CCRB's proposed rule changes. The changes will, among other things, allow the agency to self-initiate complaints, investigate bias based policing, racial profiling and improper use of Body Worn Cameras, simplify the language related to dispositions, and make the investigative process more transparent.
