CCRB 2020 PROTEST DATA SNAPSHOT – DECEMBER 23, 2021

The CCRB received over 750 complaints relating to the behavior of NYPD officers at the Black Lives Matter protests over the 2020 summer.

Those complaints resulted in 318 complaints containing over 2,000 allegations that fall within CCRB’s jurisdiction covering over 480 identified members of service. Since the summer, the CCRB has been working diligently to thoroughly investigate these complaints.

The CCRB has seen unprecedented challenges in investigating these complaints particularly around the identification of officers due to the failure to follow proper protocols, officers covering their names and shield, officers wearing protective equipment that did not belong to them, the lack of proper use of body worn cameras, as well as incomplete and severely delayed paperwork.

SUBSTANTIATED MISCONDUCT

So far, the CCRB has **substantiated 53 complaints** of misconduct containing **108** allegations against **80** officers. The Board has recommended serving Charges in **47** complaints, Command Discipline B in **12** complaints, and Command Discipline A in **23** complaints. The current substantiation rate in fully-investigated protest complaints is **36%**.

The NYPD has finalized 12 cases and only imposed discipline against 3 officers.
