Executive Summary

The Civilian Complaint Review Board ("CCRB") is an independent municipal Agency that investigates complaints of NYPD misconduct. Every month, the CCRB prepares an Executive Director report for its public meeting. Data for March 2025 included the following highlights:

- 1) Of the cases in the CCRB active investigations docket, 46% have been open for 4 months or fewer, and 64% have been open for 7 months or fewer (page 10). In March, the CCRB opened 462 new cases (page 4), and currently has a total open docket of 2,963 cases (page 11).
- 2) The CCRB substantiated allegations in 49% of its fully investigated cases in March (page 17).
- 3) The CCRB fully investigated 41% of the cases it closed in March (page 14).
- For March, investigations using video evidence resulted in substantiated allegations in 50% of cases - compared to 33% of cases in which video was not available (page 24).
- 5) The Monthly Report includes a breakdown of complaints and substantiations by NYPD precinct and borough of occurrence (pages 5-6, 39-48).
- 6) In March the Police Commissioner finalized 11 decision(s) against police officers in Administrative Prosecution Unit (APU) cases (page 30). The CCRB's APU prosecutes the most serious allegations of misconduct. The APU conducted 3 trials against members of the NYPD year-to-date; 1 trial was conducted against respondent officers in March.

The CCRB is committed to producing monthly reports that are valuable to the public, and welcomes feedback on how to make its data more accessible.

Glossary

In this glossary we have included a list of terms that regularly appear in our reports.

Allegation: An allegation is a specific act of misconduct. The same "complaint" can have multiple allegations – excessive force and discourteous language, for example. Each allegation is reviewed separately during an investigation.

APU: The Administrative Prosecution Unit is the division of the CCRB that has prosecuted "charges" cases since April 2013, after the signing of a 2012 Memorandum of Understanding between the CCRB and NYPD.

Board Panel: The "Board" of the CCRB has 15 members. Following a completed investigation by the CCRB staff, three Board members, sitting as a Board Panel, will make a finding on whether misconduct occurred and will make a recommendation on what level of penalty should follow.

Case/Complaint: For the purposes of CCRB data, a "case" or "complaint" is defined as any incident within the Agency's jurisdiction, brought to resolution by the CCRB.

Disposition: The Board's finding as to the outcome of a case (i.e. if misconduct occurred).

FADO: Under the City Charter, the CCRB has jurisdiction to investigate the following categories of police misconduct: Force, Abuse of Authority, Discourtesy and Offensive Language, collectively known as "FADO".

FADO&U: A ballot measure revising the New York City Charter, which passed on November 5, 2019, authorized the CCRB to investigate the truthfulness of an official statement made by a subject officer during a CCRB investigation into a FADO allegation. This expanded jurisdiction—Force, Abuse of Authority, Discourtesy, Offensive Language, and Untruthful Statements (FADO&U)—went into effect on March 31, 2020.

Intake: CCRB's intake team initially handles complaints from the public. Intake takes complaints that come via live phone calls, voicemails, an online complaint form, or in-person.

Investigation: CCRB investigators gather evidence and interview witnesses to prepare reports on misconduct allegations. An investigation ends when a closing report is prepared detailing the evidence and legal analysis, and the case is given to the Board for disposition.

Mediation: A complainant may mediate his or her case with the subject officer, in lieu of an investigation, with the CCRB providing a neutral, third-party mediator.


Unable to Investigate: A catch-all term, used for reporting purposes only, that refers to cases where the CCRB was unable to conduct an investigation, typically because no statement could be obtained from the complainant/alleged victim. "Unable to Investigate" incorporates the following CCRB dispositions: "Complainant/Alleged Victim Uncooperative", "Complainant/Alleged Victim Unavailable", "Witness Uncooperative", "Witness Unavailable", "Victim Unidentified", "OMB PEG Directive Closure", and "SRAD Closure."


Withdrawn: When the complainant/alleged victim asks that their complaint be withdrawn, the case is closed as "Withdrawn."

Closed Pending Litigation: When a complainant is involved in criminal or civil litigation, and declines to cooperate with an investigation on the advice of their attorney, the complaint disposition is "Closed Pending Litigation."

Complaints Received




Figure 2: New CCRB Complaints by Month (January 2024 - March 2025)




Figure 3: New CCRB Complaints by Year (YTD 2010 - YTD 2025)

The CCRB's Intake team processes misconduct complaints from the public and referrals from the NYPD. Under the New York City Charter, the CCRB's jurisdiction is limited to allegations of misconduct related to Force, Abuse of Authority, Discourtesy and Offensive Language. All other complaints are referred to the appropriate agency. Figure 1 refers to all complaints that the CCRB receives and Figures 2 and 3 refer to new cases that remain with the Agency. In March 2025, the CCRB initiated 462 new complaints.





Figure 4: CCRB Complaints Received By Borough of Occurrence (March 2025)

As described in the previous section, the CCRB has jurisdiction over four categories of NYPD misconduct. The charts below show what types of allegations are contained in the CCRB complaints received.




Figure 7: CCRB Complaints Received By Type of Allegation (March 2024 vs. March 2025)




Figure 9: CCRB Complaints Received By Type of Allegation (YTD 2024 vs. YTD 2025)





Figure 15: Number of Active Investigations (January 2024 - March 2025)

Body Worn Camera Footage Requests

Since the widespread roll out of body worn cameras in 2018, the collection of footage from these cameras has become an integral part of CCRB investigations.

The timeliness of the response to BWC footage requests has a direct impact on the length of time it takes to complete an investigation. The longer it takes to fulfill BWC requests, the longer CCRB investigations remain on the open docket.





Figure 18: Average Days To Recieve Positive Return on BWC Requests (January 2024 - March 2025)







Figure 21: Fulfilled BWC Requests (January 2024 - March 2025)



Closed Cases

In March 2025, the CCRB fully investigated 41% of the cases it closed.





Dispositions

Cases fully investigated by the CCRB generally receive one of five outcomes:

- If the alleged misconduct is found to have occurred, based on the preponderance of the evidence, the allegation is closed as **substantiated**.
- If there is not enough evidence to determine whether or not the alleged misconduct occurred, the allegation is closed as **unable to determine**.*
- If the preponderance of the evidence suggests that the event or alleged act did not occur, the allegation is closed as **unfounded**.
- If the event did occur, but was not improper by a preponderance of evidence, the allegation is closed as **within NYPD guidelines**.**
- If the CCRB was unable to identify any of the officers accused of misconduct, the case is closed as **officer unidentified**.

Case Abstracts

The following case abstracts are taken from complaints closed this month and serve as examples of what the different CCRB dispositions mean in practice:

1. Substantiated

An individual stated that he was experiencing a mental health crisis and hid in a neighbor's backyard from police looking for him. He eventually came out of hiding. Subject officer 1 proceeded to punch the individual several times in his face. The subject officers also did not properly activate their BWCs during the incident. The incident was partially captured on BWC. It showed the individual was standing on a patio when subject officer 1 grabbed him and the individual punched subject officer 1 once in the head. Subject officer 1 responded by punching the individual in his face while subject officer 2 tried to maintain a hold on him. The individual fell to the ground wherein subject officer 1 used his body weight to hold the individual down and continued to punch him in the face several times. The investigation found that both subject officers significantly outweighed the individual, were both aware that the individual no longer actively resisted but was still subjected to repeated punches by subject officer 1. The investigation also found that subject officer 1 deactivated his BWC after conferring with supervisors during the individual; subject officer 2 only activated his BWC after he had entered the individual's home during the search. The Board substantiated the Use of Force and Abuse of Authority allegations.

2. Unable to Determine

An individual stated that she and two friends tried to go through a turnstile at a subway station. One friend turned back to tap his payment card so that she could go through, but it didn't work. Her other friend went to purchase a MetroCard while she waited by the turnstiles with the friend who was standing on the other side of the turnstile. The subject officer and another officer who were nearby approached them. The subject officer asked why the individual was looking at them and why she was trying to evade the fare – he spoke in English. The individual responded in Spanish, and he responded in English "I will look at you however I want to bitch. The individual" striend told the officer that she only spoke Spanish. In Spanish the subject officer called the individual "stupid". The incident was only partially captured on BWC. It showed the individual and her friend by the turnstiles speaking to the officer – the audio only came on as the subject officer told the individual to leave the station in Spanish. The other officer did not speak Spanish and stated the entire dialogue was in Spanish. The subject officer denied using any profanity or calling the individual stupid. Without any independent witnesses or audio footage, the investigation could not determine if the subject officer spoke discourteously or

used offensive language towards the individual. The Board closed the Discourtesy and Offensive Language allegations as Unable to Determine.

3. Unfounded

An individual stated that while she was being arrested, she saw subject officer 1 push a bystander and prevent him from recording and that as she was being escorted outside, she asked to change her clothes and subject officer 2 responded "no, fuck that. She's going just like this". The incident was captured on BWC. It showed that subject officer 1 stuck his arm out to prevent a bystander from getting too close to him and told the individual that he could continue recording as long as he maintained a reasonable distance from the officers. It showed subject officer 2 denying the individual's request to change clothes without the use of any profanity towards the individual. The Board closed the Use of Force and Discourtesy allegations as Unfounded.

4. Within NYPD Guidelines

An individual stated that he refused to allow the DOB inspectors to enforce a stop work order on his building and FDNY and several officers responded to the location. He stated that subject officer 1 pushed him several times when he tried to join a conversation and that the subject officer 1 and 2 entered the property. The incident was captured on BWC. It showed the individual trying to physically interrupt the conversation between the officers and the DOB inspectors who were on site to enforce a stop work order. Subject officer 1 told him that it was a private conversation as he stood approximately two feet away. Subject officer 1 instructed the individual to move back at least three times for officer safety and when the individual did not move, subject officer 1 placed a hand on his chest and pushed him back approximately three feet and told him this distance was sufficient. There were no additional pushes. Subject officer 1 and 2 also entered the property after FDNY opened it to allow the DOB inspectors inside. The investigation found that subject officer 1 used the minimal amount of force after the individual refused multiple directives to stand back. The investigation also found that the stop work order authorized officers to assist the DOB inspectors to carry out their work and maintain peace - their entry was an administrative function governed by the stop work order. The Board closed the Abuse of Authority and Use of Force allegations as being Within NYPD Guidelines.

5. Officer Unidentified

An individual stated that she was collecting bottles when she and two civilians got into a fight. One of the civilians bit her on the shoulder and they ran off when she called 911. Officers responded to the location and one of them called her crazy. The individual requested an ambulance to treat her shoulder. The ambulance arrived, and she was pushed to it by an officer, causing her to break a toenail. While in the ambulance, an officer called her a "crazy bitch" and that same day an officer called her and told her that he would kill her. The individual gave a physical description of the officers. The investigation found that there were no ambulance dispatches to the incident location, nor any NYPD records of a 911 call, nor any records of any NYPD vehicles being in the vicinity of the incident location. Without additional pertinent information, the investigation could not identify the subject officers. The Board closed the Abuse of Authority, Discourtesy, Force, and Offensive Language allegations as Officer Unidentified.

^{*} Unable to determine is reported to the Commissioner as Unsubstantiated, meaning that there was insufficient evidence to establish whether or not there was an act of misconduct.

^{**} Within NYPD Guidelines is reported to the Commissioner as Exonerated, meaning there was a preponderance of the evidence that the acts alleged occurred but did not constitute misconduct.





Figure 24: Disposition Counts of Full Investigations (YTD 2025)

Dispositions - Untruthful Statement Allegations

The CCRB investigates untruthful statement allegations under two different allegation categories. Official statements made directly to the CCRB are investigated under the "Untruthful Statement" allegation category. Official statements made in other contexts (e.g. in court) are investigated under the "Abuse of Authority" allegation category.

All the untruthful official statement allegations are mutually exclusive, meaning that the CCRB will not plead more than one untruthful statement allegation against an officer for the same untruthful act. There are four distinct types of untruthful statement allegation as follows: 1) False official statement, 2) Misleading official statement, 3) Inaccurate official statement and 4) Impeding an investigation.


Figure 31: Substantiated Bias-Based Policing Allegations with % Change

In general, investigations relying on video evidence result in much higher substantiation rates.







Figure 36: Substantiation Rates for Full Investigations with Video (Jan 2024 - Mar 2025) (% substantiated shown)



Board Discipline Recommendations for Substantiated Officers

After a CCRB investigative team has completed its investigation, a panel of Board members determines whether to substantiate the allegation(s) and make a disciplinary recommendation against the officer(s).

- "Charges and Specifications" are the most severe form of discipline. A decision to assign Charges commences a process that may result in an administrative trial in the NYPD Trial Room. An officer may lose vacation days, be suspended, or be terminated if the officer is found guilty.
- "Command Discipline B" and "Command Discipline A" are recommended for misconduct that is moderately serious. An officer can lose up to ten vacation days as a result of Command Discipline B and up to five vacation days as a result of Command Discipline A.
- "Formalized Training" are the least severe discipline, often recommended for officers who misunderstand a policy. This determination results in training at the Police Academy or NYPD Legal Bureau (Formalized Training).
- When the Board has recommended Formalized Training or Command Discipline, the case is sent to the NYPD Commissioner to impose training and/or other penalties. Cases where the Board recommends charges are prosecuted by the CCRB's Administrative Prosecution Unit.

With the adoption of the NYPD Disciplinary Matrix on 03/15/2021, the CCRB no longer issues Instructions as a Board Discipline Recommendation.

Following the adoption of the NYPD Disciplinary Matrix on 03/15/2021, the Board Discipline Recommendation for each officer is determined by the sum of the Matrix penalty days associated with the allegation(s) substantiated against the officer as follows: 1. Charges (penalty days >= 11) 2. Command Discipline B (6 <= penalty days <= 10) 3. Command Discipline A (1 <= penalty days <= 5) 4. Formalized Training (0 < penalty days <1)

**Officer Retired/Resigned: CCRB closes an investigation if it learns that the subject officer has left the Department. In a small number of cases, CCRB will also close an investigation against a subject officer who is on extended leave and who will not be available for interview until after the Statute of Limitations has expired. These cases are elsewhere reported as "Miscellaneous" closures.

***Administrative Closure is a special category that deals with NYPD's Internal Affairs Bureau-referred cases or spin off cases with no complainant/alleged victim, and in which CCRB attempts to locate or identify a complainant/alleged victim has yielded no results.

Mediation Unit

Whenever mediation between a complainant/alleged victim and subject officer is suitable, it is offered by CCRB investigators. If the complainant/alleged victim and subject officer both agree to participate, a neutral, third-party mediator facilitates a conversation between the parties. The chart below indicates the number of mediations in March and this year.

Administrative Prosecution Unit

The CCRB's Administrative Prosecution Unit (APU) prosecutes police misconduct cases when the Board has recommended charges, in the NYPD Trial Room. The APU is also able to offer pleas to officers who admit guilt rather than going to trial. Following a plea agreement or the conclusion of a disciplinary trial, cases are sent to the Police Commissioner for final penalties.
