Executive Summary

The Civilian Complaint Review Board ("CCRB") is an independent municipal Agency that investigates complaints of NYPD misconduct. Every month, the CCRB prepares an Executive Director report for its public meeting. Data for April 2025 included the following highlights:

- 1) Of the cases in the CCRB active investigations docket, 45% have been open for 4 months or fewer, and 63% have been open for 7 months or fewer (page 10). In April, the CCRB opened 480 new cases (page 4), and currently has a total open docket of 3,021 cases (page 11).
- 2) The CCRB substantiated allegations in 67% of its fully investigated cases in April (page 17).
- 3) The CCRB fully investigated 27% of the cases it closed in April (page 14).
- For April, investigations using video evidence resulted in substantiated allegations in 68% of cases - compared to 33% of cases in which video was not available (page 24).
- 5) The Monthly Report includes a breakdown of complaints and substantiations by NYPD precinct and borough of occurrence (pages 5-6, 44-53).
- 6) In April the Police Commissioner finalized 14 decision(s) against police officers in Administrative Prosecution Unit (APU) cases (page 30). The CCRB's APU prosecutes the most serious allegations of misconduct. The APU conducted 4 trials against members of the NYPD year-to-date; 1 trial was conducted against respondent officers in April.

The CCRB is committed to producing monthly reports that are valuable to the public, and welcomes feedback on how to make its data more accessible.

Glossary

In this glossary we have included a list of terms that regularly appear in our reports.

Allegation: An allegation is a specific act of misconduct. The same "complaint" can have multiple allegations – excessive force and discourteous language, for example. Each allegation is reviewed separately during an investigation.

APU: The Administrative Prosecution Unit is the division of the CCRB that has prosecuted "charges" cases since April 2013, after the signing of a 2012 Memorandum of Understanding between the CCRB and NYPD.

Board Panel: The "Board" of the CCRB has 15 members. Following a completed investigation by the CCRB staff, three Board members, sitting as a Board Panel, will make a finding on whether misconduct occurred and will make a recommendation on what level of penalty should follow.

Case/Complaint: For the purposes of CCRB data, a "case" or "complaint" is defined as any incident within the Agency's jurisdiction, brought to resolution by the CCRB.

Disposition: The Board's finding as to the outcome of a case (i.e. if misconduct occurred).

FADO: Under the City Charter, the CCRB has jurisdiction to investigate the following categories of police misconduct: Force, Abuse of Authority, Discourtesy and Offensive Language, collectively known as "FADO".

FADO&U: A ballot measure revising the New York City Charter, which passed on November 5, 2019, authorized the CCRB to investigate the truthfulness of an official statement made by a subject officer during a CCRB investigation into a FADO allegation. This expanded jurisdiction—Force, Abuse of Authority, Discourtesy, Offensive Language, and Untruthful Statements (FADO&U)—went into effect on March 31, 2020.

Intake: CCRB's intake team initially handles complaints from the public. Intake takes complaints that come via live phone calls, voicemails, an online complaint form, or in-person.

Investigation: CCRB investigators gather evidence and interview witnesses to prepare reports on misconduct allegations. An investigation ends when a closing report is prepared detailing the evidence and legal analysis, and the case is given to the Board for disposition.

Mediation: A complainant may mediate his or her case with the subject officer, in lieu of an investigation, with the CCRB providing a neutral, third-party mediator.

Unable to Investigate: A catch-all term, used for reporting purposes only, that refers to cases where the CCRB was unable to conduct an investigation, typically because no statement could be obtained from the complainant/alleged victim. "Unable to Investigate" incorporates the following CCRB dispositions: "Complainant/Alleged Victim Uncooperative", "Complainant/Alleged Victim Unavailable", "Witness Uncooperative", "Witness Unavailable", "Victim Unidentified", "OMB PEG Directive Closure", and "SRAD Closure."


Withdrawn: When the complainant/alleged victim asks that their complaint be withdrawn, the case is closed as "Withdrawn."

Closed Pending Litigation: When a complainant is involved in criminal or civil litigation, and declines to cooperate with an investigation on the advice of their attorney, the complaint disposition is "Closed Pending Litigation."

Complaints Received




Figure 2: New CCRB Complaints by Month (January 2024 - April 2025)




Figure 3: New CCRB Complaints by Year (YTD 2010 - YTD 2025)

The CCRB's Intake team processes misconduct complaints from the public and referrals from the NYPD. Under the New York City Charter, the CCRB's jurisdiction is limited to allegations of misconduct related to Force, Abuse of Authority, Discourtesy and Offensive Language. All other complaints are referred to the appropriate agency. Figure 1 refers to all complaints that the CCRB receives and Figures 2 and 3 refer to new cases that remain with the Agency. In April 2025, the CCRB initiated 480 new complaints.

Figure 1: Total Intake by Month (January 2024 - April 2025)





Figure 4: CCRB Complaints Received By Borough of Occurrence (April 2025)

As described in the previous section, the CCRB has jurisdiction over four categories of NYPD misconduct. The charts below show what types of allegations are contained in the CCRB complaints received.




Figure 7: CCRB Complaints Received By Type of Allegation (April 2024 vs. April 2025)




Figure 9: CCRB Complaints Received By Type of Allegation (YTD 2024 vs. YTD 2025)





Figure 15: Number of Active Investigations (January 2024 - April 2025)

Body Worn Camera Footage Requests

Since the widespread roll out of body worn cameras in 2018, the collection of footage from these cameras has become an integral part of CCRB investigations.

The timeliness of the response to BWC footage requests has a direct impact on the length of time it takes to complete an investigation. The longer it takes to fulfill BWC requests, the longer CCRB investigations remain on the open docket.




Figure 18: Average Days To Recieve Positive Return on BWC Requests (January 2024 - April 2025)







Figure 21: Fulfilled BWC Requests (January 2024 - April 2025)



Closed Cases

In April 2025, the CCRB fully investigated 27% of the cases it closed.





Dispositions

Cases fully investigated by the CCRB generally receive one of five outcomes:

- If the alleged misconduct is found to have occurred, based on the preponderance of the evidence, the allegation is closed as **substantiated**.
- If there is not enough evidence to determine whether or not the alleged misconduct occurred, the allegation is closed as **unable to determine**.*
- If the preponderance of the evidence suggests that the event or alleged act did not occur, the allegation is closed as **unfounded**.
- If the event did occur, but was not improper by a preponderance of evidence, the allegation is closed as **within NYPD guidelines**.**
- If the CCRB was unable to identify any of the officers accused of misconduct, the case is closed as **officer unidentified**.

Case Abstracts

The following case abstracts are taken from complaints closed this month and serve as examples of what the different CCRB dispositions mean in practice:

1. Substantiated

An individual stated that during a vehicle stop he was arrested and his vehicle seized. While his vehicle was at the precinct stationhouse in custody of the police department, the subject officer searched his vehicle. The incident was captured on BWC. It showed that the subject officer looked through the back window of the vehicle and removed a taser from the driver's door compartment, looked under the driver front seat and removed the individual's cellphone, looked around the center console and left a second cellphone and portable charger bank in the vehicle. The subject officer stated that he did not voucher the individual's vehicle because the vehicle was being released to the individual's spouse. The investigation found that the subject officer was required to conduct an inventory search, remove all valuable items, and prepare a voucher for the items removed from the vehicle before it is returned to anyone. The Board substantiated the Abuse of Authority allegation.

2. Unable to Determine

An individual stated that he was riding an electric motorcycle when he noticed a marked police vehicle activate its lights and sirens behind him. The individual stated that his vehicle did not have a license plate, and he was not wearing a helmet. He stated that he had also run a red light. He believed that the police vehicle wanted to pass him to respond to an emergency call, so he pulled over to the side of the road to let the vehicle pass. As he pulled over, the police vehicle, driven by the subject officer swerved towards him, almost striking him. The individual in fear drove away from the police vehicle and was subsequently pursued by the police vehicle. The subject officer stated that he had driven close to the individual for a time without his lights and sirens on because he wanted to speak to the individual after he had observed him run two red lights. He then turned the lights and sirens on after the individual began to flee from him. The incident was partially recorded on BWC. It showed the subject officer driving close to the individual's vehicle but it did not show whether the subject officer intentionally tried to ram the individual's vehicle. The Board closed the Use of Force allegation as Unable to Determine.

3. Unfounded

An individual stated that he was double parked with the engine on and his driver window down in front of his partner's building. His partner had gone instead to drop off a package. While waiting for his partner the subject officer along with two other officers pulled up behind the individual's vehicle in an unmarked vehicle. They approached the individual's vehicle, the subject officer going to the driver's window. He asked the individual for his driver's license. The individual provided it and started to roll his window up. The subject officer ordered him to stop, reached in through the open window to open the car door and tried to pull the individual out of the vehicle by pulling on his wrists, his shirt collar and then the sides of his neck. The incident was recorded by the individual's partner. It showed the subject officer alternating with pulling on the individual's wrists and his jacket's shoulder. He did not put his hands on the individual's neck. The Board closed the Use of Force allegation as Unfounded.

4. Within NYPD Guidelines

An individual stated that he saw a news report on YouTube that stated that his brother had been attacked and killed a dog in his home. The individual stated that he went to the hospital to see his brother's body, but officers refused him access so he believed that the police had shot and killed his brother. The investigation found that several civilian witnesses at the individual's apartment building had called 911 because they heard a dog attacking the individual's brother. The girlfriend of the individual's brother had also called in a similar report. The following was captured on BWC - the two subject officers responded to the apartment and the individual's brother's girlfriend was inside the apartment. The subject officers witnessed the dog actively attacking the individual's brother and after yelling at the dog to stop, each fired two shots at the dog, killing the dog. The individual's brother was taken to the hospital by EMS. The investigation found that medical records showed that the individual's brother did not sustain any gunshot injuries and succumbed to the injuries from the dog attack that had resulted in substantial blood loss. The investigation found that the subject officers had a reasonable belief that there was an ongoing emergency at the individual brother's home due to the volume and nature of the 911 calls that stated that a man was being attacked by a dog in home, including the individual's brother's girlfriend was inside the apartment during the dog attack. The investigation also found that the subject officers discharging their firearms at the dog was justified because the dog was still attacking the individual's brother when they arrived and doing so was to protect both themselves and the individual's brother's girlfriend from harm. The Board closed the Abuse of Authority and Use of Force allegations as being Within NYPD Guidelines.

5. Officer Unidentified

An individual stated that while he was being fingerprinted at the precinct stationhouse subject officer 1 threatened to have ESU break his wrist if he refused to be fingerprinted, pushed him into a cell causing injury. He requested the name of subject officer 2 who was seating near the cells and the officer ignored his request. He then requested the name and shield numbers of all the officers' present and they ignored his request. The individual gave a general description of the officers. The investigation found that three officers were named in the arrest and transport documents concerning the individual and one of them did not match the individual's description while the other two somewhat matched the individual's description. The officers in the precinct at the time of the incident also did not match the individual's description. The officers denied that they sued force or threatened to use force against the individual, nor refuse to provide their name to the individual. Without additional pertinent information, the investigation could not identify the subject officers. The Board closed the Abuse of Authority and Use of Force allegations as Officer Unidentified.

^{*} Unable to determine is reported to the Commissioner as Unsubstantiated, meaning that there was insufficient evidence to establish whether or not there was an act of misconduct.

^{**} Within NYPD Guidelines is reported to the Commissioner as Exonerated, meaning there was a preponderance of the evidence that the acts alleged occurred but did not constitute misconduct.





Figure 23: Disposition Counts of Full Investigations (April 2025)

The CCRB investigates untruthful statement allegations under two different allegation categories. Official statements made directly to the CCRB are investigated under the "Untruthful Statement" allegation category. Official statements made in other contexts (e.g. in court) are investigated under the "Abuse of Authority" allegation category.

All the untruthful official statement allegations are mutually exclusive, meaning that the CCRB will not plead more than one untruthful statement allegation against an officer for the same untruthful act. There are four distinct types of untruthful statement allegation as follows: 1) False official statement, 2) Misleading official statement, 3) Inaccurate official statement and 4) Impeding an investigation.


Figure 31: Substantiated Bias-Based Policing Allegations with % Change

In general, investigations relying on video evidence result in much higher substantiation rates.







Figure 36: Substantiation Rates for Full Investigations with Video (Jan 2024 - Apr 2025) (% substantiated shown)



Board Discipline Recommendations for Substantiated Officers

After a CCRB investigative team has completed its investigation, a panel of Board members determines whether to substantiate the allegation(s) and make a disciplinary recommendation against the officer(s).

- "Charges and Specifications" are the most severe form of discipline. A decision to assign Charges commences a process that may result in an administrative trial in the NYPD Trial Room. An officer may lose vacation days, be suspended, or be terminated if the officer is found guilty.
- "Command Discipline B" and "Command Discipline A" are recommended for misconduct that is moderately serious. An officer can lose up to ten vacation days as a result of Command Discipline B and up to five vacation days as a result of Command Discipline A.
- "Formalized Training" are the least severe discipline, often recommended for officers who misunderstand a policy. This determination results in training at the Police Academy or NYPD Legal Bureau (Formalized Training).
- When the Board has recommended Formalized Training or Command Discipline, the case is sent to the NYPD Commissioner to impose training and/or other penalties. Cases where the Board recommends charges are prosecuted by the CCRB's Administrative Prosecution Unit.

With the adoption of the NYPD Disciplinary Matrix on 03/15/2021, the CCRB no longer issues Instructions as a Board Discipline Recommendation.

Following the adoption of the NYPD Disciplinary Matrix on 03/15/2021, the Board Discipline Recommendation for each officer is determined by the sum of the Matrix penalty days associated with the allegation(s) substantiated against the officer as follows: 1. Charges (penalty days >= 11) 2. Command Discipline B (6 <= penalty days <= 10) 3. Command Discipline A (1 <= penalty days <= 5) 4. Formalized Training (0 < penalty days <1)

**Officer Retired/Resigned: CCRB closes an investigation if it learns that the subject officer has left the Department. In a small number of cases, CCRB will also close an investigation against a subject officer who is on extended leave and who will not be available for interview until after the Statute of Limitations has expired. These cases are elsewhere reported as "Miscellaneous" closures.

***Administrative Closure is a special category that deals with NYPD's Internal Affairs Bureau-referred cases or spin off cases with no complainant/alleged victim, and in which CCRB attempts to locate or identify a complainant/alleged victim has yielded no results.

Mediation Unit

Whenever mediation between a complainant/alleged victim and subject officer is suitable, it is offered by CCRB investigators. If the complainant/alleged victim and subject officer both agree to participate, a neutral, third-party mediator facilitates a conversation between the parties. The chart below indicates the number of mediations in April and this year.

Administrative Prosecution Unit

The CCRB's Administrative Prosecution Unit (APU) prosecutes police misconduct cases when the Board has recommended charges, in the NYPD Trial Room. The APU is also able to offer pleas to officers who admit guilt rather than going to trial. Following a plea agreement or the conclusion of a disciplinary trial, cases are sent to the Police Commissioner for final penalties.
