#### CECM

CECM provides oversight on all events and activities in NYC outdoor public spaces; advises and assists the Mayor in the creation and coordination of procedures and policies relating to events; communicates directly with local, state, and federal permitting agencies, supplies residents, business improvement districts, community boards, and elected officials with updates so events in our City are both safe and enjoyable for all.

#### SAPO

The Street Activity Permit Office (SAPO) is within CECM; issues permits for events on city street, sidewalk, and pedestrian plaza spaces including block parties, farmers markets, health fairs, clean ups, religious events, street events, street festivals, and plaza events; collects necessary support permits to ensure a safe event; deconflicts event permits with other permitting agencies; protects the interests of the City, community, and general public.

#### **DATABASE**

The CECM Database Division built from scratch a set of custom computer applications that allow individuals to apply for various types of permits online; supports and maintains the flow of significant event data between the primary permitting agencies (SAPO, DPR, MOME, NYPD); offers event data to support permitting agencies (DOT, DOB, NYPD, FDNY) and local NYC community board and business improvement district partners.

Applications will be considered on a first-come, first-serve basis. Applications open on March 1st at 12pm and the program will run through October 31, 2021.


