SERGEANT-AT-ARMS: Quiet please.

5 CHAIRPERSON BENJAMIN: [off mic] We will 6 begin. [on mic] That's better. Good evening and 7 welcome to the first meeting of the Charter Revision 8 Commission of the City of New York established 9 pursuant to Local Law 91 of 2018. I am Gail 10 Benjamin, and I am honored to have been appointed by 11 City Council Speaker Corey Johnson to lead this 12 Commission as its chair. It is my pleasure to call 13 this meeting to order. I have a few opening remarks, 14 and then we'll get down to business, and we have sent 15 all of you packages of what we are going to do today, 16 which is an organizational meeting of the Commission 17 so that we can get officially started on the right 18 foot. Examining the structure of our government may 19 seem academic on its face, but the balance of power 20 among elected officials and institutions and how they 21 function together ultimately affects every aspect of 22 how we live together as a society. How we govern 23 ourselves matters not just in the context of big 24 picture history, but in the everyday interactions we 25 as individuals have with our government, and nowhere

2	is that more true than in the case of local
3	government. As weighty as the issues are that our
4	colleagues in Washington and Albany grapple with, it
5	is hard to deny that the government that most
6	directly impacts the everyday lives of New Yorkers is
7	the city itself. From responding to emergencies to
8	keeping our streets clean to deciding how every
9	precious acre in our city is put to use, it is city
10	government operating pursuant to the framework
11	prescribed in our Charter that performs these vital
12	functions and makes these defining decisions. That
13	is why it is vitally important that we make sure that
14	this framework reflects the times in which we're
15	living. It was Thomas Jefferson who wanted each
16	generation of citizens to have the opportunity to
17	revise the Constitution, and make any needed repairs
18	to ensure that the country's fundamation-foundament-
19	foundational document reflected the changing times
20	and provided a well functioning government. That is
21	what this Commission has the opportunity to do with
22	our city's Constitution, the Charter. Since the five
23	boroughs became one city in 1897, the City Charter
24	has served as the city's foundational governing
25	document outlining the duties and powers of elected

2	officials, the functions of each city agency and the
3	fundamental processes of local government, and
4	budgeting and zoning to the enactment of local laws
5	and rules. The Charter we know today really dates to
6	the 1989 Charter Revision Commission, which
7	fundamentally re-straight-reshaped the function and
8	structure of our government, mostly notably
9	eliminating the Board of Estimate after the Supreme
10	Court ruled its representational system was
11	unconstitutional, and while that charter has served
12	us well, we have the opportunity now to use our
13	experience over the last 30 years, and to see what
14	has worked well, what can be built upon, and what
15	could use some refreshing and updating to help shape
16	the city for the next 30 years. A lot has changed
17	about the world sine 1989. The Internet and social
18	media have revolutionized the ways we communicate.
19	Climate change has transformed the way we think about
20	what it means to have resilient infrastructure, and
21	our conception of what participation and engagement
22	in democracy has evolved. All these transformations
23	have huge implications for how govern ourselves.
24	Making sure that our city is best positioned to
25	reflect these changes and to meet the needs of all

2	New Yorkers in and ever-changing world will be the
3	essence of the work of this Commission. I want to
4	encourage the members of the Commission to begin this
5	process by thinking in visionary terms. If we were
6	advising on the creation of a brand new city of 8.5
7	million people, how would that government be
8	structured in this ideal world to ensure efficiency
9	and accountability? Balance local control with
10	centralized planning, and create effective checks and
11	balances without unduly hindering the city's ability
12	to respond to changes. There are many people current
13	and former government officials, academic experts,
14	city workers, advocates and everyday citizens who
15	know very deeply what works well and what doesn't,
16	and we'll be relying upon all of them as we craft our
17	proposals. That is why we want to hear from as many
18	New Yorkers as possible if we are going to succeed.
19	We're under no illusions that this will be easy, but
20	we're committed to a comprehensive, thoughtful,
21	thorough collaborative and fair process focused on
22	results and concrete proposals that we feel can make
23	a meaningful impact on how our city functions. We
24	anticipated bringing these proposals before the
25	people of the city for their consideration no later

2	than November of 2019. Finally, I want to point out
3	as a former City Council employee, that this is the
4	first City Charter Revision Commission to be
5	established pursuant to Local Law, and to have
6	representation from all of the city's elected
7	officials. With that historic nature in mind, we
8	enter this process with no conceived or preconceived
9	agenda. No one has told us what topics or proposals
10	we should or should not look at and, in fact, we are
11	mandated to look at the entire Charter. I could not
12	be more excited to get started on our important work.
13	I know all of you share that feeling. Now, I would
14	like to introduce the other members of the
15	Commission. I recognize that the-we have received
16	letters issued by the officials duly authorized to
17	make appointments to this Commission appointing the
18	following members of the Commission pursuant to Local
19	Law 91 of 2018. I will call out the names of those
20	who have been appointed. If you would like to say a
21	few words, you should feel free. Sal Albanese who
22	was appointed by the Brooklyn Borough President Eric
23	Adams.
24	COMMISSIONER ALBANESE: [off mic] [on mic]
25	So, I look forward to working with you on the

Dr. 15 Lillian Paoli-Barrios Paoli appointed by City Council 16 Speaker Corey Johnson. 17 COMMISSIONER PAOLI-BARRIOS: I am equally 18 excited to be part of this group, and I really hope that we can do the best for the city-for the citizens 19 20 of the city of New York. 21 CHAIRPERSON BENJAMIN: Thank you, 22 Lillian. Lisette Camilo appointed by Mayor Bill de 23 Blasio. 24 25

COMMISSIONER CORDERO, SR: I also look 13 14 forward to working with this group, and I'm honored 15 to be here. Thank you. 16 CHAIRPERSON BENJAMIN: Thank you so much. 17 Honorable Stephen Fiala appointed by Staten Island 18 Borough President Jimmy Oddo. COMMISSIONER FIALA: Thank you, Madam 19 20 Chair. I just want to start by saying I feel very good about this Commission from the get-go because of 21 2.2 the selection of the Chair. I've known you for a 23 long time, and there are very few people in the city of New York or across the nation who could really 24 fill this role, who knows you, and when you talk 25

9	adopt the Charter that we have now, and it's remained
10	largely intact. The precipitating event for those
11	Charter changes was a Supreme Court decision. We
12	don't have such a precipitating event, but I think we
13	do have an earnest desire on the part of nine
14	principals to really take this Charter, look at it
15	earnestly, and try and shape it in such a way so that
16	in the 21 <sup>st</sup> Century we're meeting the needs of a very
17	diverse and different city than it was 29 years ago.
18	So, I'm grateful to be part of the Benjamin
19	Commission.
20	CHAIRPERSON BENJAMIN: Thank you so much,
21	Stephen. Paula Gavin appointed by Mayor Bill de
22	Blasio.
23	COMMISSIONER GAVIN: I, too, am honored
24	and delighted and proud to be a part of this and
25	thinking about our 8.6 million New Yorkers and what

9	what others said. It's an honor to be here with all
10	of you to make sure that the city of New York works
11	for all of the people that call it home, and is as

15	COMMISSIONER CLINTON MILLER: Thank you,

25	that—is a—it's a new day, and it is the contemporary

18	I've served this city for almost half a century, and
19	I have a deep commitment to it, and hope that-I
20	always want to see it function as best we can, and
21	I've had the honor and pleasure of working with the
22	Chair in a variety of capacities over much of that
23	time, and have a great deal of respect for her and I
24	really welcome the opportunity to serve with her
25

[laughter]. 8 CHAIRPERSON BENJAMIN: But she was so important, I put her in separate category. 9 10 COMMISSIONER WEISBROD: I knew there was an explanation. Thank you, Chair. [laughs] 11 12 CHAIRPERSON BENJAMIN: Thank you, Carl, 13 and in the special category for only special people 14 whose skills and talents and viewpoint bring more to 15 bear than most of us can on the issues in front of 16 us. I bring you Lindsay Greene, who was appointed by 17 the Mayor. Lindsay. 18 COMMISSIONER GREENE: Thank you, Chair That was probably the most exciting intro 19 Benjamin. 20 I've every received. [laughter] This is a rare and important opportunity. I'm thrilled to serve and 21 2.2 looking forward to working with all of you. Thank 23 you. 24 CHAIRPERSON BENJAMIN: Thank you so much. That concludes the introduction of the members, and I 25

9	that are developed and approved by this Commission
10	will be presented by referendum to the people of the
11	city for their approval. I look forward to working
12	with all of you to complete the important mission. I

14	meeting to meet Jeff and some of the other staff who
15	helped us prepare for today's meeting. [background
16	comments, pause] Oh, I'm told I skipped as whole
17	section. Sorry. That's why we have really great

20	Commission authorize the staff to comply with the
21	public notice provisions of state laws by posting
22	notices of the Commission's public meeting in City
