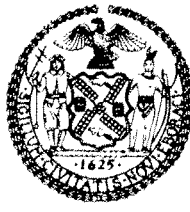

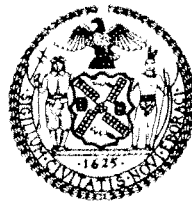


I am writing to express my support for South Brooklyn Legal Service's application for funding titled "Legal Assistance for Victims Grant Program."

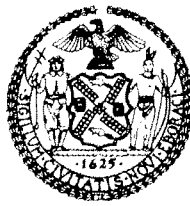


I am writing to express my support for Gina Gibney Dance, Inc's application for funding titled "Community Action for Domestic Violence."
