

**Re: Consulting Arrangement with Lori Barrett-Peterson**

Dear Mr. Carrier:

This letter serves to notify the Conflicts of Interest Board ("COIB") that in accordance with COIB Rule 1-07(d), the Mayor's Office of Media and Entertainment ("MOME") is retaining former employee Lori Barrett-Peterson as a consultant. Ms. Barrett-Peterson's employment with MOME concluded on October 24, 2025, and she is being retained as a consultant for the purpose of continuing work left unfinished at the time Ms. Barrett-Peterson separated from MOME.

Ms. Barrett-Peterson is being retained from November 10, 2025, through the end of this fiscal year, which is no longer than reasonably necessary given the City's current hiring processes. Retaining Ms. Barrett-Peterson is necessary because she possesses professional skills and subject-matter expertise that other MOME employees currently do not have. Specifically, in 2023, MOME began working on moving its TV and Radio Network Master Control (the "Project") from 365 Fifth Avenue, New York, NY 10016, to PSAC-1, 11 Metro Tech Center, Brooklyn, NY 11201 and 1 Centre Street, New York, NY 10007. Ms. Barrett-Peterson was instrumental in the administrative and operational aspects of this Project; liaising with City Hall and other City agencies. The move is scheduled to be completed by June 2026, and Ms. Barrett-Peterson's knowledge of the operational matters related to the Project will help

support an easier transition to PSAC-1 and 1 Centre Street. Additionally, Ms. Barrett-Peterson's experience, professional skills and expertise on MOME's fiscal and operational matters, including but not limited to, advising on MOME's budget, fiscal strategy, and compliance with fiscal and operational requirements will ensure continuity of the agency.


Under the consulting agreement, Ms. Barrett-Peterson will be compensated up to \$5,000.00, at a rate of \$120.00 per hour, which is comparably equal to her annual salaried rate of \$185,000 when she was employed at MOME.



**Re: Consulting Arrangement with Jacob Glickman**

Dear Mr. Carrier:

This letter serves to notify the Conflicts of Interest Board ("COIB") that in accordance with COIB Rule 1-07(d), the Mayor's Office of Media and Entertainment ("MOME") is retaining former employee Jacob Glickman as a consultant. Mr. Glickman's employment with MOME concluded on December 19, 2025, and he is being retained as a consultant for the purpose of continuing work similar to matters handled at the time Mr. Glickman separated from MOME. Mr. Glickman served a total of 31 years at the City, first as Senior Policy analyst at the New York City Department of Finance (1999-2006), then as Director of Business Development and Strategy at the Mayor's Office of Film, Theatre and Broadcasting (2006-2009), and as the Director of Finance and Business Development and Acting Assistant Commissioner for Financial Affairs at MOME (2009-2025).

Mr. Glickman is being retained from January 1, 2026, through the end of this fiscal year, which is no longer than reasonably necessary given the City's current hiring processes. Retaining Mr. Glickman is necessary because he possesses professional skills and subject-matter expertise that other MOME employees currently do not have. Due to Mr. Glickman's over 31 years of experience with the City and 20 years with MOME, he is uniquely qualified to provide the knowledge, as well as experience and expertise, not otherwise available at the agency. As MOME's Acting Assistant Commissioner for Financial Affairs, he was responsible for agency administrative and development functions, including incentive and workforce development initiatives, procurement and budgeting, grant administration and reporting, and

special projects. As a consultant, Mr. Glickman will assist MOME as it works through the hiring process<sup>1</sup> and works to ensure a smooth transition of his position to his replacement, including but not limited to, guiding and advising his replacement on various administrative and development functions. The primary focus will be to ensure continuity in MOME's business processes and support the new hire on the business functions that help MOME operate. Mr. Glickman's return as a consultant during this time is intended to continue the work with which he was previously engaged and is beneficial to MOME and the City to ensure continuity of the agency.

Under the consulting agreement, Mr. Glickman will be compensated up to \$5,000.00, at a rate of \$110.00 per hour, which is comparably equal to his annual salaried rate of \$170,500.00, when he was employed at MOME.
