Dear Conflicts of Interest Board Members:

In accordance with Conflicts of Interest Board Rule 1-13(e), I write to inform you that I have designated Dermot Shea, Commissioner of the New York City Police Department, to serve as Honorary Chair to the National Law Enforcement Museum.

Commissioner Shea will not be compensated for this activity, but will use reasonable and incidental City time and City resources to fulfill this service. As set forth below, there is a demonstrated nexus between Commissioner Shea's position, his work for the National Law Enforcement Museum, and the mission of the NYPD.

The National Law Enforcement Museum, operated by the National Law Enforcement Officers Memorial Fund (NLEOMF) a non-profit 501(c)(3) organization, provides the public with immersive exhibits as well as law enforcement research and educational programs. Commissioner Shea would serve as Honorary Chair to the Museum for its Exhibit on the 20th Anniversary of 9/11 from August 27, 2021 through May 9, 2022. His work as Honorary Chair furthers the NYPD's mission and furthers the interests of the City in honoring and remembering those lost in the terrorist attacks of 9/11.

Based on the information presented to me, I have determined that that there is a demonstrated nexus between the mission of the NYPD, Commissioner Shea's position, and the work and activities of the National Law Enforcement Museum, and that such work and activities would further the NYPD's mission and is not undertaken primarily for the benefit or interests of the National Law Enforcement Museum.

Pursuant to Rule 1-13(e) of the Rules of the Conflicts of Interest Board (COIB), I, as Commissioner of the New York City Police Department, hereby designate Deputy Commissioner Robert Ganley, in his official capacity as Deputy Commissioner of Employee Relations of the New York City Police Department (NYPD), to serve on the Advisory Board of First Responders Children's Foundation.

First Responders Children's Foundation is a not-for-profit organization that provides support to first responders and their families enduring financial hardship due to tragic circumstances. I have determined that there is a demonstrated nexus between Deputy Commissioner Ganley's service on the First Responders Children's Foundation Advisory Board, his role as Deputy Commissioner of Employee Relations, and the mission of the NYPD. Deputy Commissioner Ganley's work for First Responders Children's Foundation furthers the NYPD's mission and is not undertaken primarily for the benefit or interest of First Responders Children's Foundation. Furthermore, to the extent that any such business is conducted, Deputy Commissioner Ganley will take no part in the organization's business dealings with the City.

I have been advised that Deputy Commissioner Ganley does not anticipate any conflicts between his responsibilities at the NYPD and his responsibilities as a member of the Advisory Board of First Responders Children's Foundation. I approve of the reasonable use of City time and resources for the purpose of Deputy Commissioner Ganley serving on the First Responders Children's Foundation Advisory Board.
