Electronic Cigarette Retail Dealer Cap Exception Certification

Failure to complete this Certification and submit requested documents may result in denial of your license application.

You must submit your complete application and this Exception Certification with supporting documentation within 30 days of:

- Change in ownership or partnership OR
- Date you receive your new Newsstand license because:
 - You transferred the license from your name to your business name. OR
 - You were transferred the license due to the death or disability of the prior license holder.

Definitions and Resources

"**Good standing**" means the Electronic Cigarette Retail Dealer license holder did not violate New York City Administrative Code section 17-704.1(b) or 17-706(a-1) on more than one day in the **three years** before the new application date. For copies of the law, visit nyc.gov/dcwp.

It is not sufficient that the current business has an active license with DCWP. If the business does not qualify as being in "good standing," DCWP will deny the license application.
