

## Legal Referrals

### I. Suggested Questions to Ask BEFORE Hiring Attorney

1. What kinds of cases does your practice focus on?
2. Have you ever filed a case like mine before? What are the strengths and weaknesses of my case?
3. If I am successful in the case, how much do I have to pay you?
4. If I am not successful in the case, do I still have to pay you? If so, how much?
5. Do you try to settle cases before bringing them to trial? Are there situations in which you would recommend going to trial rather than settling?
6. What will be expected of me in order to work with you on this matter?
7. What is your communication style? How often will you update me on the progress of my case? Do you prefer communicating by phone or email?

All private attorneys listed offer free consultations. Many of these attorneys charge for services on a contingency fee basis. This means payment is based on a percentage of total recovery at the conclusion of the case.
