DEPARTMENT OF CITYWIDE ADMINISTRATIVE SERVICES COMMISSIONER'S DIRECTIVE NO. 2020-3 CONCERNING EXTENSION FOR TIME-LIMITED TITLES DURING THE COVID-19 CRISIS NOVEMBER 25, 2020

WHEREAS, on March 7, 2020, Mayor de Blasio issued Emergency Executive Order No. 98 declaring a State of Emergency in the City of New York resulting from the outbreak of novel coronavirus disease 2019 ("COVID-19"); and

WHEREAS, Emergency Executive Order No. 98 directs "all agency heads . . . to take all appropriate and necessary steps to preserve public safety and the health of their employees, and to render all required and available assistance to protect the security, well-being and health of the residents of the City"; and

WHEREAS, the class specifications for certain interne, trainee and apprentice titles set forth in Exhibit A of this Directive establish limited durations in which appointees may serve during which time they must acquire certifications or licenses or fulfill other requirements in order to be eligible for or maturate to a succeeding title; and

WHEREAS, the class specifications for certain permanent titles set forth in Exhibit B to this Directive require appointees to acquire certifications or licenses or fulfill other requirements in a defined period of time in order to continue holding the permanent title; and

WHEREAS, during the COVID-19 State of Emergency, the ability of city employees in such titles to acquire the specified certifications or licenses or fulfill other requirements has been impeded; and

WHEREAS, there is currently in the city a freeze on the hiring of new employees due to the financial strain caused by the COVID-19 emergency; and

WHEREAS, it is in the public interest that employees in time-limited titles be able to continue their employment until such time as they are able to acquire the certifications or licenses or fulfill other requirements set forth in the class specifications;

NOW, THEREFORE, I take the following actions:

Section 1. I hereby direct that incumbent appointees to titles set forth in Exhibit A and any persons appointed to such trainee, interne and apprentice titles during the existence of the COVID-19 State of Emergency shall be permitted to continue to hold the titles past the duration of the term for the title set forth in the class specifications and for one year after the termination of the COVID-19 State of Emergency in order to have the opportunity to acquire the certification or license or fulfill such other requirement necessary to be eligible for appointment or maturation to a succeeding title.

§ 2. I hereby direct that incumbent appointees to permanent titles set forth in Exhibit B and any persons appointed to such permanent titles during the existence of the COVID-19 State of Emergency shall be permitted to continue to hold the titles past the time set forth in the class specifications to acquire certifications or licenses or fulfill other requirements in order to continue holding the title, and for one year after the termination of the COVID-19 State of Emergency, in order to have the opportunity to acquire the certification or license or fulfill such other requirement necessary to be eligible to continue to hold the permanent title. Any such time extended beyond the time set forth in the class certification that an incumbent appointee shall take to acquire certifications or licenses or fulfill other requirement of any required probationary period.

§ 3. This Commissioner's Directive No. 2020-3 shall take effect immediately.
