## BUILD NYC RESOURCE CORPORATION

■ PUBLIC HEARINGS

The Build NYC Resource Corporation (the "Corporation") is a not-for-profit local development corporation organized under Sections 402 and 1411 of the Not-for-Profit Corporation Law of the State of New York. In accordance with the aforesaid law, and pursuant to its certificate of incorporation, the Corporation has the power to issue non-recourse revenue bonds and to make the proceeds of those bonds available for projects that promote community and economic development in The City of New York (the "City"), and to thereby create jobs in the non-profit and for-profit sectors of the City's economy. The Corporation has been requested to issue such bonds for the financings listed below in the approximate dollar amounts respectively indicated. As used herein, "bonds" are the bonds of the Corporation, the interest on which may be exempt from local and/or state and/or federal income taxes; and, with reference to the bond amounts provided herein below, "approximately" shall be deemed to mean up to such stated bond amount or a greater principal amount not to exceed 10% of such stated bond amount.

Approximately \$27,700,000 tax-exempt revenue bond transaction for the benefit of The Berkeley Carroll School (the "School"), a not-for-profit education corporation exempt from federal taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, which operates as a coeducational private school for pre-kindergarten to 12th grade.

Proceeds of the bonds will be used by the School to (a) refinance outstanding debt in the aggregate amount of approximately \$25,700,000, the proceeds of which was used to: (i) finance the costs of the expansion, renovation, equipping and/or furnishing of an approximately 68,488 square foot building on an approximately 27,730 square foot parcel of land located at 181 Lincoln Place, Brooklyn, New York 11217 (the "Lincoln Place Facility"), in the approximate amount of \$8,464,500, which includes a new dining facility, kitchen and server, student common areas, classrooms and faculty and staff offices for the School's middle and upper school; (ii) finance the costs of the expansion, renovation, equipping and/or furnishing of an approximately 19,788 square foot building on an approximately 8,400 square foot parcel of land located at 712-716 Carroll Street, Brooklyn, New York 11215 (the "712-716 Carroll Street Facility"), in the approximate amount of \$6,365,500, including enlarging the lobby and reception areas, adding a new elevator and stairway, enlarging classrooms, adding several new specialty classrooms and expanding the library for the School's lower school; (iii) finance the costs of the acquisition of an approximately 16,590 square foot building on an approximately 8,567 square foot parcel of land located 152-156 Sterling Place, Brooklyn, New York 11217, in the approximate amount of \$1,860,000, to house administrative and other functions for the School; and (iv) refund the then outstanding New York City Industrial Development Agency Civic Facility Refunding and Improvement Revenue Bonds (1998 The Berkeley Carroll School Project) in the approximate amount of \$9,010,000, a portion of which bond proceeds was used to (1) finance a portion of the construction, renovation, equipping and/or furnishing of an approximately 40,300 square foot building on an approximately 18,500 square foot parcel of land located on adjacent tax lots at 701 Carroll Street (a/k/a 762 President Street), Brooklyn, New York 11215 and 699 Carroll Street, Brooklyn New York 11215 (collectively, the "701 Carroll Street Facility") for the School's lower school and the renovation and furnishing of the Lincoln Place Facility and (2) refund the then outstanding New York City Industrial Development Agency Civic Facility Revenue Bonds (The Berkeley Carroll School Project, Series 1993), a portion of which bond proceeds was used to finance the construction, renovation, equipping and/or furnishing of the Lincoln Place Facility, the 712-716 Carroll Street Facility and the 701 Carroll Street Facility; (b) pay for certain costs related to the issuance of the bonds and refinancing; and (c) fund any required debt service reserve fund. The financial assistance proposed to be conferred by the Corporation will consist of such tax-exempt bond financing and exemption from City and State mortgage recording

Approximately \$33,000,000 tax-exempt revenue bond transaction for the benefit of the Stephen Gaynor School, Inc. (the "School"), a New York not-for-profit education corporation exempt from federal taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, . Proceeds of the bonds, together with other funds of the borrower, will be used by the School to: (i) refinance outstanding lines of credit in the aggregate amount of approximately \$17,600,000, the proceeds of which, together with other funds of the School, were used to (a) finance the costs of acquisition of an approximately 9,818 square foot parcel of land located at 171-177 West 89th Street, New York, New York 10024, together with the improvements thereon, including a five-story building thereon (the "Building"), and (b) finance the costs of expansion, renovation, equipping and/or furnishing of approximately 22,500 square feet of space in the Building, which included classrooms, cafeteria space and the construction of a bridge connecting the Building to the School's adjacent space located at 148 West 90th Street, New York, New York; (ii) finance the renovation, equipping and/or furnishing of the fifth floor of the Building, which is to include classrooms and a library; (iii) finance the construction, renovation and equipping of a new approximately 4,000 square foot field house, together with ancillary circulation space and mechanical space on the roof of the Building; and (iv) pay for certain costs related to the issuance of the bonds. The properties described herein are owned and operated by the School, which operates as a co-educational independent day school for students who range in age from 3 to 14. The financial assistance proposed to be conferred by the Corporation will consist of such taxexempt bond financing and exemption from City and State mortgage recording taxes.

Approximately \$7,500,000 tax-exempt revenue bond transaction for the benefit of Trinity Episcopal School Corporation (the "School"), a New York not-for-profit education corporation exempt from federal taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, as borrower. Proceeds of the bonds, together with other funds of the borrower, will be used by the School to (i)

refund approximately \$7,375,000 in outstanding New York City Industrial Development Agency ("NYCIDA") Civic Facility Revenue Bonds (Trinity Episcopal School Corporation), Series 1997 (the "1997 Bonds"), the proceeds of which, together with other funds of the School, were used to finance the costs of constructing, furnishing and equipping of a three-story building located at 115 West 91st Street, New York, New York 10024 for use as classroom, administrative, and gymnasium space and (ii) finance certain costs of issuance for the bonds. The property described herein is owned and operated by the School as an independent school serving students in kindergarten through twelfth grade. The financial assistance proposed to be conferred by the Corporation will consist of such tax-exempt financing and exemption from City and State mortgage recording taxes.

Approximately \$11,800,000 tax-exempt revenue bond transaction for the benefit of 1887 Bathgate Properties LLC ("Bathgate"), a New York limited liability company that is a disregarded entity for federal income tax purposes and is a wholly-owned direct subsidiary of Volunteers of America -Greater New York, Inc. ("Volunteers of America"), a New York not-for-profit corporation exempt from federal taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and which is a human services organization. Proceeds of the bonds, together with other funds of Bathgate, will be used by Bathgate to: (a) refinance a loan or loans that were used to finance the acquisition, renovation, equipping and/or furnishing of an approximately 33,000 square foot building on an approximately 14,527 square foot parcel of land located at 1887 Bathgate Avenue, Bronx, New York 10457 (the "Facility"); (b) finance certain renovations, tenant improvements and equipping of the Facility; (c) fund a debt service reserve fund, if necessary; and (d) pay certain costs of issuance for the bonds. The Facility will be owned by Bathgate and operated by Volunteers of America as the Bronx Early Learning Center, which provides comprehensive educational services to preschool children with and without developmental delays. The financial assistance proposed to be conferred by the Corporation will consist of such tax-exempt bond financing and exemption from City and State mortgage recording taxes.

Pursuant to Internal Revenue Code Section 147(f), the Corporation will hold a public hearing on the proposed financings described hereinabove at the offices of the New York City Economic Development Corporation ("NYCEDC"), located at 110 William Street, 4th Floor, New York, New York 10038, commencing at 10:00 A.M. on Thursday, February 6, 2014. Interested members of the public are invited to attend. The Corporation will invite comments at such hearing on the proposed financings. In addition, at such hearing the Corporation will provide the public with an opportunity to review the financing application and the costbenefit analysis for each of the proposed financings. For those members of the public desiring to review project applications and cost benefit analyses before the date of the hearing, copies of these materials will be made available, starting on or about fourteen (14) days prior to the hearing. - In M1-5A and M1-5B Districts, on a #zoning lot# that, as of December 15, 2003, is vacant, is #land with minor improvements#, ex has not more than 20 percent of the #lot area# occupied by existing #buildings#, or has #street# frontages on two or more #wide streets# and not more than 40 percent of the #lot area# occupied by existing #buildings#, the Commission may modify #use# regulations to permit #residential development#, and, below the floor level of the second #story# of any #development#, #uses# permitted under Section 32-15 (Use Group 6), provided that:
  - (1) the #use# modifications <u>shall</u> meet the following conditions, <u>that</u>:
    - (i) that-#residential development#
      complies with the requirements
      of Sections 23-47 (Minimum
      Required Rear Yards) and 23-86
      (Minimum Distance Between
      Legally Required Windows and
      Walls or Lot Lines) pertaining
      to R8 Districts;
    - (ii) that total #floor area ratio# on the #zoning lot# shall be limited to 5.0;
    - (iii) that the minimum #floor area#
      of each #dwelling unit#
      permitted by this Section shall
      be 1,200 square feet;
    - (iv) that-all #signs# for #residential# or #commercial uses# permitted by this Section shall conform to the applicable regulations of Section 32-60 (SIGN REGULATIONS) pertaining to C2 Districts; and
    - (v) that eating and drinking establishments of any size, as set forth in Use Groups 6A and 12A, are not permitted;
  - (2) the Commission shall finds that such #use# modifications:
    - (i) have minimal adverse effects on the conforming #uses# in the surrounding area;
    - (ii) are compatible with the character of the surrounding area; and
    - (iii) for modifications that permit
      #residential use#, result in a
      #development# that is
      compatible with the scale of the
      surrounding area.
  - In all districts, the Commission may modify #bulk# regulations, except #floor area ratio# regulations, for #development# on a #zoning lot# that is vacant or is #land with minor improvements#, and in M1-5A and M1-5B Districts, the Commission may make such modifications for #zoning lots# where not more than 20 percent of the #lot area# is occupied by existing #buildings# as of December 15, 2003, provided the Commission finds that such #bulk# modifications: comply with the findings set forth below.

In addition, in M1-5A and M1-5B Districts, the Commission may also modify #bulk# regulations, except #floor area ratio# regulations, for #development# on a #zoning lot# that has #street# frontages on two or more #wide streets# and that, as of December 15, 2003, has not more than 40 percent of the #lot area# occupied by existing #buildings#, provided the #development# contains no #residences# and the Commission finds that such #bulk# modifications:

- (1) shall not adversely affect structures or #open space# in the vicinity in terms of scale, location and access to light and air;
- (2) relate harmoniously to #buildings# in the Historic District as evidenced by a Certificate of Appropriateness or other permit from the Landmarks Preservation Commission.

The City Planning Commission may prescribe appropriate additional conditions and safeguards in order to enhance the character of the #development# and to minimize adverse effects on the character of the surrounding area.

#### 32-421 Limitation on floors occupied by commercial uses

C1 C2 C3

In the districts indicated, in any #building#, or portion of a #building# occupied on one or more of its upper #stories# by #residential uses# or by #community facility uses#, no #commercial uses# listed in Use Group 6, 7, 8, 9 or 14 shall be located above the level of the first #story# ceiling, provided, however, that permitted #signs#, other than #advertising signs#, #accessory# to such #commercial uses# may extend to a maximum height of two feet above the level of the finished floor of the second #story#, but in no event higher than six inches below the lowest window sill of the second #story#. In any other #building#, or portion thereof, not more than two #stories# may be occupied by #commercial uses# listed in Use Group 6A, 6B, 6C, 6F, 7, 8, 9 or 14.

Non #residential uses# listed in Use Group 6, 7, 8, 9 or 14, where permitted by the applicable district regulations, may occupy the lowest two #stories# in any #building# constructed after September 17, 1970 in C1 or C2 Districts mapped within R9 or R10 Districts or in C1 8, C1 9, C2 7 or C2 8 Districts.

However, in C1 or C2 Districts mapped within R9 or R10 Districts or in C1-8, C1-9, C2-7 or C2-8 Districts, non-#residential uses# listed in Use Group 6, 7, 8, 9 or 14, where permitted by the applicable district regulations, may occupy the lowest two #stories# in any #building# constructed after September 17, 1970. For #buildings# constructed in such districts prior to September 17, 1970 located in Manhattan Community District Six, such non-#residential uses# may occupy the lowest two #stories# in such #building#, provided that:

The HHS Accelerator System is a web-based system maintained by the City of New York for use by its human services Agencies to manage procurement. To establish this, the City of New York is using the innovative procurement method, as permitted and in accordance with Section 3-12 of the Procurement Policy Board Rules of the City of New York ("PPB Rules").
