74-10 SPECIAL PERMIT USES

74-145 Bus stations

The City Planning Commission may permit bus stations listed under Use Group IV(B) with fewer than 10 berths pursuant to paragraph (a)

of this Section, and with 10 or more berths pursuant to paragraph (b)_or paragraph (c), as applicable.

All bus stations lawfully existing on December 15, 1961 are permitted to continue for the duration of the term for which such #use# has been authorized but the #enlargement#, #extension#, reconstruction or relocation of any bus station heretofore or hereafter constructed shall not be permitted except in accordance with the provisions set forth in this Section.

(a) In C1, C2, C4, C6, C7 or C8 Districts, or in any #Manufacturing District#, the Commission may permit bus stations with fewer than 10 berths for buses on a site of not less than 20,000 square feet, provided that the following findings are made:

* * *

(b) In C4, C6 or #Manufacturing Districts#, the Commission may permit the construction of a bus station with 10 or more berths for buses on a site of not less than 20,000 square feet, provided that the following findings are made:

* * *

In addition, the Commission shall require the provision of adequate #accessory# off-street parking spaces necessary to prevent the creation of traffic congestion caused by the curb parking of vehicles generated by such #use# and shall determine the required spaces in accordance with the purposes established in this Resolution with respect to other major traffic-generating facilities. The Commission shall require, in any event, no less than 20 spaces for the temporary parking of automobiles.

(c) In any #Commercial District# or #Manufacturing District#,
located within Community District 4 in the Borough of
Manhattan, the Commission may permit the construction of a
bus station with 10 or more berths for buses on a site of any size.

In conjunction with a permit for a bus station, when the air space above a #street# or portion thereof is closed, demapped and conveyed by the City to the owner of an adjoining #zoning lot# that will contain such bus station, the Commission may permit in such demapped air space the #development# or #enlargement# of a #building# or portion thereof which is part of such bus station. Additionally, the Commission may permit the modification of any applicable regulations of this Resolution, other than #floor area ratio# provisions, in connection with such bus station or any other #use# #developed# on the same #zoning lot# as such bus station.

In order to grant such a permit, the Commission shall determine that the conditions set forth in paragraph (c)(1) and the findings set forth in paragraphs (c)(2) and (c)(3) of this Section, as applicable, are met.

Where the bus station and related facilities allowed under this Section will be #developed# pursuant to Chapter 8 of Title 17 of the Unconsolidated Laws of New York, any #buildings or other structures# comprising such bus station and related facilities shall not be subject to the #bulk# regulations or other applicable regulations of this Resolution, and the floor space within such #buildings or other structures# shall be excluded from the calculation of #floor area#.

The curb level of a zoning lot of which the demapped air space is a part shall not be affected by the closing and demapping of air space above such street. However, the Commission may establish an appropriate level or levels instead of curb level as the reference plane for the applicable regulations relating to open space, yards, level of yards, equivalent rear yards, rear yard setback, minimum distance between buildings, and height and setback.

(1) Conditions

Where the #development# or #enlargement# of a #building# is allowed within one or more demapped air spaces pursuant to this Section, such demapped air spaces and any adjoining tracts of land containing such #building# may be considered as part of a single #zoning lot#, but such demapped air spaces shall not generate #floor area# to be utilized on such #zoning lot#.

2) Findings applicable to bus station #use#

In order to allow such bus station #use#, the Commission shall find that:

 the operation of such bus station does not create serious traffic congestion, and is not detrimental to public health or general welfare of the city;

- the principal access for such #use# is not located on a local #street# but is located either on an arterial highway. (ii) a major #street# or a secondary #street# within onequarter mile of an arterial highway or major #street#;
- (iii) the site plan for the bus station and related facilities includes pedestrian-oriented public spaces that, in their sizes and locations, reflect appropriate consideration of existing or planned at-grade pedestrian circulation networks;
- (iv) the design of the facility, including public entrances to the bus station, vehicular entrances and exits, bus ramps or overpasses, and accessory #uses# within the bus station and related facilities are sited and designed in a manner that reflects appropriate consideration of the civic importance of the site and of the experience of pedestrians within existing or planned #streets# or open
- (v) the locations of at-grade entrances to such bus station and related facilities are designed to encourage pedestrian circulation into and on the #zoning lot# and are well-situated in relation to existing and proposed atgrade pedestrian and bicycle circulation networks;
- <u>(vi)</u> the bus station provides adequate connections to and from existing transportation facilities;
- the bus station and surrounding transportation network (vii) accommodate projected bus volumes and reduces potential conflicts between buses and other modes of transportation in the surrounding area; and
- (viii) the #use# and #development# of the bus station will not have undue adverse impacts on the character of or land uses in the surrounding area.
- Findings applicable to modifications other than those allowing the bus station #use#

In order to modify any other applicable regulations of this Resolution, the Commission shall find that:

- such modifications will facilitate an improved site plan for the bus station and related facilities or are otherwise in furtherance of the bus station project;
- (ii) such modifications will not unduly obstruct access to light and air from surrounding #streets#, open areas and properties; and
- any proposed modification of regulations governing (iii) #zoning lots# divided by district boundaries or the permitted transfer of #floor area# will not unduly increase the #bulk# of any #development# or #enlargement# on the #zoning lot# or the intensity of #use# on any #block# to the detriment of occupants of #buildings# on the #block# or the surrounding area.

The Commission may prescribe appropriate conditions and safeguards to minimize adverse effects on the character of the surrounding area.

Notice of Adoption of Amendments to Title 24 of the Rules of the City of New York

In compliance with section 1043(b) of the New York City Charter ("Charter"), a notice of intention to add Chapter 39 (Added Sugar Warning) to Title 24 of the Rules of the City of New York was published in the New York City Record on April 23, 2024, and a public hearing was held on May 23, 2024. The rule requires food service establishments with 15 or more locations nationally to display added sugar warning icons informing consumers about food items for which a serving size contains added sugars in an amount that is equal to or more than the Daily Value for added sugars (currently 50 grams of added sugars (or 200 calories)).

At the hearing, four people testified, and twenty-three written comments were received. The testimony, as well as the written comments, largely supported the rule but some commenters recommended changes to the text of the warning, the placement of the warning text and the image of the warning icon. Specifically, several commenters made recommendations regarding the warning statement, including: to make it clearer that consuming added sugars (whether eating or drinking) increased health risks, to include dental disease among the health risks, and to clarify that risks are associated with high added sugars intake over time.

In response, the Department made changes to the language of the warning statement. Additionally, the Department has updated section 39-01(c) requiring the placement of the warning statement to include the menu, menu board and self-service location. Since "menu or menu board" is defined to include online menus, the added sugar warning statement and icon must appear on a covered establishment's online menus. Additionally, the Department made changes to clarify that the rule applies to combination meals. The Statement of Basis and Purpose was also updated to reflect current data.

After review of the available evidence, consideration of the desire for consistency with the sodium icon and evaluation of implementation considerations, the Department chose to keep the originally proposed icon

Statement of Basis and Purpose

Statutory Authority

This amendment to Title 24 of the Rules of the City of New York ("RCNY") is promulgated pursuant to sections 556 and 1043 of the New York City Charter and section 17-199.18 of the Administrative Code.

Background

Local Law 33 of 2022 ("Local Law 33") and Local Law 150 of 2023 ("Local Law 150") amended the Administrative Code of the City of New York ("Administrative Code") by adding a new section 17-199.18, requiring Food Service Establishments ("FSE" or "restaurant") that are inspected pursuant to the restaurant grading program established

pursuant to subdivision a of section 81.51 of the New York City health code and are part of chains with 15 or more locations across the nation to display added sugars notifications for certain food items displayed and listed on menus or menu boards that contain high levels of added sugars and a warning statement about the harms of high added sugars intake.

Sugar Consumption That Exceeds Dietary Recommendations is Associated with Negative Health Outcomes

The 2020-2025 Dietary Guidelines for Americans ("2020 DGA") recommends limiting consumption of added sugars, starting at age 2 years, to less than 10% of daily caloric intake, the equivalent of 200 calories of added sugars per day for a 2,000-calorie daily diet. The 2020 DGA also recommends avoiding foods and beverages with added sugars for those younger than age 2. Despite national recommendations, the average American consumes more than 13 percent of total daily calories from added sugars, about 270 calories. There is an established body of scientific literature demonstrating the health harms of high added sugars intake. Regarding excess body weight and type 2 diabetes, the Scientific Report of the 2015 Dietary Guidelines Advisory Committee ("2015 DGAC") concluded the following:

"Strong and consistent evidence shows that intake of added sugars from food and/or sugar sweetened beverages are associated with excess body weight in children and adults. The reduction of added sugars and sugar-sweetened beverages in the diet reduces body mass index in both children and adults. Comparison groups with the highest versus the lowest intakes of added sugars in cohort studies were compatible with a recommendation to keep added sugars intake below 10 percent of total energy intake."

"Strong evidence shows that higher consumption of added sugars, especially sugar-sweetened beverages, increases the risk of type 2 diabetes among adults and this relationship is not fully explained by body weight."

Type 2 diabetes is among the leading causes of premature deaths in New York $\mathrm{City.}^5$

Dental caries, also known as tooth decay, is the most common noncommunicable disease worldwide. The prevalence of dental caries in the United States is 45.8% among children ages 2 to 19 years, 89.9% among adults aged 20 to 64 years, and 96.1% among adults aged 65 years and older. The 2015 DGAC noted its concurrence with the World Health Organization's ("WHO") commissioned systematic review? that "moderate consistent evidence supports a relationship between the amount of free sugars intake and the development of dental caries among children and adults."

Added Sugars are Pervasive in the Food Supply

Restaurants are an important source of food for Americans, with an estimated 41% of adults in the United States consuming food from quick-service restaurants and 24% from full-service restaurants on a given day. 10 Also, added sugars are widespread in the national food supply. More than 60% of packaged foods in the U.S. contain added sugars 11 , making it difficult for individuals to reduce their sugar consumption. Further, most added sugars consumed in the U.S. diet comes from processed and packaged foods. 12

Sugary drinks are the leading contributor to added sugars in the American diet: nearly 25% of all added sugars consumed comes from sodas, fruit drinks, sports and energy drinks, and other sugar drinks. ¹³ Just one bottled sugary drink can exceed the daily added sugars limit for adults, for example: a 20 oz. bottle of Coca-Cola, Red Bull and Arizona Iced-Tea contains 65, 64 and 60 grams of added sugars, or the equivalent of approximately 260, 256, and 240 calories of added sugars, respectively. A 2020 study found that 32% of fast-food or quick-service restaurants ("QSR") respondents and 21% of full-service restaurant ("FSR") respondents ordered sugary drinks, including fountain drinks and bottle drinks: at QSR, among those who did so, mean sugary drink caloric contributions was 262 calories, and 71% purchased sugary drinks containing at least 200 calories, or 50 grams of added sugars. ¹⁴ At FSR, mean sugary drink calories amounted to 133 calories, and 10% of respondents had 200 or more calories, or 50 or more grams of added sugars, from sugary drinks, among those who purchased one. ¹⁵

Foods that are Not Offered Prepackaged but Are Represented as the Same Brand and Product as a Prepackaged Food Item

The U.S. Food and Drug Administration requires disclosure of added sugars content on the Nutrition Facts label of prepackaged foods but does not currently require such disclosure for non-prepackaged food offered by chain restaurants. However, the New York City Administrative Code does require the notification label on chain restaurant's non-prepackaged food items that are identical to prepackaged food items because foods offered that are non-prepackaged in chain restaurants have essentially the same high sugar content as the same prepackaged foods sold in retail stores.

The notification and warning requirements also apply when chain restaurants offer products that are represented to the public as the same brand and product as a prepackaged food item with high added sugars content. Identical to prepackaged food items include, but are not limited to, fountain sodas, coffee beverages and salad dressings.

Consumers must be able to easily identify items that exceed nationally recommended limits for daily added sugars consumption to decide whether they want to purchase an item that may harm their health. The warning label would provide this information for prepackaged foods, and items identical to prepackaged foods that mirror formulation of packaged foods and contain exceedingly high amounts of added sugars.

Section one. Title 24 of the Rules of the City of New York is amended by adding a new Chapter 39 to read as follows:

§ 39-01 Added Sugar Warning.

- (a) Definitions. When used in this section the following words and terms have the following meanings:
- (1) Added sugars has the meaning set forth in title 21, section 101.9 (c) (6)(iii) of the code of federal regulations, or any successor regulations.
- (2) Combination meal has the meaning set forth in section 81.49 of the Health Code.
- (3) Covered establishment means any food service establishment inspected pursuant to the restaurant grading program established pursuant to subdivision a of section 81.51 of the Health Code that is part of a chain with 15 or more locations doing business under the same name and offering for sale substantially the same food items.
- (4) Covered food item with a high added sugars content means any prepackaged food item or food item identical to a prepackaged food item for which a serving size contains added sugars in an amount that is equal to or more than the Daily Value for added sugars, or any combination meal for which any combination of food items available to the consumer contains added sugars in an amount that is equal to or more than the Daily Value for added sugars.
- $\begin{array}{c} \underline{(5)\ Daily\ Value\ for\ added\ sugars\ means\ the\ daily\ reference\ value} \\ \underline{established\ in\ title\ 21,\ section\ 101.9(c)(9)\ of\ the\ code\ of\ federal} \\ \underline{regulations,\ or\ any\ successor\ regulation,\ for\ adults\ and\ children\ aged\ 4\ years\ and\ older.} \end{array}$
- (6) Food has the meaning set forth in article 71 of the Health Code.
- (7) Food item on display means any food item that is visible to the customer before the customer makes a selection.
- (8) Identical to prepackaged food item means a food item offered by a food service establishment that is not prepackaged but has the same product name and is promoted, advertised, or presented as substantially the same as a prepackaged food item offered under the same brand name, whether in the covered establishment or in a retail location, as determined by the Department. Such items include, for example, fountain sodas, coffee beverages, salad dressings and dessert products.
- (9) Menu or menu board has the meaning set forth in section 81.49 of the Health Code.
- (10) Menu item means any individual food item or combination of food items listed on a menu or menu board, as well as any temporary menu item or variable menu item. Temporary menu item and variable menu item have the meanings set forth in section 81.49 of the Health Code.
- (11) Point of purchase has the meaning set forth in section 81.49 of the Health Code.
- (12) Prepackaged food item means any food item that is packaged by the manufacturer and required to have a Nutrition Facts label pursuant to title 21, part 101 of the code of federal regulations, or any successor regulations.
- (13) Self-Service food has the meaning set forth in section 81.50 of the Health Code.
- (b) Required warning icon. A covered establishment that offers for sale any covered food item with a high added sugars content must display an added sugar warning icon as follows:
- (1) The added sugar warning icon must appear on any menu or menu board next to the name of any covered food item with a high added sugars content, and on a tag next to any food item on display that is a covered food item with a high added sugars content:
- (2) The added sugar warning icon must be a black and white triangle with an image of a spoon bearing a heap of sugar and must be the same size and font and be equal in height to the largest letter in the name of the covered food item with a high added sugars content, as displayed on the menu, menu board, or tag next to any food item on display that is a covered food item with a high added sugars content; and
- (c) Required warning statement. The following statement must be posted prominently and conspicuously at the point of purchase, on the menu or menu board, and at any location where a food item requiring an icon pursuant to this subdivision is sold as a self-service food: "Warning: A indicates that the added sugars content of this item is equal to or higher than the total daily recommended limit of added sugars for a 2,000 calorie diet (50g). Eating or drinking high amounts of added sugars over time can increase risk of type 2 diabetes, weight gain, and tooth decay."
- (d) Sugar density of identical to prepackaged food items. For the purposes of this chapter, a food item that is identical to a prepackaged

food item will be presumed to have the same density of added sugars as is displayed on the Nutrition Facts label of the corresponding prepackaged food item, unless the food service establishment demonstrates otherwise to the satisfaction of the Department.

(e) Severability. If any provision of this section, or its application to any person or circumstance, is held invalid by any court of competent jurisdiction, the remaining provisions or application of the section to other persons or circumstances shall not be affected.

Revision of New York City Department of Park & Recreation's Rules

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED IN the Commissioner of the Department of Parks & Recreation ("the Department") by Sections 389 and 533(a)(9) of the New York City Charter and in accordance with the requirement of Section 1043 of the New York City Charter, the Department hereby revises §2-08 of Chapter 2 to Title 56 of the Official Compilation of the Rules of the City of New York.

Written comments regarding the rules were received in accordance with the notice published in the City Record or electronically through NYC RULES at www.nyc.gov/nycrules and a public hearing was held on August 29, 2024 at Chelsea Recreation Center, 430 West 25th Street, New York, NY 10001.

Statement of Basis and Purpose

The Department is revising § 2-08 of Chapter 2, Title 56 of the Rules of the City of New York. For large-size multi-day events at Flushing Meadows Corona Park ("FMCP"), the Department is removing the preference currently given to permit applications for events that were not held in the prior calendar year.

Previously, for FMCP only, the rules gave preference to multi-day events that did <u>not</u> take place in the prior year, except in the case of events that have a 10-year or longer history in FMCP, whereas in other venues the Department gave preference to events that occurred in the prior calendar year. The rule amendment eliminates this preference and gives both new and reoccurring applicants an equal opportunity to hold a multi-day event. This change will encourage operators to produce well-run events compliant with Department rules and regulations so that they have the potential to be approved again the following year, and will allow popular events to continue to benefit the community.

The rule changes also eliminate the categorization of these multi-day events by the number of attendees. A previous rule change addressed a concern that all large events are not equal in scope and scale, and the Department used a tiered system for multi-day FMCP event permits. The rules allowed for one multi-day FMCP event per year of 2,000 to 20,000 attendees, and one multi-day FMCP event per year of 20,001 to 40,000 attendees. The Department determined that using this tiered system did not provide the public with as great a diversity of events as had been anticipated, but instead might have deterred event operators from applying for permits at FMCP. As such, the Department is eliminating the tiered system, and allows two multi-day FMCP events each year for events ranging from 2,000 to 40,000 attendees. Moreover, the Department's new rule clarifies that there is no specific limitation on the number of multi-day special events for under 2,000 attendees.

The Department's authority for these rules is found in Sections 389, 533(a)(9), and 1043 of the New York City Charter.

"Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

New text is underlined and deleted text is in brackets:

- § 1. Paragraph (8) of subdivision (b) of section 2-08 of Title 56 of the Rules of the City of New York is amended to read as follows:
- (8) Permit applications for any event at Flushing Meadows Corona Park ("FMCP") may be submitted no earlier than the Tuesday following Labor Day in September, and no later than October 1 in the calendar year immediately preceding the calendar year in which the multi-day event would occur. Permits for multi-day events at FMCP, defined as an event that is open to guests for more than one day but no longer than three consecutive days, will be awarded based on the criteria outlined in section 2-08(w)(4), provided that:

- (A) the applicant confirms event attendance will not exceed 40,000 attendees per day and the specifies the method that will be used to ensure attendance does not exceed 40,000:
- (B) [if two or more applicants apply before the October 1 deadline, and one of the applicants received a permit in the previous calendar year, preference will be given to the applicant, if any, who did not receive a permit in the previous calendar year;
- (C)] events that have occurred in the FMCP for a minimum of ten consecutive years, excluding years where events were prohibited by State-imposed restrictions related to the Covid-19 pandemic, are not subject to Subparagraph 2-08(w)(4)(B).

§ 2. The introductory paragraph of paragraph 4 of subdivision (w) of Section 2-08 of Title 56 of the Rules of the City of New York is amended to read as follows:

4. Notwithstanding any other provision of this subdivision, the following additional conditions shall apply to any [event] <u>Large FMCP Event</u> that is open to guests for more than one day but no longer than three consecutive days within FMCP, even if each day is separately ticketed ("Multi-Day FMCP Event"):

§ 3. Subparagraph (B) of paragraph 4 of subdivision (w) of Section 2-08 of Title 56 of the Rules of the City of New York is amended to read as follows:

(B) In any calendar year, there will be a maximum of two permits granted for Multi-Day FMCP Events, not counting events that have occurred in FMCP for a minimum of ten consecutive years, excluding years where events were prohibited by State-imposed restrictions related to the Covid-19 pandemic. [Of the two permits granted for Multi-Day FMCP Events other than events that have occurred in FMCP for a minimum of ten consecutive years, the Department will grant a maximum of one permit for an event in each of the following categories: (a) events of 2,000 to 20,000 attendees and (b) events of 20,001 to 40,000 attendees. However, if there are (i) no applications for a permit in one category; or (ii) all applicants for a permit in one category withdraw their application; or (iii) the Department cannot issue a permit to any of the applicants in one category, the Department may, in its discretion, issue two permits for events in the other category.]

§ 4. Subparagraph (G) of paragraph 4 of subdivision (w) of Section 2-08 of Title 56 of the Rules of the City of New York is amended to read as follows:

- (G) All Multi-Day FMCP Event permit applications will be considered following the close of the application period after the October 1 deadline. Applications will be considered in the order received[, and categorized as set forth in paragraph (B) above]. [Other than events that have occurred in FMCP for a minimum of ten consecutive years, excluding years where events were prohibited by State-imposed restrictions related to the Covid-19 pandemic, any applicant that received a permit for the same or substantially similar event in the previous calendar year will be considered only after all otherwise-compliant applications for the same category from applicants that did not receive a permit in the prior calendar year have been reviewed. In the event] If multiple applications [in a category] are received on the same day [where each has, or each has not, received a permit for the prior calendar year], such applications will be reviewed based as follows:
 - the application that requests <u>a permit for</u> the fewest number of total days [for its total term] will be viewed more favorably;
 - (ii) if multiple applications request the same number of days for their term, the application that provides for the greatest free access to the general public or, if the event is ticketed, the application that provides the greater percentage of free tickets to the public [shall] will be viewed more favorably[.];
 - (iii) if multiple applications request the same number of days for their term, and such applications provide equal free access to the general public or, if the event is ticketed, provide an equal percentage of free tickets to the public, the application that minimizes its impact on FMCP will be viewed more favorably. In determining the impact of a proposed event on FMCP, the Department will consider factors including, but not limited to, the footprint of the proposed event, the number of attendees, and the infrastructure to be installed at FMCP for the proposed event.

FINDING OF SUBSTANTIAL NEED FOR EARLIER IMPLEMENTATION

Pursuant to the New York City Charter Section 1043(f)(1)(d), I hereby find and represent to the Mayor that there is a substantial need for the implementation, immediately upon its final publication in the City Record, of the New York City Department of Parks and Recreation (the "Department") rule amending the rules governing permit applications for multi-day special events in Flushing Meadows Corona Park ("FMCP").

As explained in the Statement and Basis of Purpose accompanying the Notice of Adoption of the final rule, the rule amendment (1) removes the preference currently given to applications for events that were not held the previous year; (2) allows for two multi-day events for between 2,000 and 40,000 attendees each year, rather than one multi-day event for between 2,000 and 20,000 attendees and one multi-day event for 20,001 and 40,000 attendees; (3) clarifies that there is no specific limitation on the number of multi-day special events for under 2,000 attendees; and (4) clarifies how the Department awards a multi-day event permits when applications are received on the same day, request the same number of total days, and provide for equal free access to the general public. These changes are being made to eliminate potential deterrents in the application process, and to encourage popular, well-run, and diverse events at FMCP.

Applicants may submit multi-day event permit applications beginning the first Tuesday after Labor Day, and the application period closes on October 1. Applications are considered following the close of the application period. Immediate implementation of this rule is necessary because without such immediate implementation these rule changes will not go into effect until after the application period for events to be held in 2025 has closed. This delay would likely harm the community by reducing the number of applications for permits for multi-day events to be held in 2025.

Therefore, this rule must take effect immediately upon its final publication in the City Record, in accordance with Charter Section 1043(f)(1)(d).
