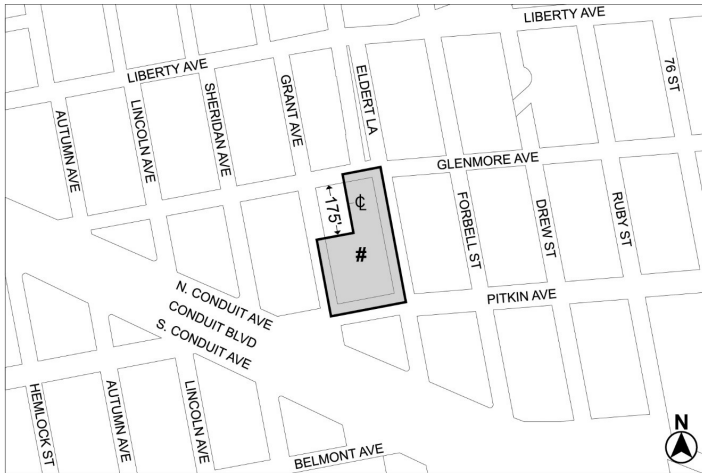

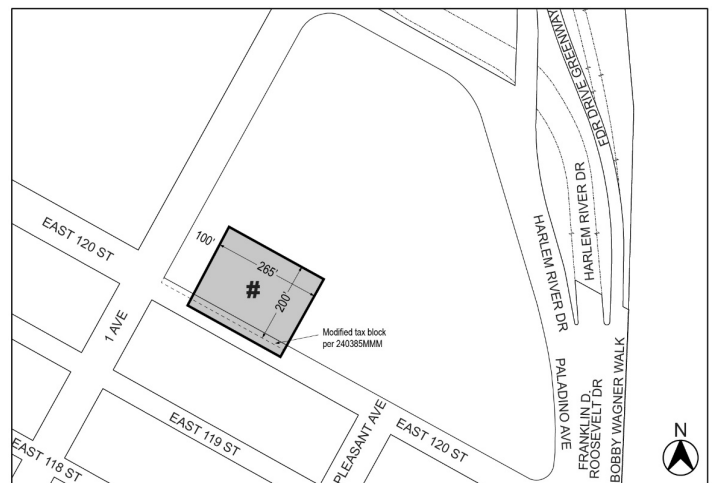

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED IN THE MAYOR'S OFFICE OF CITYWIDE EVENTS COORDINATION AND MANAGEMENT by Executive Order No. 105 of 2007, and in accordance with Section 1043 of the Charter, that the Office of Citywide Events Coordination and Management has amended Chapter 1 of Title 50 of the Official Compilation of Rules of the City of New York relating to street activity permits.

Notice regarding a public hearing about the amendment was first published on October 21, 2024, with a hearing held November 20, 2024, and the agency accepting comments until November 20, 2024. Approximately 11 comments were received. Among all comments, 7 people misunderstood what the proposed rule provided and thought that SAPO would deny all block parties in calendar year 2025 instead of newly proposed street fairs. SAPO also received comments from some community organizations and residents in support of the extension of this existing street fair moratorium. The agency is prepared to make available for public inspection all written and oral comments it received on the matter, within a reasonable time after receipt, between the hours of 9:30 A.M. and 4:30 P.M. at the Office of Citywide Events Coordination and Management, 253 Broadway, 6th Floor, New York, New York 10007.

Statement of Basis and Purpose

To more effectively deploy police resources and control overtime costs, the New York City Police Department has recommended that SAPO exercise its discretion to deny permit applications for new multi-block/multi-day street fair events in calendar year 2025. This rule authorizes SAPO to deny permit applications for street fairs if the street fair was not held in the calendar year 2024. Events that received permits in calendar year 2024 may be eligible to receive permits again in calendar year 2025.

Each year SAPO issues permits to over 200 street fairs and over 6,000 other events, most of which include the use of multiple blocks over several days, the erection of structures, the vending of food, apparel and other goods and the use of amplified sound and the performance of music. Events like these require additional police officers which increases overtime costs to the City. These events also divert police officers from core crime fighting, public safety and counterterrorism duties.

CECM authority for this rule is found in section 1043 of the New York City Charter, Local Law 8 of 2021, and Executive Orders Nos. 100 and 105 of 2007, which established and conferred rulemaking authority upon the Coordinator of Citywide Special Events.

Where can I find the DSNY's rules? DSNY's rules are in Title 16 of the Rules of the City of New York.

What laws govern the rulemaking process? DSNY must meet the requirements of Section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of Section 1043 of the City Charter.

Statement of Basis and Purpose

The Department of Sanitation is currently implementing the first zone of the Commercial Waste Zones program mandated by Local Law 199 of 2019. The private waste carters who have been awarded the

right to operate within the first zone ("awardees") have been signing up customers, but the percentage of businesses that have signed up with an awardee remains low. Pursuant to 16 RCNY 20-20(e), the Department will assign an awardee to any businesses that have failed to sign up with an awardee by the final implementation date for the zone. The rules of the Department currently state that assigned businesses shall receive two days of refuse collection per week and one day of designated recyclable materials collection per week, as well as one day of source separated organics collection per week if the commercial establishment is a designated covered establishment. However, there are businesses that generate a large amount of waste such that they currently require waste collection as frequently as five days per week. If these businesses were assigned an awardee for waste collection just two days per week, their waste would not be collected in a timely manner, and it could build up on the street. Therefore, the Department proposes to give itself the flexibility to assign a business up to five days a week of waste collection if an assigned business generates an amount of waste that requires collection more frequently than two days a week.

Notwithstanding any other provision of this paragraph, the Department may require that an awardee provide up to five days of refuse collection to a commercial establishment that has been assigned to such awardee as provided in this paragraph if the Department determines that such commercial establishment requires commercial waste collection service at a higher level of service than that described in subparagraph (i) of paragraph (2) of subdivision (a) of 16 RCNY § 20-22.
