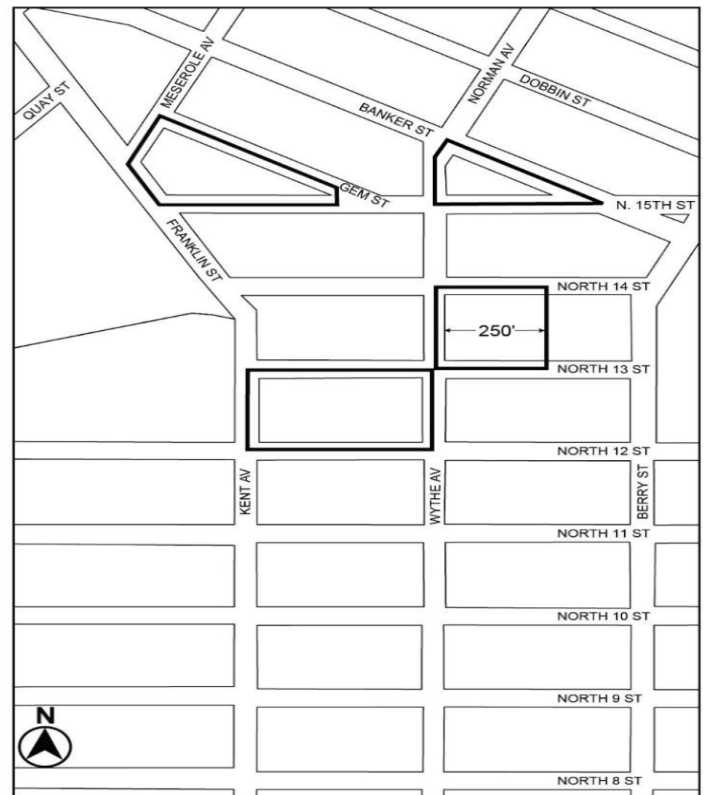

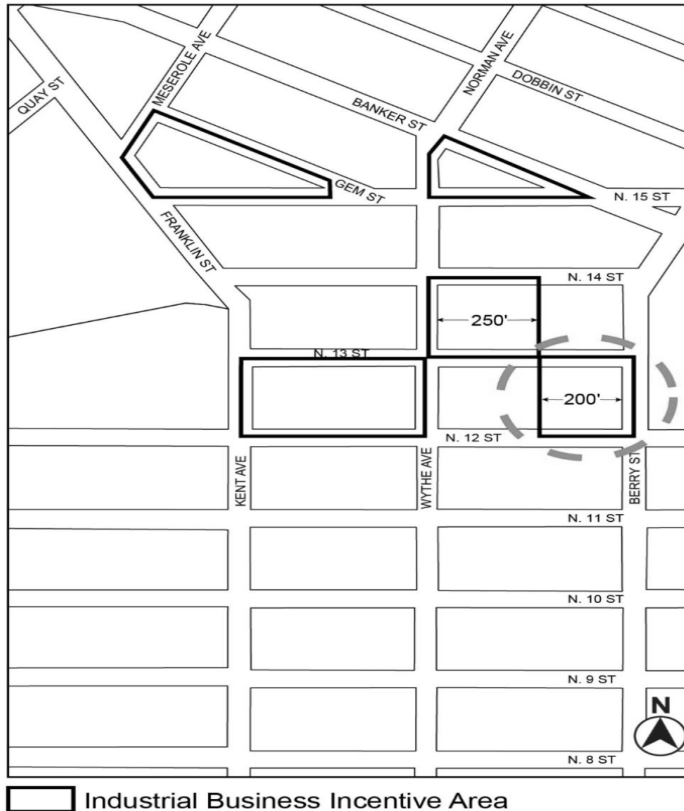
Map 1: Brooklyn

On January 7, 2025, a public hearing is being held by the City Planning Commission (CPC), accessible in-person and remotely, in conjunction with the above ULURP hearing to receive comments related to a Draft Environmental Impact Statement (DEIS) concerning an application by The New York City Department of Environmental Protection (DEP) and the New York City Department of Citywide Administrative Services (DCAS) (the "Applicants"). The New York City Department of Environmental Protection (DEP) is the CEQR Lead Agency for the environmental review. The Applicants are seeking a series of land use actions including site selection of a capital project and acquisition of property as well as the acquisition of permanent surface and subterranean easements at several properties for long-term maintenance and security (the "Proposed Actions") in Brooklyn Community District 1 and Queens Community Districts 2 and 5. Construction and operation of a combined sewer overflow (CSO) tunnel and additional infrastructure to reduce the volume of CSO entering Newtown Creek, under the Newtown Creek CSO Storage Tunnel project constitutes the "Proposed Project". The Proposed Actions would facilitate the Proposed Project which may require property leasing during various stages of construction and includes the CSO tunnel along with diversion chambers, drop shafts, conveyance sewers, new outfalls, and odor control systems. The proposed CSO storage tunnel would be at a depth ranging from 80-130 feet below existing ground surface, and approximately 26 feet in diameter. The tunnel alignment would run from a site in Brooklyn (on the southern side of the Creek) near Whale Creek and the Newtown Creek WRRF, east under the Creek into the Blissville neighborhood of Queens, continuing south and east

along Review Avenue, underneath the Kosciusko Bridge toward the Maspeth section of Queens, then curving south and then west into Brooklyn. In addition to the tunnel, the Proposed Project would include a tunnel dewatering pump station (TDPS), diversion facilities at outfalls BB-026, NCQ-077, NCB-083, and NCB-015 to divert CSOs from the outfalls to the tunnel, and a new gravity diversion sewer to connect outfall BB-026 to the tunnel. Construction of the diversion facility at BB-026 would be facilitated by the acquisition of easements. Acquisition of the TDPS site would not be required since it is a City-owned property (currently being used by DSNY). In total, the Proposed Project would affect up to 99 properties: 9 properties are City-owned and require only site selection approval, and 90 properties are privately owned and require both site selection and acquisition approval. Of the up to 90 properties requiring both site selection and acquisition approval, 4 require fee simple acquisition (for the diversion facilities at NCQ-077, NCB-083, and NCB-015), up to 83 require subterranean easements along the proposed tunnel and gravity diversion sewer alignments (including one property that also requires both acquisition of a permanent surface easement and a temporary construction easement, and one property that also requires acquisition of a temporary construction easement), and 3 properties require both acquisition of permanent surface and temporary construction easements (but no subterranean easement). The fee simple acquisition, property leasing, and establishment of subterranean and surface easements would be facilitated by the proposed acquisition action under ULURP. The Build Year is 2040.

The Proposed Project may require several other actions, including approval by local entities such as the NYC Landmarks Preservation Commission (LPC), New York City Public Design Commission, New York City Department of Transportation (DOT) Office of Construction Mitigation and Coordination (OCMC); state entities such as the New York State Department of State (NYS DOS), New York State Office of General Services (NYS OGS), New York State Department of Environmental Conservation (NYS DEC), New York State Historic Preservation Office (SHPO), Metropolitan Transit Authority (MTA); and federal entities such as the U.S. Environmental Protection Agency (EPA), Coastal Zone Management Act, U.S. Army Corps of Engineers (USACE), United States Fish and Wildlife Service (USFWS) and National Marine Fisheries Service (NMFS), and the Advisory Council on Historic Preservation.

Written comments on the DEIS are requested and will be received and considered by the Lead Agency through 5:00 P.M. on Tuesday, January 20, 2026.

NOTICE OF ADOPTION OF FINAL RULE

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED IN THE COMMISSIONER OF THE DEPARTMENT OF ENVIRONMENTAL PROTECTION by Section 1403(c) of the New York City Charter and Sections 24-204, 24-219 and 24-222 of the New York City Administrative Code, that the Department of Environmental Protection ("Department" or "DEP") is adopting a rule to amend the Citywide Construction Noise Mitigation Rules codified in Chapter 28 of Title 15 of the Rules of the City of New York, by adding a new requirement that certain construction sites that will be in operation after hours must have a noise monitor.

A public hearing was held on the proposed rule on November 12, 2025. Most of the comments supported adoption of the rule, while there were a small number of comments suggesting certain clarifications. In response to these comments, minor changes have been made to clarify that the rule applies to projects lasting 30 days or longer whether or not the 30 days are consecutive, that the term "square footage" is the same as the gross floor area of the project as defined in the Building Code, and that monitoring must take place continuously for the duration of the project. A provision was also added to make the effective date of the rule 120 days from the date of final publication, in order to give the regulated community adequate time to prepare for

compliance, and to promulgate a rule making necessary additions to the Noise Code Penalty Schedule.

Statement of Basis and Purpose

On December 29, 2005, Local Law 113 for the year 2005 became effective. The law amended the Administrative Code of the City of New York in relation to the Noise Control Code. Specifically, the law established standards and procedures to reduce noise from construction, and established sound level standards and procedures for specific noise sources. Pursuant to section 24-219 of the Noise Code, in 2007, DEP promulgated rules that prescribe the methods, procedures, and strategies that must be used whenever there is a construction site that will utilize certain construction devices or activities.

For after-hours construction, section 24-221 of the Noise Code authorizes the Commissioner to grant an approval for an alternative noise mitigation plan if the alternative noise mitigation strategies, methods, procedures or equipment proposed are consistent with the purposes and policies of the Noise Code. The amendment requires the use of noise monitoring devices as part of such a plan in order to help regulate construction noise.

Specifically, this amendment requires the use of noise monitoring devices at construction sites of 200,000 or more square feet that are located within 50 feet of a residential receptor and that will have ongoing after-hours construction for 30 days or longer.

The City's 311 system received over 20,000 complaints for after-hours construction noise in 2023. This rule requires the party responsible for a construction site to perform noise monitoring of the site. The data collected will identify any times when the sound levels exceeded those allowed by the Noise Code and the Alternative Noise Mitigation Plan (ANMP). This data will inform whether additional mitigation strategies are needed, or whether the hours that the work is permitted should be reduced or changed. Monitoring will also enable DEP to better advise the responsible party about what needs to be done to stay within prescribed noise levels. Appropriate noise attenuation is expected to reduce noise complaints.

The rule is authorized by section 1043 of the Charter of the City of New York as well as sections 24-204, 24-219 and 24-221, of the Administrative Code of the City of New York.

The text of the rule follows. New matter is underlined.

Section 1. Subdivision o of section 28-101 of chapter 28 of Title 15 of the Rules of the City of New York is relettered as subdivision s, and new subdivisions o, p, q and r are added, to read as follows:

o. Noise Monitoring at Construction Sites

1. When a new building construction project requires an Alternative Noise Mitigation Plan (ANMP) pursuant to Section 24-221, the duration of that ANMP is for 30 days (consecutive or non-consecutive) or longer, the building's gross floor area, as defined in section 202 of the Building Code, is 200,000 square feet or more, and the work site is within 50 feet of a residential receptor; at least one noise monitoring device must be placed facing the nearest sensitive receptors, as defined in 15 RCNY § 28-101(i), or the nearest residential receptor, whichever is closer. The application for the ANMP shall include a map identifying the sensitive and residential receptors within a 75 foot radius of the site that are shown on the Department of City Planning's ZoLa Map, which can be accessed at ZoLa | NYC's Zoning & Land Use Map¹, and the map shall show the proposed location of the noise monitoring device(s). The ANMP application shall also provide the number and locations of monitoring devices, and the responsible party's name and contact information.

2. The noise monitoring device(s) must be installed on the construction site and collect data for the duration of the project, until the construction activities taking place at the site are limited to minimal noise impact construction activities, as set forth in 15 RCNY § 30-102, and interior renovation work, as defined in 15 RCNY § 28-110.

3. Readings must be measured in A-scale and must be taken 24 hours a day for the duration of the project. The responsible party must transmit the data collected by the monitoring device(s) to DEP via the designated public API endpoint using the required API payload specifications. The data provided must include the location of the monitoring device, whether indicated by GPS coordinates or by an address entered manually; the recorded decibel level in A scale; the date and time of the reading; and the Lmax as defined in section 24-203 of the Noise Code, across a 5 minute sampling interval for the duration of the project. Such data must be transmitted at a minimum of once every hour for the duration of the project.

p. Noise Monitoring device installation and maintenance is required as follows:

1 <https://zola.planning.nyc.gov/about#9.72/40.7125/-73.733>.

1. Noise monitoring devices must be mounted approximately 8-10 feet off of the ground, either on a wall or on a pole. Each device must be equipped with an outdoor microphone with wind and rain protection that is at least a class 2 type microphone and conforms to IEC 61672-1. If wall-mounted, the device must be installed with the outdoor microphone at least one foot away from the nearest surface to avoid sound reflection.

2. The windscreens on each monitoring device must be checked at least once a month and replaced if there is any damage to the foam surface or other defect.

3. Noise monitoring devices can be powered via an external source or a rechargeable solar platform.

q. Subdivisions o and p of this section do not apply to:

1. the construction of a building in which all of the dwelling units will be affordable housing units as defined in section 26-2201 of the Administrative Code; or

2. emergency work as defined in section 24-223(e)(1) of the Administrative Code.

r. DEP may maintain an "Approved Devices" list in order to facilitate compliance with this rule. In order for a noise monitoring device to be added to the list, the device must satisfy the criteria set forth in subdivision o of this section. A device may be removed from the Approved Devices list at any time if the department determines that it does not meet such criteria. The Approved Devices list shall be posted on the department's website.

§ 2. This rule takes effect 120 days after publication in the City Record.

What laws govern the rulemaking process? MOME must meet the requirements of section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of section 1043(b) of the City Charter.

STATEMENT OF BASIS AND PURPOSE OF PROPOSED RULES

The Mayor's Office of Media and Entertainment ("MOME") is responsible for issuing New York City's press credentials to eligible members of the press and newsgathering organizations. A press credential or "press card" allows a press card holder, subject to space limitations and safety and evidence preservation concerns, to: (1) cross police, fire lines, or other restrictions, limitations, or barriers established by the City at emergency, spot, or breaking news events and public events of a non-emergency nature, and (2) attend City-sponsored events that are open to members of the press.

To reflect the City's ongoing commitment to the safety and wellbeing of New Yorkers while also supporting a free and independent press, MOME is proposing to amend its press credentials rules to:

- Add new definitions for the terms "Employment Verification," "Journalism Association," "Magazine," "Misuse," "News," "News Agency," "Newsgathering," "Newspaper," "Prearranged Interview," "Premier Press Card," "Press Association," and "Wire Service."
- Amend the definitions for the terms "Member of the Press," "Newsgathering Organization," and "Press Credential."
- Require applicants to be employed by or affiliated with a media platform (i.e., newspaper, magazine, news agency, press association, wire service etc.) owned or operated by a newsgathering organization, or be a member of a journalism association.
- Create a "Premier Press Card" credential for journalists with 20 years or more of newsgathering experience.
- Expand the grounds upon which a press credential may be denied, suspended or revoked to include (1) an open arrest for or prior conviction of a misdemeanor offense, regardless of whether the offense was committed during the course of newsgathering, and (2) making verbal or physical threats against another or placing another in reasonable fear of physical injury.
- Extend the maximum period of suspension of a press credential from six months to twelve months.

MOME is also proposing to amend its rule to require applicants to submit government-issued identification with a date of birth. The current rule requires the applicant to provide their personal identifying information but does not specify that the applicant must provide documentation or proof of identity.

Sections 389(b) and 1043 of the New York City Charter and section 3-119.4 of the Administrative Code of the City of New York authorize MOME to propose this rule.

Proposed Rule Amendments

"Shall" and "must" denote mandatory requirements and may be used interchangeably unless otherwise specified or unless the context clearly indicates otherwise.

Section 1. Chapter 16 of Title 43 of the Rules of the City of New York is amended to read as follows:

Chapter 16: Press Credentials

§ 16-01 Definitions.

As used in this chapter, the following terms have the following meanings:

Commissioner. “Commissioner” means the Commissioner of the Office of Media and Entertainment.

Emergency, spot, or breaking news event. An “emergency, spot, or breaking news event” means an incident or occurrence in a public place within the City of New York that was unplanned or unforeseen by an agency of the City of New York and is the subject of newsgathering, including, but not limited to, a crime scene, fire, train wreck, bombing, and plane crash.

Event sponsored by the City of New York that is open to members of the press. An “event sponsored by the City of New York that is open to members of the press” means an event that is organized by one or more agencies or offices of the City of New York that is available to more than one member of the press, including, but not limited to, a local press conference; provided, however, that such an event does not include a meeting of City employees or officials with individual members of the press or individuals engaged by a single newsgathering organization.

Employment Verification. “Employment verification” means either (i) a document issued by a newsgathering organization stating that the applicant for a Standard Press Card, Premier Press Card, or Single Event Press Card, is employed by the newsgathering organization either as an employee or as one otherwise professionally affiliated for gain or livelihood with such newsgathering organization or (ii) a document issued by a journalism association stating that the applicant for a Standard Press Card, Premier Press Card, or Single Event Press Card is a current member in good standing.

Journalism Association. “Journalism association” means a professional organization comprised of media practitioners that: (i) maintains an active membership program, (ii) establishes and enforces professional standards and ethical guidelines for its members, and (iii) provides advocacy, professional development, and support services to advance the interests of journalism professionals across print, broadcast, digital, and other media sectors.

Magazine. “Magazine” means a publication containing news which is published and distributed periodically, and has done so for at least one year, has a paid circulation and has been entered at a United States post-office as second-class matter.

Member of the press. A “member of the press” means an individual who [gathers and reports the news, by publishing, broadcasting, or cablecasting articles, commentaries, books, photographs, video, film, or audio by electronic, print, or digital media such as radio, television, newspapers, magazines, wire, books, and the Internet, including but not limited to an employee of a newsgathering organization or a self-employed newsperson] for gain or livelihood is engaged in the gathering, reporting, writing, editing, filming, taping or photographing of news, intended for a newspaper, magazine, news agency, press association or wire service or other media platform owned or operated by a newsgathering organization whose principal function is the processing and researching of news intended for public dissemination; such person shall be someone performing such function either as an employee or as one otherwise professionally affiliated for gain or livelihood with such media platform.

Misuse. “Misuse” means using a press credential for any purpose other than to cross police, fire lines, or other restrictions, limitations or barriers established by the City of New York at emergency, spot, or breaking news events and public events of a non-emergency nature where police, fire lines, or other restrictions, limitations, or barriers established by the City of New York have been set up for security or crowd control purposes within the City of New York or to attend events sponsored by the City of New York that are open to members of the press.

News. “News” means information about current events or matters of public interest that are based on verifiable facts and intended for dissemination to the public.

News Agency. “News agency” means an organization that collects and supplies news to subscribing newspapers, magazines, periodicals and news broadcasters.

Newsgathering. “Newsgathering” means when a member of the press engages in the gathering, reporting, writing, editing, filming, taping or photographing of news intended for a newspaper, magazine, news

agency, press association or wire service or other media platform owned or operated by a newsgathering organization.

Newsgathering organization. A “newsgathering organization” [is] means an organization or entity [that gathers and reports] whose principal function is to gather and report the news by publishing, broadcasting, or cablecasting articles, commentaries, books, photographs, video, film, or audio by electronic, print, or digital media such as radio, television, newspapers, magazines, wire, books, and the Internet for public dissemination.

Newspaper. “Newspaper” means a paper that is printed and distributed ordinarily not less frequently than once a week, and has done so for at least one year, and that contains news, articles of opinion (as editorials), features, advertising, or other matter regarded as of current interest, has a paid circulation and has been entered at United States post-office as second-class matter.

Prearranged interview. “Prearranged interview” means an interview of a City employee that is scheduled in advance and authorized in writing by the press officer or person designated by the Commissioner or agency head.

Premier Press Card. A “Premier Press Card” means a credential issued to a person with 20 years or more of experience as a member of the press pursuant to 43 RCNY § 16-04.

Press Association. “Press Association” means an association of newspapers, magazines, or broadcasters formed to gather and distribute news to its members.

Press credential. A “press credential” means a Standard Press Card, a Premier Press Card, a Reserve Press Card, or a Single Event Press Card.

Press Credential Unit. The MOME Press Credential Unit (“PCU”) is the division within MOME that administers and oversees the press credential issuance program.

Public event of a non-emergency nature. A “public event of a non-emergency nature” means an event in a public place within the City of New York that was planned, anticipated, approved, or permitted by one or more agencies or offices of the City of New York, including, but not limited to, a parade or demonstration.

Reserve Press Card. A “Reserve Press Card” means a credential issued to a newsgathering organization pursuant to 43 RCNY § [16-04] 16-05.

Reserve Press Card authorized user. A “Reserve Press Card authorized user” means a member of the press who has been temporarily issued a Reserve Press Card by a newsgathering organization pursuant to 43 RCNY § [16-05] 16-06.

Single Event. A “Single Event” means a discrete activity that is an emergency, spot, or breaking news event, a public event of a non-emergency nature, or an event sponsored by the City of New York that is open to members of the press.

Single Event Press Card. A “Single Event Press Card” means a credential issued pursuant to 43 RCNY § [16-05] 16-06 to a member of the press to cover a Single Event.

Standard Press Card. A “Standard Press Card” means a credential issued to a member of the press pursuant to 43 RCNY § 16-03.

Wire Service. “Wire Service” means an organization that gathers and processes news for electronic distribution to multiple paying subscribers.

§ 16-02 Press Card Access.

- (a) A Standard Press Card holder, a Single Event Press Card holder, Premier Press Card holder, or a Reserve Press Card authorized user is entitled (i) subject to space limitations and safety and evidence preservation concerns, to cross police, fire lines, or other restrictions, limitations or barriers established by the City of New York at emergency, spot, or breaking news events and public events of a non-emergency nature where police, fire lines, or other restrictions, limitations, or barriers established by the City of New York have been set up for security or crowd control purposes, within the City of New York; and (ii) subject to space limitations and safety concerns, to attend events sponsored by the City of New York that are open to members of the press.
- (b) When there is a denial of a Standard Press Card holder’s, Single Event Press Card holder’s, Premier Press Card holder’s, or Reserve Press Card authorized user’s ability to cross police or fire lines, or other restrictions, limitations, or barriers established by the City of New York or attend events sponsored by the City of New York, such denial must come from a authorized person of the City agency(ies) or office(s) sponsoring the event or a supervising officer or a member of

the Office of the Deputy Commissioner, Public Information of the New York City Police Department ("NYPD").

- (c) Upon request from an authorized person of the City agency(ies) or offices sponsoring the event or a supervising officer or a member of the Office of the Deputy Commissioner, Public Information of the NYPD, a Reserve Press Card authorized user must provide identification (i) when seeking to cross police or fire lines, or other restrictions, limitations, or barriers established by the City of New York or attend events sponsored by the City of New York; and (ii) at any time after such access has been granted.
- (d) A Single Event Press Card holder who is under sixteen (16) years old:
 - i. must be accompanied by a parent, a legal guardian, or a responsible adult who is at least eighteen (18) years old when seeking to cross police or fire lines, or other restrictions, limitations, or barriers established by the City of New York or attend events sponsored by the City of New York, and at all times after such access has been granted. Only one parent, legal guardian, or responsible adult must accompany no more than one Single Event Press Card holder who is under sixteen (16) years old to each event for which the Single Event Press Card is issued.
 - ii. In the discretion of the Commissioner or the Commissioner's designee, the Mayor's Office of Media and Entertainment may waive this requirement for a Single Event Press Card holder who is under sixteen (16) years old taking into account the criteria listed in § [16-05] 16-06(e)(iv)(C);
- (e) A Single Event Press Card Holder who is sixteen (16) years old to eighteen (18) years old: In the discretion of the Commissioner or the Commissioner's designee, the Mayor's Office of Media and Entertainment may require, after taking into account the criteria listed in § [16-05] 16-06(e)(iv)(C), that the Single Event Press Card holder be accompanied by a parent, a legal guardian, or a responsible adult who is at least eighteen (18) years old when seeking to cross police or fire lines, or other restrictions, limitations, or barriers established by the City of New York or attend events sponsored by the City of New York, and at all times after such access has been granted. Only one parent, legal guardian, or responsible adult must accompany no more than one Single Event Press Card holder who is sixteen (16) years old until eighteen (18) years old to each event for which the Single Event Press Card is issued.
- (f) In the discretion of the Commissioner or the Commissioner's designee, the Mayor's Office of Media and Entertainment may require the person accompanying the Single Event Press Card Holder pursuant to § 16-02(d) or § 16-02(e) to wear a badge or other identification issued by PCU.

§ 16-03 Standard Press Card.

- (a) To be eligible for a Standard Press Card, an individual must be a member of the press who is at least eighteen (18) years old and who covers, in person:
 - i. emergency, spot, or breaking news events, or public events of a non-emergency nature where police or fire lines, or other restrictions, limitations, or barriers established by the City of New York have been set up for security or crowd control purposes; or
 - ii. events sponsored by the City of New York that are open to members of the press.
- (b) Supervisory or managerial personnel of a newsgathering organization may be issued the Standard Press Card if their responsibilities require that they cover, in person, the events specified in paragraphs (i) or (ii) of subdivision (a) of this section.
- (c) The Standard Press Card cycle is two (2) years. All Standard Press Cards expire on January 15 of every odd year.
- (d) The Standard Press Card must bear the name and photograph of the individual to whom it is issued, and the name of the newsgathering organization[, if any,] that employs such member of the press, together with other information designated by the Commissioner or head of the PCU. Any additional information designated by the Commissioner or head of the PCU shall be provided on MOME's website.
- (e) An individual who is eligible under subdivision (a) or (b) of this section may apply for a Standard Press Card by completing an application that includes the applicant's [personal identifying information and] government-issued photo identification card that

contains the applicant's date of birth, the name of the newsgathering organization[, if any,] that employs the individual, and employment verification. The applicant must submit six (6) or more articles, commentaries, books, photographs, videos, films, or audios published, broadcast, or cablecast on a media platform owned or operated by a newsgathering organization within the twenty-four (24) months immediately preceding the Standard Press Card application, sufficient to show that such applicant covered, in person, six (6) or more events occurring on separate days described in subdivision (a) of this section.

(f) An application for a Standard Press Card will be granted or denied no later than thirty (30) days after the applicant submits a complete application for the Press Card. If an application for a Standard Press Card is denied, the applicant shall be advised in writing of the basis for the denial.

(g) An individual must appear in person to pick up a Standard Press Card if their application is granted. If the individual was issued a Standard Press Card during the previous cycle, they must surrender such card in person to MOME. If such card was lost or stolen, they must provide a Verification of Crime/Lost Property Report issued by the New York City Police Department.

§ 16-04 Premier Press Card.

- (a) To be eligible for a Premier Press Card, an individual must be a member of the press who has twenty (20) years or more of news gathering experience, and who covers news events within New York City or conducts Prearranged Interviews.
- (b) The Premier Press Card cycle is two (2) years. All Premier Press Cards expire on January 15 of every odd year.
- (c) The Premier Press Card must bear the name and photograph of the individual to whom it is issued, and the name of the newsgathering organization that employs such member of the press, together with other information designated by the Commissioner or head of the PCU.
- (d) An individual who is eligible under subdivision (a) of this section may apply for a Premier Press Card by completing an application that includes the applicant's government-issued photo identification card that contains the applicant's date of birth, a resume or other document showing twenty (20) years or more of newsgathering experience, the name of the newsgathering organization that employs the individual, and employment verification. The applicant must submit six (6) or more articles, commentaries, books, photographs, videos, films, or audios published, broadcast, or cablecast on a media platform owned or operated by a newsgathering organization within the twenty-four (24) months immediately preceding the Premier Press Card application.
- (e) An application for a Premier Press Card will be granted or denied no later than thirty (30) days after the applicant submits a complete application for the Premier Press Card. If an application for a Premier Press Card is denied, the applicant shall be advised in writing of the basis for the denial.
- (f) An individual must appear in person to pick up a Premier Press Card if their application is granted. If the individual was issued a Premier Press Card during the previous cycle, they must surrender such card in person to MOME. If such card was lost or stolen, they must provide a Verification of Crime/Lost Property Report issued by the New York City Police Department.

§ [16-04] 16-05 Reserve Press Card.

- (a) A Reserve Press Card is only issued to a newsgathering organization that employs or otherwise engages an individual(s) who is a member of the press to cover, in person:
 - i. emergency, spot, or breaking news events, or public events of a non-emergency nature, where police, fire lines, or other restrictions, limitations, or barriers established by the City of New York have been set up for security or crowd control purposes; or
 - ii. events sponsored by the City of New York that are open to members of the press.
- (b) In its discretion, the Mayor's Office of Media and Entertainment may issue more than one Reserve Press Card to a single newsgathering organization based on the newsgathering organization's demonstration of need.
- (c) The Reserve Press Card cycle is two (2) years. All Reserve Press Cards expire on January 15 of every odd year.
- (d) The Reserve Press Card bears the name of the newsgathering organization to which it is issued together with other information designated by the Commissioner or head of the PCU. Any additional information designated by the Commissioner or head of the PCU shall be provided on MOME's website.
- (e) A newsgathering organization that qualifies under subdivision (a) of this section may apply by completing an application that includes information about the newsgathering organization and members of the

press engaged by the newsgathering organization. The newsgathering organization must submit six (6) or more articles, commentaries, books, photographs, videos, films, or audios published, broadcast, or cablecast on a media platform owned or operated by a newsgathering organization on separate days within the twenty-four (24) months immediately preceding the Reserve Press Card application, sufficient to show that the newsgathering organization complies with subdivision (a) of this section.

(f) An application for a Reserve Press Card shall be granted or denied no later than thirty (30) days after the applicant submits a complete application for the Reserve Press Card. If an application for a Reserve Press Card is denied, the applicant shall be advised in writing of the basis for the denial pursuant to 43 RCNY § [16-06] 16-07.

(g) An authorized representative of a newsgathering organization must appear in person to pick up the Reserve Press Card(s) if the application is approved. If the newsgathering organization was issued a Reserve Press Card(s) during the previous cycle, it must surrender all such card(s) in person to MOME. If such card(s) was lost or stolen, it must provide a Verification of Crime/Lost Property Report issued by the NYPD.

(h) The newsgathering organization holding a Reserve Press Card(s) may provide a Reserve Press Card to an individual who is a member of the press employed or engaged by the newsgathering organization if:

- i. such individual does not already have a Standard Press Card issued in accordance with 43 RCNY § 16-03;
- ii. such individual is not currently subject to a period of suspension or revocation of a Standard Press Card or Single Event Press Card, or such individual's conduct within the past six (6) months is not characterized by any of the criteria for suspension or revocation set forth in paragraph (iii) of subdivision (b) or paragraph (iii) of subdivision (c) of 43 RCNY § [16-06] 16-07;
- iii. the newsgathering organization directs such individual to complete a specific assignment that requires the individual to cover, in person:

(A) an emergency, spot, or breaking news event, or a public event of a non-emergency nature, where police or fire lines, or other restrictions, limitations, or barriers established by the City of New York have been set up for security or crowd control purposes; or

(B) an event sponsored by the City of New York that is open to members of the press; and

- iv. such individual is at least eighteen (18) years old.

(i) When the editor or supervising employee of the newsgathering organization has determined that the Reserve Press Card authorized user completed the specific assignment for which the Reserve Press Card was issued, the Reserve Press Card authorized user must promptly return the Reserve Press Card to the editor or supervising employee of the newsgathering organization.

§ [16-05] 16-06 Single Event Press Card.

(a) To be eligible for a Single Event Press Card for a Single Event, an individual must be a member of the press who:

i. published, broadcast, or cablecast on a media platform owned or operated by a newsgathering organization six (6) or more articles, commentaries, books, photographs, videos, films, or audios within the twenty-four (24) months immediately preceding pre-registration;

ii. covers in-person emergency, spot, or breaking news events, or public events of a non-emergency nature where police or fire lines, or other restrictions, limitations, or barriers established by a governmental entity have been set up for security or crowd control purposes or events sponsored by a governmental entity that are open to members of the press;

[ii] iii. completed the pre-registration process set forth in subdivision (e) of this section; and

[iii] iv. timely submitted a completed application for a Single Event Press Card.

(b) An individual must apply for a Single Event Press Card by the following deadlines:

- i. no fewer than ten (10) days before the Single Event if the Single Event was announced to the public at least two (2) weeks in advance of the Single Event; or
- ii. no later than two (2) business days after the Single Event was announced to the public for a Single Event scheduled fewer than two (2) weeks in advance; or
- iii. if there is less than two (2) days' notice of the Single Event or in an exigent circumstance, the application should be submitted as soon as practicable.

(c) Each pre-registration will be valid for up to two (2) years, expiring on January 15 of every odd year. Each Single Event Press Card will be valid for the shorter of the duration of the Single Event or twenty-four (24) hours; provided, however, that MOME may issue a Single Event Press Card for longer than twenty-four (24) hours if the Single Event has a duration of more than twenty-four (24) hours.

(d) A Single Event Press Card bears the name, photograph, and newsgathering organization, [if any] that employs the member of the press to whom it is issued, together with other information designated by the Commissioner or head of the PCU.

(e) An individual may

i. pre-register by completing an application that includes such applicant's [personal identifying information] government-issued photo identification card that contains the applicant's date of birth, [and] the name of the newsgathering organization [if any], that employs the individual, and employment verification. The applicant must submit six (6) or more articles, commentaries, books, photographs, videos, films, or audios published, broadcast, or cablecast on a media platform owned or operated by a newsgathering organization within the twenty-four (24) months immediately preceding the pre-registration, sufficient to show that such applicant covered, in person, six (6) or more events occurring on separate days;

ii. apply for a Single Event Press Card by providing information that describes the Single Event, including the date(s) and location(s) of such Single Event; and

iii. apply for a renewal of a Single Event Press Card upon a demonstration that the Single Event is continuing beyond the expiration of the Single Event Press Card that has been issued to such individual.

iv. If the individual is under eighteen (18) years old:

- (A) the individual may apply for a Single Event Press Card that provides access to a public event of a non-emergency nature or an event sponsored by the City of New York that is open to members of the press;
- (B) the individual's parent or legal guardian must provide their consent in writing on a form provided by MOME. The parent or legal guardian's consent must be submitted with each pre-registration application, each Single Event Press Card application, and each renewal application, and
- (C) In the discretion of the Commissioner or the Commissioner's designee, PCU may consider factors such as the individual's age, nature of the event, the event's location, event's duration, space limitations, potential safety risks, available space behind police, fire lines or City barriers, the impact of space limitations and the safety of individuals required to accompany the Single Event Press Card applicant pursuant to § [16-06] 16-07(d), among other factors, when assessing whether to issue a Single Event Press Card to an individual under eighteen (18) years old.

(f) An application for a Single Event Press Card will be granted or denied no later than two (2) business days before the scheduled event, except that in the case of applications submitted fewer than two (2) weeks before the scheduled event, the application shall be granted or denied as soon as practicable. If an application for a Press Card is denied, the applicant shall be advised in writing of the basis for the denial pursuant to 43 RCNY § [16-06] 16-07.

(g) An individual must appear in person to obtain a Single Event Press Card if their application is granted.

(h) MOME's failure to issue a Single Event Press Card prior to the conclusion of a Single Event that is the subject of an application shall not be deemed to constitute a denial subject to subdivision (a) of 43 RCNY § [16-06] 16-07 if such application was received fewer than two (2) weeks in advance of such Single Event.

(i) Within three (3) business days of the expiration of a Single Event Press Card, the Single Event Press Card holder must either return the card in person to MOME, mail the card in a postage-paid envelope addressed to MOME, or provide the card to a courier or delivery service for delivery to MOME. MOME will post its address for mail and deliveries of Single Event Press Cards on its website. If such card is not received by MOME and the individual subsequently applies for a press credential, the individual must provide as a condition of receiving a press credential:

- i. a Verification of Crime/Lost Property Report issued by the New York City Police Department; or
- ii. proof of mailing or use of a courier or delivery service in a form acceptable to MOME.

§ [16-06] 16-07 Appeals and Hearings.

(a) *Denial of application.*

i. *Right to appeal.*

(A) Any applicant who is denied a press credential shall be

notified in writing of the basis of the denial and their right to appeal the denial by requesting a hearing before the adjudicatory body authorized to conduct trials at the Office of Administrative Trials and Hearings ("OATH"), in accordance with Section 1046 of the City Charter and Title 48 of the Rules of the City of New York.

(B) An applicant seeking to appeal a denial to OATH must request, through MOME, a hearing within sixty-five (65) days of the date of the denial. The request to MOME must be in writing and submitted on a form prescribed by MOME, which shall process the request and forward to OATH all relevant documentation received from the applicant.

(C) Upon receipt of the request submitted through MOME, OATH will hold the hearing within sixty (60) days of the date the applicant's request was received by MOME, except where the parties jointly agree on a later hearing date, an adjournment is granted pursuant to OATH's rules of practice and procedures, or where extraordinary circumstances prevent such scheduling, as determined by the Chief Administrative Law Judge or their designee.

ii. *Criteria.* One or more of the following criteria must be met to justify a denial of an application for a press credential:

(A) The applicant failed to meet the eligibility qualifications described in the definition of a "member of the press" or "newsgathering organization", as applicable, set forth in 43 RCNY § 16-01; or

(B) The applicant failed to meet the eligibility requirements for the press credential; or

(C) The applicant failed to complete all administrative requirements or instructions set forth in these rules or in the application; provided, however, that MOME will notify the applicant of any incomplete requirements and provide an opportunity for the applicant to complete the application within five (5) business days of notification; or

(D) The applicant failed to truthfully respond to application questions or provided fraudulent proof of eligibility; provided, however, that the application will not be denied on the basis of an immaterial error in the application that is corrected by the applicant within five (5) business days of notification by MOME; or

(E) The applicant (1) has an open case for a lawful arrest for or was convicted of a misdemeanor [while newsgathering] or has an open case for a lawful arrest for or was convicted of a felony; and (2) the Mayor's Office of Media and Entertainment determines that granting a press credential to such applicant would involve an unreasonable risk to property or to the safety or welfare of specific individuals or the general public; or

(F) The applicant failed to complete a period of suspension or revocation concerning a previously issued press credential; or

(G) The applicant was responsible for the misconduct resulting in the suspension or revocation of a Reserve Press Card and such period of suspension or revocation has not expired, or

(H) The applicant engaged in conduct set forth in paragraphs (B)-(F)] (H) of paragraph (iii) of subdivision (b) of this section.

(b) *Suspension.*

i. *Right to a hearing.* MOME is the only agency authorized to suspend a press credential. A press credential may not be suspended by MOME prior to a hearing and a determination that a suspension is proper, based on the criteria set forth in paragraph (iii) of this subdivision. Upon MOME's determination that a press card was seized by an agency, office, official, or employee of the City of New York in violation of this paragraph, MOME shall promptly replace the press card.

ii. *Procedure and burden of proof.* The hearing will be held before the adjudicatory body authorized to conduct trials at OATH, in accordance with Section 1046 of the Charter and Title 48 of the Rules of the City of New York; provided, however, that consistent with subdivision (f) of § 3-119.4 of the New York City Administrative Code, the applicable burden of proof for a suspension of a press credential is clear and convincing evidence.

iii. *Criteria.* One or more of the following criteria must be met to justify the suspension of a press credential. The Standard Press Card holder, Premier Press Card holder, or Single Event Press Card holder:

(A) (1) has an open case for a lawful arrest for or was convicted of a misdemeanor [while newsgathering] or has an open case for a lawful arrest for or was convicted of a felony and (2) continued use of the press credential would involve an unreasonable risk to property or to the safety or welfare of specific individuals or the general public; or

(B) while engaged in a newsgathering capacity, failed to comply with a lawful order of a police officer or an authorized person of the City agency(ies) or office(s) sponsoring the event; or

(C) while engaged in a newsgathering capacity, intentionally interfered or attempted to interfere with the performance of an official function of a police officer or an authorized person of the City agency(ies) or office(s) sponsoring the event; or

(D) misused or misrepresented a press credential issued by the City of New York; or

(E) conducted an unauthorized transfer or assignment of such credential; or

(F) engaged in verbal or physical threats to the safety or welfare of specific individuals or the general public, or placed a person in unreasonable fear of physical injury; or

(F)] (G) engaged in other conduct that involved an unreasonable risk to property or to the safety or welfare of specific individuals or the general public, or interfered with official law enforcement or emergency personnel needs while engaged in a newsgathering capacity.

iv. *Reserve Press Cards.* A newsgathering organization's Reserve Press Card(s) may be suspended if:

- (A) the newsgathering organization issues the Reserve Press Card to an authorized user who engages in conduct set forth in subparagraphs (A)-(F)] (G) of paragraph (iii) of this subdivision, and (2) the newsgathering organization's continued use of a Reserve Press Card(s) would involve an unreasonable risk to property or to the safety or welfare of specific individuals or the general public; or
- (B) the newsgathering organization issues the Reserve Press Card to an individual who does not meet all criteria set forth in paragraph (h) of Section [16-04] 16-05.

v. *Period of suspension.*

(A) The hearing officer will consider the following factors in determining the length of a suspension:

- 1. whether misconduct actually occurred;
- 2. the seriousness of any misconduct;
- 3. the risk that the press credential holder will engage in future misconduct or, in the case of a Reserve Press Card, the Reserve Press Card authorized user will engage in future misconduct;
- 4. the press credential holder's history of suspensions or a prior revocation, if any; and
- 5. any other factors raised by the parties at the hearing.

(B) The maximum length of a suspension shall be no more than [six (6)] twelve (12) months, except that if the suspension resulted from a lawful arrest or indictment based on the press credential holder's or Reserve Press Card authorized user's commission of a misdemeanor or felony, then the length of the suspension may be extended until resolution of the criminal proceedings, and, if an arrest results in a conviction or guilty plea, then the length of the suspension shall be the period of imprisonment that results from the conviction or guilty plea or six months, whichever is greater.

vi. *Press credentials during suspension.* If a Standard Press Card, Premier Press Card, or a Single Event Press Card is suspended, the Standard Press Card holder, Premier Press Card, or Single Event Press Card holder may not obtain or use a press credential during the period of suspension.

vii. *Expiration during suspension.* If a press credential expires during suspension, the press credential holder may not apply for a new press credential until the period of suspension is complete.

(c) *Revocation.*

i. *Right to a hearing.* MOME is the only agency authorized to revoke a press credential. A press credential may not be revoked by MOME prior to a hearing and a determination that a revocation is proper based on the criteria set forth in paragraph (iii) of this subdivision. Upon MOME's determination that a press card was seized by an agency, office, official, or employee of the City of New York in violation of this paragraph, MOME shall promptly replace the press card.

ii. *Procedure and burden of proof.* The hearing will be held before the adjudicatory body authorized to conduct trials at OATH, in accordance with Section 1046 of the City Charter and Title 48 of the Rules of the City of New York; provided, however, that consistent with subdivision (f) of § 3-119.4 of the New York City Administrative Code, the applicable burden of proof for a revocation of a press credential is clear and convincing evidence.

iii. *Criteria.* One or more of the following criteria must be met to justify the revocation of a press credential. The Standard Press Card holder, Premier Press Card holder, Single Event Press Card holder, or the Reserve Press Card holder:

(A) made a misrepresentation or a made a material error or omission in the press credential application which, if known by MOME at the time of application, would have justified a denial; or

(B) had two or more suspensions of a press credential within that credential's two-year cycle; or

(C) used a press credential during a period of suspension or revocation; or

(D) the Press Card holder's continued possession of a press credential creates an unreasonable risk to property or to the safety or welfare of specific individuals or the general public that cannot be resolved by a suspension.

iv. If a press credential is revoked, the press credential holder may not re-apply for a new press credential until one year after the date of the written decision to revoke the press credential.

v. *Press credentials during revocation.* If a press credential is

revoked, the press credential holder may not obtain or use a press credential during the period of revocation.

Pursuant to City Environmental Quality Review (CEQR), Mayoral Executive Order No. 91 of 1977, CEQR Rules of Procedure of 1991 and the regulations of Article 8 of the State Environmental Conservation Law, State Environmental Quality Review Act (SEQRA) as found in 6 NYCRR Part 617, a Draft Environmental Impact Statement (DEIS) has been prepared for the action described below. Copies of the DEIS are available for public inspection at the office of the undersigned as well as online via the Monitor Point project page on ZAP: <https://zap.planning.nyc.gov/projects/2024K0358>. To view the Monitor Point DEIS, navigate to the project page in ZAP and select Public Documents, then "DEIS_25DCP068K." The proposal involves actions by the City Planning Commission (CPC) and the New York City Council pursuant to Uniform Land Use Review Procedure (ULURP). A public hearing on the DEIS will be held at a later date to be announced, in conjunction with the City Planning Commission's citywide public hearing pursuant to ULURP. Advance notice will be given of the time and place of the hearing. Written comments on the DEIS are requested and would be received and considered by the Lead Agency until the 10th calendar day following the close of the public hearing.

GO Quay, LLC (the Project Developer) and the New York State Metropolitan Transportation Authority (MTA) (an affiliate of the New York City Transit Authority [NYCTA]) (collectively, the Applicants) are seeking several discretionary actions including a zoning map amendment, zoning text amendment, zoning special permits, certification, and a City Map amendment (collectively, the Proposed Actions). The Proposed Actions would apply to a rezoning area consisting of Brooklyn Block 2590, Lot 25, the majority of Lot 1, and the northern half of the former Quay Street in the Greenpoint neighborhood of Brooklyn, Community District (CD) 1 (the Rezoning Area); the remaining portion of Lot 1 (which would not be rezoned); and a relocation site that would house two NYCTA facilities that are being relocated from their existing locations and consolidated into a new turnkey facility located at 213 Meadow Street (Block 2951, Lots 1, 5, and 45) in the East Williamsburg neighborhood of Brooklyn CD 1 (the NYCTA Relocation Site) that would be constructed by the Project Developer. The Rezoning Area, the remaining portion of Lot 1 that will not be rezoned, and the NYCTA Relocation Site are, collectively, the Affected Area.

The Proposed Actions would facilitate on the Development Site (Brooklyn Block 2590, Lots 1 and 25) a mixed-use development that would comprise three buildings totaling approximately 1,215,000 gross square feet (gsf) (7.13 FAR) (the Proposed Development). The Proposed Development would involve the construction of two buildings on Lot 1 totaling approximately 1,106,500 gsf of residential space for up to approximately 1,150 total dwelling units (DUs). Additionally, the Proposed Development would include the construction on Lot 25 of approximately 35,000 gsf of community facility space (0.25 FAR) earmarked as a permanent home for the Greenpoint Monitor Museum, which is owned by the Monitor Museum. It is the Project Developer's intent to pursue Mandatory Inclusionary Housing (MIH) Option 1, under which 25 percent (up to approximately 300) of the proposed units would be affordable at an average of 60 percent Area Median Income (AMI), pursuant to MIH requirements. However, the Project Developer intends to provide the affordable units at an average of 56 percent AMI. The development would also include approximately 36,500 gsf (0.26 FAR) of local retail commercial space and approximately 37,000 gsf of below-grade parking (approximately 140 spaces) in a single cellar level accessed via a new curb cut on Quay Street on Lot 1.

The Proposed Development would introduce a newly created turnaround at the western end of Quay Street, at its terminus, adjacent to Wharf Drive. The portions of the turnaround area that extend beyond the mapped street would be considered as Public Access Area (PAA), with an area of approximately 2,000 sf. The Proposed Development would also include substantial open space improvements, introducing approximately 50,000 sf (~1.15 acre) of open space—43,000 sf of which would be publicly accessible, including 34,000 sf of required Waterfront Public Access Area (WPAA), which would provide a pedestrian connection between the future Bushwick Inlet Park and the

existing Shore Public Walkway to the north of the site and an upland connection between the future Bushwick Inlet Park and West Street, plus an additional 9,000 sf of PAA. The remaining 7,000 sf of open space would be made up of space for museum visitors as well as landscaping and planting areas that would visually blend and physically connect with the WPAA and PAA spaces. In addition to this new open space, as part of the Proposed Development, long-term funding, in the amount of \$300,000 annually, would be provided to the City/New York City Department of Parks and Recreation (NYC Parks) for the operation of Bushwick Inlet Park.

Furthermore, the Proposed Development would include resiliency and flood protection measures on the Development Site—including installation of a new bulkhead to defend against future flooding due to sea level rise; implementation of wet floodproofing for non-critical and dry floodproofing for critical features; and the inclusion of green roofs, green infrastructure, and soft surfaces where feasible and practicable.

In order to allow for the redevelopment of the Development Site, the Proposed Actions also involve the relocation and consolidation of two existing critical NYCTA facilities to a new 143,000-gsf turnkey facility at the NYCTA Relocation Site. The proposed NYCTA Relocation Site would accommodate the NYCTA Mobile Wash Unit and Materials Storage currently located on a portion of the Development Site (Block 2590, Lot 1) (the NYCTA Facility), and the NYCTA Emergency Response Unit (ERU) facility currently located on 65 Commercial Street (Block 2472, Lot 415) (the ERU Site).

The Proposed Development would remove from the waterfront the existing industrial building on Lot 1, which currently houses NYCTA operations and is a non-compliant industrial use in the existing residential zoning district. Lot 1 was rezoned to an R6 zoning district as part of the 2005 Greenpoint-Williamsburg Rezoning (CEQR No. 04DCP003K), establishing this site for future residential development. The current proposal is the fulfillment of the City's vision for this site as established by the 2005 rezoning.

The removal of the NYCTA Facility from the Development Site eliminates a non-compliant industrial use from a neighborhood increasingly characterized by residential and retail uses, while also improving public safety by removing truck traffic. The removal of the NYCTA Facility on Lot 1 also eliminates a wall to the waterfront, replacing it with a new access point in the form of the WPAA. The relocation of the ERU Facility (currently located at 65 Commercial Street) to the NYCTA Relocation Site would create a fully vacant site at Commercial Street, which would facilitate the full realization of the City's planned Box Street Park by allowing for an additional approximately 25,000 sf of publicly accessible open space at the ERU Site in the future. No land use actions are associated with the departure of the ERU Facility from 65 Commercial Street; the existing ERU Facility operates under a lease, and NYCTA will be terminating the lease and vacating that property.

The NYCTA Relocation Site, located in the North Brooklyn Industrial Business Zone (IBZ) in East Williamsburg, would be redeveloped with an approximate 3-story, approximately 143,000-gsf building (the NYCTA Replacement Facility) that would include space for the Mobile Wash and Material Control uses to be relocated from the NYCTA Facility on Lot 1 and the ERU Facility to be relocated from the ERU Site. To facilitate the Proposed Development, the Applicants are seeking the approval of several discretionary actions/approvals, as part of the Proposed Actions, that would apply to the Rezoning Area, the Development Site, and NYCTA Relocation Site.

To facilitate the Proposed Development, the Applicants are seeking the approval of Proposed Actions, which would apply to the Rezoning Area:¹ **(I) a zoning map amendment** to rezone (1) Block 2590, Lot 25 from M3-1 to R8; (2) a portion of Block 2590, Lot 1 from (a) R6 to R8/C2-4 and (b) R6/C2-4 to R8/C2-4; (3) the northern half of former Quay Street from M3-1 to R6; and (4) modify the park boundary to exclude Lot 25 and the northern half of former Quay Street; **(II) zoning text amendments** to the Zoning Resolution (ZR), as amended will include: (1) To amend ZR Section 62-361 (Special Floor Area Regulations) to allow the underlying MIH FAR to apply to MIH sites within BK-1; (2) To amend ZR Section 62-931 (Waterfront Access Plan BK-1: Greenpoint-Williamsburg) to remove the park identification of Block 2590, Lot 25 and the former Quay Street and update WAP BK-1 maps; (3) To amend ZR Section 62-363 (Special Height and Setback Regulations) to update special height and setback regulations for R8/MIH sites within BK-1; (4) To amend ZR Appendix F to map an MIH area coterminous with the Development Site; (5) To amend ZR Section 74-745 to allow the waiver or reduction of required loading berths as part of a Large Scale special permit within WAP BK-1; **(III) zoning special permits** pursuant to ZR Sections 74-743(a)(2) and 74-745 for Large Scale General Development

(LSGD) applicable to the Development Site to allow the following modifications in order to achieve a superior site plan: ZR 62-343, 62-363, 36-62, and 62-332(a) (height and setback, maximum tower width, maximum tower size, loading, and waterfront yard depth); **(IV) a zoning certification** by the Chairperson of the City Planning Commission pursuant to ZR Section 62-811 (Waterfront public access and visual corridor; and **(V) an amendment to the City Map** to remove the existing park identification from Lot 25 and the former Quay Street to facilitate development of a publicly accessible open space and a permanent home for the Greenpoint Monitor Museum as part of the Proposed Development.

In addition to the Proposed Actions, Monitor Museum, as the owner of Lot 25, is seeking the following amendments to currently held State and Federal permits, which are necessary to facilitate the development of the landscaped Waterfront Public Access Area: amendment of existing or new New York State Department of Environmental Conservation (DEC) Tidal Wetland and Protection of Waters permits in connection with shoreline restoration work on Lot 25; application for new DEC Tidal Wetland and Protection of Waters permits on Lot 1 (sought by the Project Developer); and amendment of U.S. Army Corps of Engineers (USACE) Section 10 and Section 404 permits in connection with shoreline restoration work on Lot 25.

Additional State actions, not subject to CPC review include: MTA Board approval of the lease and redevelopment of Lot 1 and the lease and redevelopment (including approval of rear yard bulk waiver) of the NYCTA Relocation Site; and DEC for Brownfield Cleanup Program (BCP); not a SEQRA Action.

In addition, the project approvals would include establishment of an (E)-designation (E-870) on the NYCTA Relocation Site to codify restrictions related to hazardous materials and air quality; and a Restrictive Declaration (RD) that would be recorded against the Development Site to codify restrictions related to air quality and noise, Project Components Related to the Environment (PCREs) regarding construction-related air quality and noise commitments, and mitigation measures related to transportation (traffic) and construction-related transportation (traffic).

In order to assess the possible effects of the Proposed Actions, a Reasonable Worst-Case Scenario (RWCDs) was established for both the Future Without the Proposed Actions (No-Action) and the Future With the Proposed Actions (With-Action) Conditions for a 2031 analysis year. The analysis year assumes approval of the Proposed Actions in 2026 and that construction of the NYCTA Replacement Facility would commence shortly thereafter, with construction of the Proposed Development beginning subsequent to the NYCTA's relocation. It is estimated that construction of the NYCTA Replacement Facility would last approximately 18 months, plus an additional 2 months to relocate operations into the new facility, followed by subsequent demolition of the existing NYCTA Facility on Lot 1 (6 months), with construction of the Proposed Development (approximately 36 months) being completed in 2031. This timeline accounts for the construction of a new, approximately 143,000-gsf turnkey NYCTA facility in East Williamsburg; relocation of the existing NYCTA Facility to the NYCTA Relocation Site; demolition of the NYCTA Facility on the Development Site; and the construction of the Proposed Development, including all shoreline improvements and public open space. Accordingly, the EIS uses a 2031 build year.

In the No-Action Condition, it is assumed that existing conditions at both the Development Site and the NYCTA Relocation Site would remain. The With-Action Condition is the same as the Proposed Development, which is described above. The incremental difference between the No-Action and With-Action Conditions serves as the basis of the impact category analyses. The 2021 *CEQR Technical Manual* serves as guidance on the methodologies and impact criteria to evaluate the potential environmental effects of the Proposed Actions.

The EIS assesses whether development resulting from the Proposed Actions could result in significant adverse environmental impacts. The EIS identifies potential significant adverse impacts related to transportation (traffic and pedestrians), and construction (traffic, pedestrians, and noise).

Of the 13 intersections analyzed, the Proposed Actions would result in significant adverse traffic impacts at four intersections (at six specific traffic movements) during the weekday AM peak hour, four intersections (at six specific traffic movements) during the weekday midday peak hour, five intersections (at nine specific traffic movements) during the weekday PM peak hour, and five intersections (at seven specific traffic movements) during the Saturday peak hour. Standard traffic capacity improvements typically implemented by the New York City Department of Transportation (NYC DOT), such as signal timing modifications, could mitigate traffic impacts at two intersections during the weekday AM peak hour, three intersections during the weekday midday peak hour, four intersections during the weekday PM peak hour, and two intersections during the Saturday

¹ Lot 25 and a portion of Lot 1 would be rezoned under the Proposed Actions. A portion of Lot 1 would remain R6. However, all of the Development Site would be mapped MIH.

peak hour. However, significant traffic impacts to the following five intersections would remain unmitigated: Franklin Street and Quay Street (weekday midday, weekday PM, and Saturday peak hours); Franklin Street and Greenpoint Avenue (weekday AM peak hour); McGuinness Boulevard and Greenpoint Avenue (Saturday peak hour); West Street and Oak Street (weekday AM peak hour); and Franklin Street and Milton Street (Saturday peak hour). The proposed mitigation measures are subject to review and approval by NYC DOT. If, prior to implementation, NYC DOT determines that any of the identified mitigation measures are infeasible, and no other alternative and equivalent mitigation measures could be advanced, then the impacts would remain unmitigated and would constitute an unavoidable significant adverse impact.

Of the 22 pedestrian elements analyzed, significant adverse pedestrian impacts were identified at the intersection of Franklin Street and Quay Street (one crosswalk in all peak hours analyzed and at one corner during the Saturday peak hour). No feasible mitigation measures were identified, therefore the significant adverse impacts to these pedestrian elements would remain unmitigated and constitute an unavoidable significant adverse impact.

The detailed traffic analyses determined that three of the 13 intersections analyzed would be significantly impacted during the weekday AM construction peak hour, and four of the 13 intersections analyzed would be significantly impacted during the weekday PM construction peak hour. Standard traffic capacity improvements typically implemented by the NYC DOT, such as signal timing modifications, could fully mitigate impacted traffic movements at the three intersections impacted during the weekday AM construction peak hour and at three of the four intersections impacted during the weekday PM construction peak hour. However, a significant traffic impact during the weekday PM construction peak hour would remain unmitigated at the intersection of McGuinness Boulevard and Greenpoint Avenue. The proposed mitigation measures are subject to review and approval by NYC DOT. If, prior to implementation, NYC DOT determines that any of the identified mitigation measures are infeasible, and no other alternative and equivalent mitigation measures could be advanced, then the impacts would remain unmitigated and would constitute an unavoidable significant adverse impact.

Construction-related activities would generate 567 pedestrian trips during the weekday AM and PM construction peak hours. While the number of construction-related pedestrian trips would be substantially lower than pedestrian trips generated by the Proposed Development (1,262 pedestrian trips during the weekday AM peak hour and 2,278 pedestrian trips during the peak hour), significant impacts that could not be mitigated were identified at were identified at the south crosswalk at the intersection of Franklin Street and Quay Street under weekday operational conditions). Therefore, it is possible that construction activities could result in significant adverse pedestrian impacts, although the potential for significant pedestrian impacts during construction would be no worse than what has been identified for the operational condition.

The construction noise analysis assesses the potential for construction to cause significant adverse noise impacts on nearby sensitive noise receptors. The Project Developer has committed to using grid power instead of the generators during Foundation, Superstructure, and Finishing phase, where grid power is sufficient and available, which would be implemented as a PCRE. Construction noise from mobile sources would not increase by 3 A-weighted decibels (dBA) or more, and there would be no significant adverse noise impacts at the existing and future receptors due to construction mobile sources. However, since construction noise levels would exceed the thresholds for exterior increase in noise as well as the thresholds for acceptable interior noise levels for residential uses, there would be potential for a significant adverse construction noise impact to the future building at 3 West Street located across the street from the Development Site. No other receptors analyzed would experience significant adverse construction noise impacts. Construction activities at the Development Site would be required to adhere to New York City's construction noise regulations, including the requirement to prepare and implement a Construction Noise Mitigation Plan and to construct an 8-foot-tall construction noise barrier, as well as additional measures (i.e., limiting the usage of generators) beyond what is required by the code, which is assumed in the noise modeling analysis. Even with these measures, construction noise would exceed the threshold for a significant adverse construction noise impact at one receptor location, 3 West Street, during certain phases of construction. As such, this significant adverse impact would be unmitigated and therefore unavoidable.

The DEIS considers three alternatives to the Proposed Actions: (1) a No-Action Alternative, (2) an Existing Zoning Alternative, and (3) a No Unmitigated Significant Adverse Impacts Alternative. The No-Action Alternative is the "Future Without the Proposed Project," or "No-Action condition," described above in "Analysis Framework" and analyzed in the EIS. Under the No-Action Alternative, the relocation of the existing

NYCTA Facility and ERU Site would not occur and existing conditions would remain on the Development Site. In the Existing Zoning Alternative, the Applicants would seek MTA Board Approval (a discretionary action subject to SEQRA) to relocate the existing NYCTA Facility on Lot 1, facilitating a new development on the Development Site pursuant to the existing R6 and R6/C2-4 zoning district. The Existing Zoning Alternative could result in significant adverse impacts similar to those of the Proposed Actions; however, it would provide for significantly less housing and no affordable housing. Further, many of the intended public benefits of the Proposed Actions would not be realized with the Existing Zoning Alternative. The No Unmitigated Significant Adverse Impacts Alternative examines a scenario in which the projected density increase and other components of the Proposed Actions are changed specifically to avoid the unmitigated significant adverse impacts associated with the Proposed Actions, which include transportation (traffic and pedestrians) and construction (traffic, pedestrians, and noise). However, to eliminate all identified unmitigated significant adverse impacts, the Proposed Actions would have to be modified to a point where the principal goals and objectives of the Proposed Actions would not be fully realized.

Unavoidable significant adverse impacts are those that would occur if a proposed project or action is implemented regardless of the mitigation employed, or if mitigation is impracticable. As previously noted, the Proposed Actions have the potential to result in significant adverse impacts related to transportation (traffic and pedestrians), and construction (traffic, pedestrians, and noise). Mitigation measures have been proposed to the extent practicable for these significant adverse impacts. However, in some instances, no practicable mitigation has been identified to fully mitigate the significant adverse impact, and there are no reasonable alternatives that would meet the purpose and need of the Proposed Actions, eliminate potential impacts, and not cause other or similar significant adverse impacts. Identified mitigation measures will be codified in an RD that would be executed by the Applicant upon approval of the Proposed Actions. In the absence of the implementation of these mitigation measures, the impacts would be unmitigated and would constitute an unavoidable significant adverse impact.

Effective December 30, 2024, Section 8-0109(2)(k) of the New York State Environmental Conservation Law (ECL) requires that EISs include a statement of the effects of the Proposed Actions on disadvantaged communities, including whether the Proposed Actions may cause or increase a disproportionate pollution burden. The 2021 *CEQR Technical Manual* predates these revisions to the ECL and does not provide guidance regarding the scope of this analysis. On January 29, 2025, the DEC proposed draft revisions to its SEQRA regulations (6 NYCRR Part 617) to implement this new statutory provision. This assessment considers the impacts that have been identified pursuant to the 2021 *CEQR Technical Manual* as well as applicable guidance from DEC in determining whether the Proposed Actions would result in disproportionate impacts on disadvantaged communities. The area affected by the Proposed Actions would affect census tracts comprised of Disadvantaged Communities (DACs) - both higher and lower vulnerability levels - and non-DACs. The Proposed Actions have the potential to result in significant adverse impacts in the following CEQR technical areas: transportation (traffic and pedestrians) and construction (traffic, pedestrians, and noise).

There would not be any disproportionate pollution burden on DACs because of the Proposed Actions related to transportation and construction. Although many of the potential impacts would occur in DACs with "higher burdens and vulnerabilities," the potential impacts would not cause or increase a pollution burden in DACs.

WHEREAS, although there has been improvement in excessive staff absenteeism, extraordinarily high rates of attrition due to staff retirements and other departures continue to seriously affect the Department of Correction's (DOC's) staffing levels and create a serious risk to DOC's ability to carry out the safety and security measures required for the maintenance of sanitary conditions; and access to basic services, including showers, meals, visitation, religious services, commissary, and recreation; and

WHEREAS, this Order is given to prioritize compliance with the *Nunez* Action Plan and to address the effects of DOC's staffing levels, the conditions at DOC facilities, and health operations; and

WHEREAS, additional reasons for requiring the measures continued in this Order are set forth in Emergency Executive Order No. 140 of 2022, Emergency Executive Order No. 579 of 2024, and Emergency Executive Order 623 of 2024; and

WHEREAS, the state of emergency existing within DOC facilities, first declared in Emergency Executive Order No. 241, dated September 15, 2021, and extended by subsequent orders, remains in effect;

NOW, THEREFORE, pursuant to the powers vested in me by the laws of the State of New York and the City of New York, including but not limited to the New York Executive Law, the New York City Charter and the Administrative Code of the City of New York, and the common law authority to protect the public in the event of an emergency:

Section 1. I hereby direct that section 1 of Emergency Executive Order No. 893, dated December 9, 2025, is extended for five (5) days.

§ 2. This Emergency Executive Order shall take effect immediately and shall remain in effect for five (5) days unless it is terminated or modified at an earlier date.

The New York City Mayor's Office of Criminal Justice (MOCJ) seeks to issue a Request for Proposals (RFP) to provide transition services in every borough within NYC (Queens, Manhattan, Brooklyn, Bronx, and Staten Island). Last year approximately 14,000 people left New York City's jails and returned to their communities. Although many are successful in making the transition home, each year approximately 37% return to the city's custody within one year of release. Despite this, New York City has one of the lowest incarceration rates of all large cities in the United States, per capita, with an average daily jail population of approximately 7,000 as of October 2025. Research and practice show that there are still some improvements that can be implemented for individuals' post-release outcomes in the community, particularly within the first 90 days of release.

The MOCJ-funded "Community Justice Re-entry Network" (CJRN), comprised of 10 non-profit agencies across the 5 boroughs, has provided paid transitional employment, job training services, and a variety of supportive social services to thousands of justice-involved New Yorkers to help them stabilize in the community after involvement with the criminal justice system. From January 2021 to June 2025, the CJRN completed more than 17,000 intakes, had more than 3,000 permanent employment placements, and more than 2,500 placements into short-term transitional employment. CJRN also held training sessions for more than 14,000 individuals across a wide range of categories including but not limited to: cognitive behavioral skills, construction, technology, leadership, and peer work.

In an effort to build on the success of the CJRN and refine service delivery, MOCJ seeks to create a coordinated system of transitional services called the "Community Justice Transition Network" (CJTN) to continue discharge planning services and connect individuals leaving city jail to mentoring, education, employment, therapeutic services, and an array of additional supportive services included but not limited to mental health services, substance use treatment, physical healthcare, transitional case management, vital documents, financial literacy, etc. in the community to promote community stability and reduce the likelihood of further justice system involvement. MOCJ seeks to serve anyone who needs transition services as early as their initial contact with the system. Although transitioning back into community is a continuous experience, MOCJ will place emphasis on serving and engaging individuals who are recently released (within 2 years) from custody.
