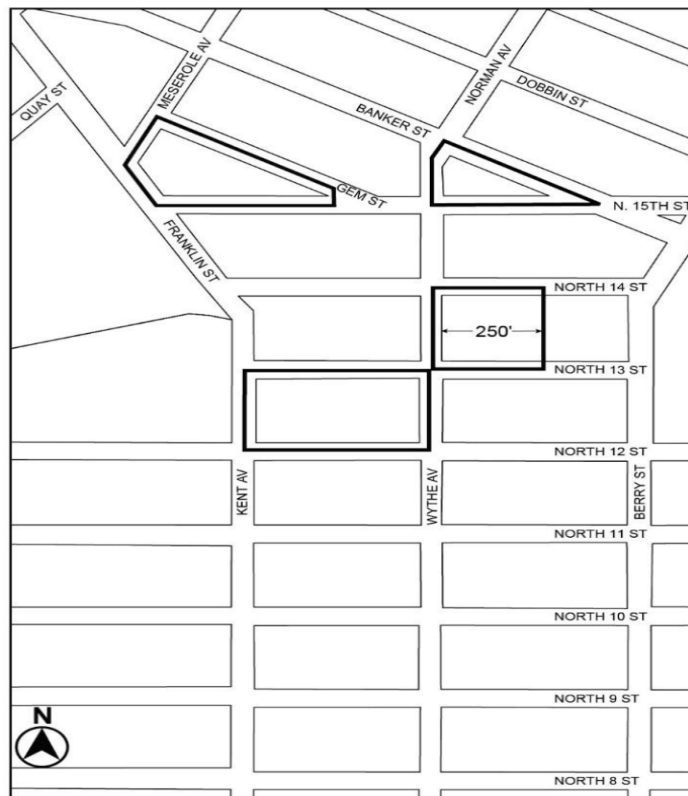

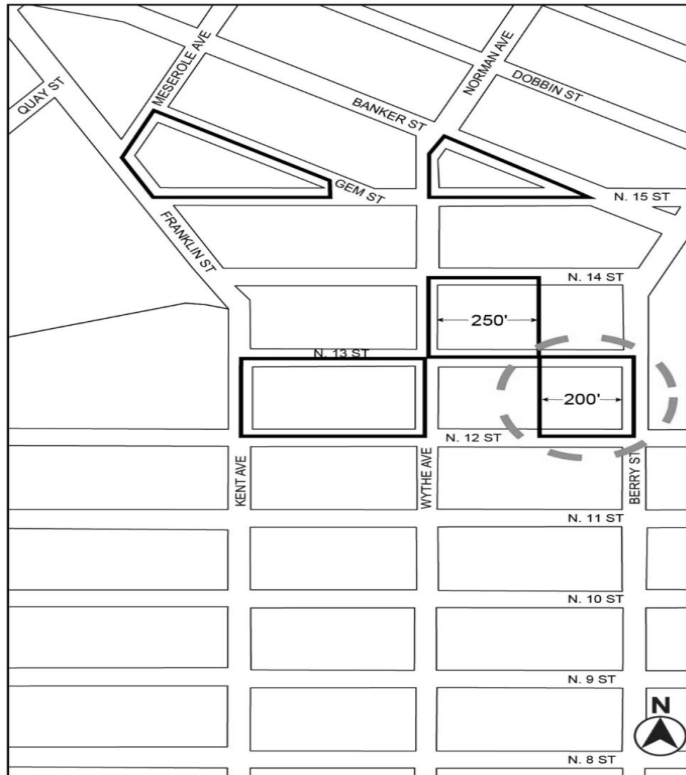
Map 1: Brooklyn

On January 7, 2025, a public hearing is being held by the City Planning Commission (CPC), accessible in-person and remotely, in conjunction with the above ULURP hearing to receive comments related to a Draft Environmental Impact Statement (DEIS) concerning an application by The New York City Department of Environmental Protection (DEP) and the New York City Department of Citywide Administrative Services (DCAS) (the "Applicants"). The New York City Department of Environmental Protection (DEP) is the CEQR Lead Agency for the environmental review. The Applicants are seeking a series of land use actions including site selection of a capital project and acquisition of property as well as the acquisition of permanent surface and subterranean easements at several properties for long-term maintenance and security (the "Proposed Actions") in Brooklyn Community District 1 and Queens Community Districts 2 and 5. Construction and operation of a combined sewer overflow (CSO) tunnel and additional infrastructure to reduce the volume of CSO entering Newtown Creek, under the Newtown Creek CSO Storage Tunnel project constitutes the "Proposed Project". The Proposed Actions would facilitate the Proposed Project which may require property leasing during various stages of construction and includes the CSO tunnel along with diversion chambers, drop shafts, conveyance sewers, new outfalls, and odor control systems. The proposed CSO storage tunnel would be at a depth ranging from 80-130 feet below existing ground surface, and approximately 26 feet in diameter. The tunnel alignment would run from a site in Brooklyn (on the southern side of the Creek) near Whale Creek and the Newtown Creek WRRF, east under the Creek into the Blissville neighborhood of Queens, continuing south and east

along Review Avenue, underneath the Kosciusko Bridge toward the Maspeth section of Queens, then curving south and then west into Brooklyn. In addition to the tunnel, the Proposed Project would include a tunnel dewatering pump station (TDPS), diversion facilities at outfalls BB-026, NCQ-077, NCB-083, and NCB-015 to divert CSOs from the outfalls to the tunnel, and a new gravity diversion sewer to connect outfall BB-026 to the tunnel. Construction of the diversion facility at BB-026 would be facilitated by the acquisition of easements. Acquisition of the TDPS site would not be required since it is a City-owned property (currently being used by DSNY). In total, the Proposed Project would affect up to 99 properties: 9 properties are City-owned and require only site selection approval, and 90 properties are privately owned and require both site selection and acquisition approval. Of the up to 90 properties requiring both site selection and acquisition approval, 4 require fee simple acquisition (for the diversion facilities at NCQ-077, NCB-083, and NCB-015), up to 83 require subterranean easements along the proposed tunnel and gravity diversion sewer alignments (including one property that also requires both acquisition of a permanent surface easement and a temporary construction easement, and one property that also requires acquisition of a temporary construction easement), and 3 properties require both acquisition of permanent surface and temporary construction easements (but no subterranean easement). The fee simple acquisition, property leasing, and establishment of subterranean and surface easements would be facilitated by the proposed acquisition action under ULURP. The Build Year is 2040.

The Proposed Project may require several other actions, including approval by local entities such as the NYC Landmarks Preservation Commission (LPC), New York City Public Design Commission, New York City Department of Transportation (DOT) Office of Construction Mitigation and Coordination (OCMC); state entities such as the New York State Department of State (NYS DOS), New York State Office of General Services (NYS OGS), New York State Department of Environmental Conservation (NYS DEC), New York State Historic Preservation Office (SHPO), Metropolitan Transit Authority (MTA); and federal entities such as the U.S. Environmental Protection Agency (EPA), Coastal Zone Management Act, U.S. Army Corps of Engineers (USACE), United States Fish and Wildlife Service (USFWS) and National Marine Fisheries Service (NMFS), and the Advisory Council on Historic Preservation.

Written comments on the DEIS are requested and will be received and considered by the Lead Agency through 5:00 P.M. on Tuesday, January 20, 2026.

DCWP is proposing to amend section 2-433 of subchapter HH of chapter 2 of title 6 of the Rules of the City of New York (“Rules”) by removing the requirement that car wash licensees submit certain documents when applying for a renewal license.

The Rules currently require licensed car wash businesses to maintain electronic records, documents and photographs related to any complaints of damage to vehicles. As currently written, section 2-433(d)(4) requires a car wash licensee to produce these records when submitting a renewal application for their license. This is not necessary, since licensees must maintain records of complaints of damage to vehicles on an ongoing basis, and under sections 2-443(d)(2) and (3) licensees must produce these records to DCWP upon request.

Submission of these documents upon renewal application for a license is inefficient and creates unnecessary paperwork. The proposed amendment to the Rules repeals this requirement, thereby streamlining the renewal process for licensees.

Sections 1043 and 2203(c) and (f) of the New York City Charter and section 20-104(b)(4) of the New York City Administrative Code authorize DCWP to make this proposed amendment to the Rules.

New material is underlined.

“Shall” and “must” denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

Section 1. Subdivision d of section 2-433 of subchapter HH of chapter 2 of title 6 of the Rules of the City of New York is amended to read as follows:

(d) Format, preservation and production of records.

(1) Electronic records must be maintained in a manner designed to ensure their security and preservation, including by creation of back-up copies.

(2) Upon request by the Department, a licensee must produce electronic records to the Department in the format in which the licensee maintains the electronic files.

(3) Upon request by the Department, a licensee must produce all documents and photographs required to be maintained to the Department.

[(4) The licensee shall produce the electronic records, documents and photographs to the Department with its renewal application.]

Statement of Basis and Purpose of Proposed Rule

The New York City Department of Finance ("DOF") is proposing the following rule change pursuant to the powers set forth in New York City Charter §§ 1043(a) and 1504, as well as New York City Administrative Code § 11-203.

DOF is proposing a rule amendment that would provide that the requirements applicable to tax lot merger and apportionments pursuant to chapter 54 of Title 19 of the Rules of the City of New York ("RCNY") do not apply when a portion of a separately assessed parcel has been acquired by the City through a condemnation proceeding. The City, as condemnor, takes title to property via eminent domain. Because of the involuntary nature of condemnation proceedings, former owners of portions of property that the City has condemned may not, or cannot, cooperate in an application for an apportionment under 19 RCNY § 54-02. In these circumstances, a streamlined apportionment process is necessary to properly apportion parcels where such action is already subject to substantial administrative and judicial oversight.

Section one of this rule would amend 19 RCNY § 54-02 to add a new subdivision (b-1), which would provide that in circumstances where the City takes title to a portion of a parcel through condemnation, the City, as an applicant for apportionment of such parcel in accordance with such condemnation, would not be subject to the requirements of subdivision (b) of such section.

Section two of this rule would clarify that this rule applies to properties acquired via eminent domain both prior to and after the effective date of this rule for apportionment submitted after the effective date of this rule.

Section 1. Section 54-02 of title 19 of the Rule of the City of New York is amended by adding a new subdivision (b-1) to read as follows:

(b-1) Notwithstanding any other provision of this chapter, the provisions of subdivision (b) of this section shall not apply to the city of New York where the city of New York submits an application for the apportionment of a parcel, provided that (i) the city of New York acquired a portion of such parcel through a condemnation proceeding conducted in accordance with the Eminent Domain Procedure Law; and (ii) such application only seeks to apportion from such parcel the portion acquired by the City of New York through such condemnation proceeding.

§ 2. Section one of this rule applies to the City of New York in regard to applications submitted to the Department of Finance pursuant to chapter 54 of title 19 of the Rules of the City of New York after the date that this rule takes effect.

NOTICE OF ADOPTION relating to amendments of the New York City Department of Transportation's (DOT) "Highway Rules" contained in Chapter 2 of Title 34 of the Rules of the City of New York to update various provisions of the Adopt-A-Highway (AAH) Program rules.

NOTICE IS HEREBY GIVEN PURSUANT TO THE AUTHORITY VESTED in the Commissioner of the New York City Department of Transportation (DOT) by Section 2903(a) of the New York City Charter and in accordance with the requirements of Section 1043 of the New York City Charter that DOT hereby amends Chapter 2 of Title 34 of the Rules of the City of New York.

This rule was first published in the City Record on October 16, 2025, and a public hearing was held on November 17, 2025. Two people—who currently participate in the AAH program as volunteers—provided testimony at the public hearing and no written comments were received in response to the proposed rule. The testimony received was posed as questions to DOT about the impact the proposed rule would have on specific adopted segments that the volunteers currently maintain. No comments or concerns were provided related to the substance of the proposed rule. For those reasons, no changes were made to the now-adopted rule.

Statement of Basis and Purpose of the Adopted Rule

The purpose of the adopted rule is to update and clarify various sections of DOT's Adopt-A-Highway (AAH) program which have not been updated since the rule was first adopted in 2013. Specifically, the adopted amendments are as follows:

- Section 2-21(b)(5) is amended to update the definition of

"maintenance services."

- Section 2-21(c)(5) is amended to include a prohibition of sponsors with political affiliations.
- Section 2-21(c)(3) is amended to include grounds for DOT to remove an AAH sponsor.
- Section 2-21(g)(1)(i) is amended to include a requirement that sponsors and maintenance providers use a Department-approved agreement.
- Section 2-21(g)(3)(i) is amended to increase the minimum sponsorship commitment to 2 years and remove 2-21(g)(3)(ii) because it is duplicative of proposed amendment to Section 2-21(g)(3)(i).
- Section 2-21(g)(4) is amended to update the registration process for maintenance providers.
- Section 2-21(g)(5) is amended to clarify and update the administrative obligations of maintenance providers.
- Section 2-21(g) is amended by adding a new paragraph (17) to include grounds for termination of an AAH sponsor or adopter by DOT.
- Section 2-21(h)(1) is amended to increase the minimum volunteer commitment to 2 years.
- Section 2-21(h)(2)(ii) is amended to clarify AAH volunteer responsibilities.
- Section 2-21(h) is amended by adding two new paragraphs (12) and (13) to include grounds for termination of an AAH volunteer and a prohibition of volunteers with political affiliations.
- Section 2-21(k)(17) is amended by updating technical requirements for AAH signage.

"Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

New material is underlined.

[Deleted material is in brackets.]

Asterisks (***) indicate unamended text.

Section 1. The definition of "maintenance services" set forth in paragraph 5 of subdivision (b) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended to read as follows:

- (5) **Maintenance services** means work performed at the adopted segments that may include, but is not necessarily limited to, litter removal, tree trimming, graffiti removal, mechanical sweeping, mowing, planting flowers or trees, and other landscape maintenance.

§2. Subparagraph (i) of paragraph 1 of subdivision (c) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended to read as follows:

- (i) *Sponsors.* Any individual, business, corporation or organization who desires to participate in the Adopt-a-Highway Program as a sponsor must obtain from the Department a list of maintenance providers with whom the sponsor may enter into a maintenance provider agreement. A government official, candidate for elected office, or group affiliated with a political party or campaign may not be a sponsor.

§3. Subparagraph (ii) of paragraph 2 of subdivision (c) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended to read as follows:

- (ii) The Department [will] may maintain waiting lists for adopted segments in order of the date therequest for an adopted segment is received by the Department. Upon termination or relinquishment of the adoption of a particular segment, if there is a waiting list for such segment, the Department will give the prospective adopter at the top of the applicable waiting list the opportunity to adopt such segment.

§4. Paragraph 3 of subdivision (c) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended to read as follows:

- (3) *Compliance.* Adopters and maintenance providers must comply with any agreement the adopter or maintenance provider enters with the Department related to the Adopt-a-Highway Program, the terms of the permit issued by the Department, the Adopt-a-Highway technical guidelines published by the Department, any other terms and conditions as required by the Department, and all applicable laws, rules, and regulations. The Department may remove an adopter or sponsor from the Adopt-a-Highway Program for any reason, including but not limited to, failure to comply with this section, the NYC Adopt-a-Highway Sponsorship Program Technical

Guidelines, any applicable laws, rules, and regulations, or if the Department determines that participation of the sponsor or adopter is not in the public interest.

§5. Subparagraph (i) of paragraph 1 of subdivision (g) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended to read as follows:

- (i) The sponsor agreement is exclusively between the maintenance provider and the sponsor. The Department is not a party to any agreement between the maintenance provider and the sponsor. Neither the maintenance provider nor the sponsor will be considered an agent of the Department. The cost of services for sponsors participating in the program is to be negotiated solely between the sponsor and the maintenance provider. All billing and collection occur[s] between those two parties. The parties must use a Department-approved sponsor agreement available on the Department's website. The Department has the right to review the sponsor agreement.

§6. Paragraphs 3 and 4 of subdivision (g) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York are amended to read as follows:

- (3) Term of Adoption. [(i)]Sponsors wishing to adopt a segment must commit to a minimum of a [one] two-year agreement with a Department-approved maintenance provider.

[(ii) Adopted areas that need landscaping require sponsor commitment for a minimum of two years.]

- (4) Maintenance provider qualifications. Maintenance providers must be approved by the Department to participate in the Adopt-a-Highway Program. Maintenance providers must have a minimum of five years of maintenance experience similar to that as defined as maintenance services in these rules, administrative experience, and experience with roadway closures. Maintenance Providers must register with PASSport, New York City's end-to-end digital procurement platform, and conform with [the] its requirements [of VENDEX, New York City's automated system check on background, performance, tax, and contact information for businesses that contract with the City].

§7. Subparagraphs (ii), (iv), (v), and (vii) of paragraph 5 of subdivision (g) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York are amended, and a new subparagraph (xvii) is added, to read as follows:

- (i) [Reaching] Entering into a sponsor agreement with a sponsor and informing sponsors of maintenance services completed.

- (iv) [Submitting] Obtaining a maintenance provider work permit [application and performing all administrative work associated with the program including billing and related services with the sponsor].

- (v) Performing all maintenance services in accordance with the maintenance provider agreement, [and] maintenance provider permit, and sponsor agreement.

- (vii) Supplying all labor, equipment and capital resources necessary to perform the maintenance services in accordance with the maintenance provider agreement, [and] maintenance provider permit, and sponsor agreement.

- (xvii) Performing all administrative work associated with the program including billing and related services with the sponsor.

§8. Subdivision (g) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended by adding a new paragraph (17), to read as follows:

(17) Termination. The Department may terminate, revoke, or deny renewal to a sponsor or adopter of the Adopt-A-Highway program for any reason, including, but not limited to, safety concerns, failure to comply with this section, the Adopt-a-Highway technical guidelines, any applicable laws, rules, and regulations, or if the Department determines that participation of the sponsor or adopter is not in the public interest.

§9. Paragraph 1 of subdivision (h) of section 2-21 of chapter 2 of

Title 34 of the Rules of the City of New York is amended to read as follows:

- (1) Term of adoption. Volunteers wishing to adopt a segment must commit to a minimum of a [one] two-year agreement with the Department to perform maintenance services at the adopted segment.

§10. Subparagraph (iii) of paragraph 2 of subdivision (h) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended to read as follows:

- (iii) [Submitting] Obtaining a volunteer permit [application to] from the Department.

§11. Subdivision (h) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended by adding new paragraphs (12) and (13), to read as follows:

- (12) No political affiliation. A government official, candidate for elected office, or any group affiliated with a political party or campaign may not be volunteers.
- (13) Termination. The Department may terminate, revoke, or deny renewal to a volunteer from the Adopt-A-Highway program for any reason, including, but not limited to, safety concerns, failure to comply with this section, the Adopt-a-Highway technical guidelines, any applicable laws, rules, and regulations, or if participation of the volunteer is not in the public interest.

§12. Subdivision (k) of section 2-21 of chapter 2 of Title 34 of the Rules of the City of New York is amended to read as follows:

- (k) Adopt-a-Highway Signs.

- (1) Sponsor signs. [Signs are] The portion of a sign naming the sponsor ("sponsor panel") is produced and maintained by the maintenance provider [or volunteer] and must be delivered to the Department for installation no later than one month after the permit for an adopted segment is approved. All other portions of the sign ("background panel") are produced by the Department.



White area is sponsor panel.

Other portion of the sign is background panel.

- (2) Volunteer signs. Signs naming the volunteer are produced and maintained by the Department.
- (3) Sign installation.
- (i) Ground mounted signs will be installed by the Department as close to the beginning of the adopted segment feasible, taking into consideration safety and other informational signage.
- (ii) Signs requiring bridge, gantry wall, or parapet mounting will be installed by the Department or a contractor approved by the Department, and paid for by the maintenance provider or volunteer.
- (3) (4) All signs posted at the adopted segment must:
- (i) consist of a standard base sign design with removable recognition panel identifying the sponsor's or volunteer's name and/or logo;
- (ii) conform to the Department's specifications for size, shape, materials, and placement;
- (iii) not be used for advertising purposes; and
- (iv) comply with applicable laws, rules, and regulations.

- [(4)] (5) Where litter pick-up, trimming and/or mechanical sweeping are the services provided, the sign will read "[LITTER REMOVAL] For a Cleaner, Greener NYC."
- [(5)] (6) Where other services are provided, the [signs] sign will read "BEAUTIFICATION."
- [(6)] (7) Signs on elevated highway segments must be 4' x 4.5' and hung on lampposts.
- [(7)] (8) Signs on the Henry Hudson Parkway must be larger than 4' x 4.5' to accommodate two recognition panels.
- [(8)] (9) Maintenance providers and volunteers must replace damaged or stolen signs.
- [(9)] (10) When an adopter terminates its agreement with the Adopt-a-Highway program, the adopter must not remove the sign. The Department will remove the recognition panel portion of the sign.

The Ambrose, aka LV87, or Light Vessel 87, was built in 1907 for the United States Lighthouse Establishment by the New York Shipbuilding Company of Camden, New Jersey. From 1907 until 1932 the ship was anchored at the entrance to the newly dredged Ambrose Channel in New York Harbor.

After undergoing a major overhaul in 1933, the ship provided various services to the U.S. Coast Guard at various locations. She was decommissioned in 1966 and donated to the South Street Seaport Museum in 1968. In 1989 the Ambrose was awarded National Historic Landmark status.

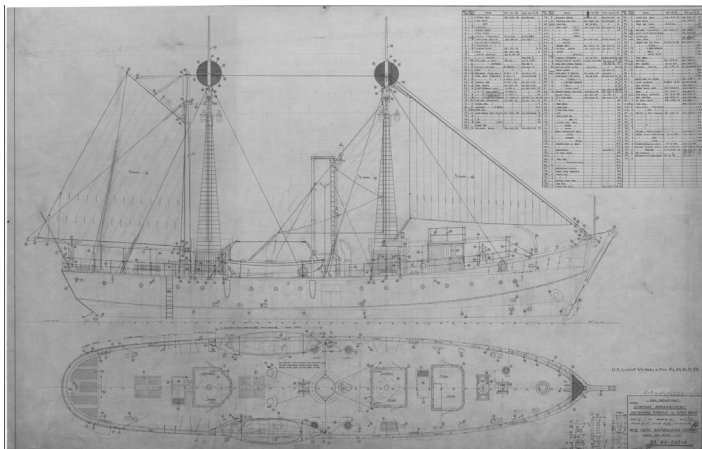


Figure 1 - Lightship Ambrose, 1907 Configuration

EMERGENCY EXECUTIVE ORDER NO. 897

December 19, 2025

WHEREAS, on September 2, 2021, the federal monitor in the *Nunez* use-of-force class action stated steps must be taken immediately to address the conditions in the New York City jails; and

WHEREAS, on June 14, 2022, the federal court in *Nunez* approved the *Nunez* Action Plan, which "represents a way to move forward with concrete measures now to address the ongoing crisis at Rikers Island"; and

WHEREAS, while there has been improvement in excessive staff absenteeism, the Department of Correction's (DOC's) staffing levels continue to contribute to a rise in unrest and disorder and create a serious risk to the necessary maintenance and delivery of sanitary conditions; access to basic services including showers, meals, visitation, religious services, commissary, and recreation; and prompt processing at intake; and

WHEREAS, this Order is given to prioritize compliance with the *Nunez* Action Plan and to address the effects of DOC's staffing levels, the conditions at DOC facilities, and health operations; and

WHEREAS, additional reasons for requiring the measures continued in this Order are set forth in Emergency Executive Order No. 140; Emergency Executive Order No. 579 of 2024, and Emergency Executive Order 623 of 2024; and

WHEREAS, the state of emergency existing within DOC facilities, first declared in Emergency Executive Order No. 241, dated September 15, 2021, and extended by subsequent orders, remains in effect;

NOW, THEREFORE, pursuant to the powers vested in me by the laws of the State of New York and the City of New York, including but not limited to the New York Executive Law, the New York City Charter and the Administrative Code of the City of New York, and the common law authority to protect the public in the event of an emergency:

Section 1. I hereby direct that the State of Emergency declared in Emergency Executive Order No. 241, dated September 15, 2021, and extended by subsequent orders, is extended for thirty (30) days.

§ 2. I hereby direct that section 1 of Emergency Executive Order No. 895, dated December 14, 2025, is extended for five (5) days.

§ 3. This Emergency Executive Order shall take effect immediately. The State of Emergency shall remain in effect for a period not to exceed thirty (30) days or until rescinded, whichever occurs first. Additional declarations to extend the State of Emergency for additional periods not to exceed thirty (30) days shall be issued if needed.

EMERGENCY EXECUTIVE ORDER NO. 898

December 19, 2025

WHEREAS, since October 2022, over two hundred thousand asylum seekers have arrived in New York City from the Southern border without having any immediate plans for shelter; and

WHEREAS, the City continues to face an unprecedented humanitarian crisis that requires it to take extraordinary measures

to meet the needs of the asylum seekers while continuing to serve the tens of thousands of people who currently use the Department of Homeless Services Shelter System; and

WHEREAS, the state of emergency based on the arrival of hundreds of thousands of individuals and families seeking asylum, first declared in Emergency Executive Order No. 224, dated October 7, 2022,¹ and extended by subsequent orders, remains in effect; and

WHEREAS, additional measures continued in this order were originally set forth in Emergency Executive Order No. 230 of 2022, Emergency Executive Order No. 241 of 2022, Emergency Executive Order No. 302 of 2023, Emergency Executive Order No. 350 of 2023, Emergency Executive Order No. 386 of 2023, Emergency Executive Order No. 402 of 2023, and Emergency Executive Order No. 406 of 2023; and

WHEREAS, section 3 of Emergency Executive Order No. 886 of 2025 listed provisions of laws and rules that had been suspended by such prior orders to allow for the continued operation of facilities needed to address the asylum emergency, and such list is attached as an appendix to this order; and

WHEREAS, section 4 of Emergency Executive Order No. 886 of 2025 provided for such suspensions to remain in effect for 5 days, and such suspensions have been extended by subsequent emergency orders, and continue to be necessary;

NOW, THEREFORE, pursuant to the powers vested in me by the laws of the State of New York and the City of New York, including but not limited to the New York Executive Law, the New York City Charter, the New York City Administrative Code, and the common law authority to protect the public in the event of an emergency:

Section 1. I hereby direct that the State of Emergency declared in Emergency Executive Order No. 224, dated October 7, 2022, and extended by subsequent orders, is extended for thirty (30) days.

§2. Humanitarian Emergency Response and Relief Centers.

a. The New York City Mayor's Office of Housing Recovery Operations (HRO) shall continue to coordinate with the New York City Health and Hospitals Corporation (H+H) and other agencies as appropriate, to operate temporary humanitarian relief centers to be known as "Humanitarian Emergency Response and Relief Centers" ("HERRCs") to provide assistance to asylum seekers, by offering respite, food, medical care, case work services, and assistance in accessing a range of settlement options, including through connections to family and friends inside and outside of New York City, in addition to, if needed, direct referrals to alternative emergency supports.

b. The Deputy Mayor of Health and Human Services is authorized to oversee compliance with all memoranda of understanding with H+H concerning the establishment and operation of the HERRCs, which, among other things, provide for the establishment of policies and procedures for the operation of the HERRCs, provide for the confidentiality of information collected from the persons served in the HERRCs, and provide restrictions on disclosure of information about an individual's immigration status consistent with the policies set forth in Executive Order 34, dated May 13, 2003, and Executive Order 41, dated September 17, 2003.

§ 3. I hereby order that section 1 of Emergency Executive Order No. 896, dated December 14, 2025, is extended for five (5) days.

§ 4. This Emergency Executive Order shall take effect immediately. The State of Emergency shall remain in effect for a period not to exceed thirty (30) days or until rescinded, whichever occurs first. Additional declarations to extend the State of Emergency for additional periods not to exceed thirty (30) days shall be issued if needed.

APPENDIX

LAWS AND RULES SUSPENDED, AS DESCRIBED IN SECTION 3 OF EMERGENCY EXECUTIVE ORDER NO. 886 OF 2025

a. The following laws and rules, first suspended on October 7, 2022 by Emergency Executive Order No. 224, related to the Uniform Land Use Review Procedure, and other procedures applicable to the City planning and land use review processes, to the extent they would apply to the continued operation of the HERRCs, impose limitations on the amount of time permitted for the holding of public hearings, the certification of applications, the submission of recommendations, any

required or necessary voting, the taking of final actions, and the issuance of determinations, remain suspended, and any such time limitations are tolled for the duration of the State of Emergency: sections 195, 197-d, and 203 and subdivisions (b) through (h) of section 197-c of the Charter, and sections 1-05.5 and 1-07.5 of Title 2 and sections 2-02 through 2-07 of Title 62 of the Rules of the City of New York.

b. Section 14-140 of the Administrative Code and section 12-10 of Title 38 of the Rules of the City of New York, first suspended on October 7, 2022 by Emergency Executive Order No. 224, remain suspended, to the extent they impact the disposition of personal property at the HERRCs.

c. The following laws and rules, first suspended on October 12, 2022 by Emergency Executive Order No. 224, remain suspended:

- i. Sections 28-111.1.1 and 28-111.1.2 of the Administrative Code, but only to the extent such provisions limit temporary structures or uses to no more than 90 days;
- ii. Sections 28-118.3.1 and 28-118.3.2 of the Administrative Code, Chapter 2 of Article 2, Chapter 2 of Article 3, Chapter 2 of Article 4 and any other applicable district use regulations, including in Special Purpose Districts, of the Zoning Resolution of the City of New York and any other provisions of such code, resolution or rules, to the extent that they would prevent the alteration and/or use of buildings as HERRCs that provide assistance for arriving asylum seekers, provided that such structures or buildings, regardless of length of stay, shall be occupied in a manner that will not endanger public safety, health, or welfare as certified by a registered design professional.

d. Section 21-312 of the Administrative Code, first suspended on October 22, 2022 by Emergency Executive Order No. 241, remains suspended to the extent it limits the number of persons who may be served in a Department of Homeless Services shelter for adults.

e. As first authorized on January 5, 2023 by Executive Order No. 302, the Fire Department ("FDNY") continues to be authorized to waive any provision of 3 RCNY § 901-04 relating to central station monitoring of fire alarm systems, preparation and filing of a fire safety and evacuation plan, decorations, portable fire extinguishers, and commercial cooking systems, where FDNY determines such provision would prevent or delay the alteration or use of a building as a HERRC. Where FDNY waives such a provision, such provision shall be deemed suspended with respect to the alteration or use of such building as a HERRC. FDNY shall require that adequate mitigating fire safety measures to ensure public safety, health and welfare be implemented at any such building. Any waivers and mitigating measures pursuant to this order shall be adopted by written FDNY guidance or documented in a written determination issued by FDNY. Such documentation shall be maintained at the premises of the HERRC and at the FDNY.

f. As first ordered on March 6, 2023 by Emergency Executive Order No. 350, where the provisions of the 1968 Building Code apply to the alteration of a prior code building in accordance with section 28-101.4.3 of the Administrative Code, section 27-359 and the corresponding capacity requirements in table 6-1 of article 2 of subchapter 6 of chapter 1 of title 27 of the Administrative Code remain suspended to the extent that they would prevent the alteration and/or use of buildings as HERRCs that will provide assistance for arriving asylum seekers, provided that for such buildings:

- i. Section 1005 of the New York City Building Code shall apply to such alteration;
- ii. The relevant space shall comply with section 901-04 of title 3 of the Rules of the City of New York, including with protection throughout such space by a functional sprinkler system designed and installed in accordance with the applicable provisions of such Building Code or prior code, as such section may otherwise be modified by the Fire Department pursuant to Emergency Executive Order No. 302;
- iii. Every occupied floor shall be staffed with fire guards for fire watch coverage; and
- iv. Such structures or buildings, regardless of length of stay, shall be occupied in a manner that will not endanger public safety, health, or welfare as certified by a registered design professional.

g. Sections 21-309 and 21-312 of the Administrative Code, first suspended on April 20, 2023 by Emergency Executive Order No. 386, to the extent they would apply to the continued operation of facilities, including homeless shelters, created and/or expanded in response to the asylum emergency, impose limitations on the amount of time permitted for the holding of public hearings, the certification of applications, the submission of recommendations, any required or necessary voting, the taking of final actions, and the issuance of determinations, remain suspended, and any such time limitations are tolled for the duration of the State of Emergency.

h. The following laws, first suspended on May 10, 2023 by Emergency Executive Order No. 402, remain suspended:

- i. Section 21-124 of the Administrative Code;
- ii. Section 21-313 of the Administrative Code, to the extent it sets a deadline for the City's temporary shelter placements; and
- iii. Section 26-521 of the Administrative Code, to the extent such provision gives rights to individuals in need of shelter or housing because of the circumstances that led to the state of emergency and who have been occupants of dwelling units for 30 or more days, or creates a landlord-tenant relationship between any individual assisting with the response to the state of emergency or any individual in need of shelter or housing because of the circumstances that led to the state of emergency, and any individual or entity, including but not limited to any hotel owner, hospital, not-for-profit housing provider or any other person or entity who provides temporary housing for a period of thirty days or more solely for purposes of assisting in the response to the state of emergency.

i. Subdivision (a) of section 824 of the Charter, first suspended on May 15, 2023 by Emergency Executive Order No. 406, to the extent it applies to the continued operation of facilities, including homeless shelters, created and/or expanded for use in response to the asylum emergency, require the holding of public hearings, the certification of applications, the submission of recommendations, any required or necessary voting, the taking of final actions, and the issuance of determinations, remains suspended.
