

# PROVISIONAL REDUCTION PLAN TWO-YEAR EXTENSION TIMELINE FOR COMPLETING PLAN ACTIONS

## Administration of Exams for 37 Titles

DCAS proposed exams for 37 titles over the next two years. The timeline lays out the expected number of titles to be examined and the number of provisionals addressed by these exams (as of 8/31/2014) during each reporting period.

# **Analysis of Titles with Few Incumbents**

In the plan DCAS identified 389 civil service titles with 20 or fewer incumbents which will be analyzed for the appropriateness of either jurisdictional or positional classification actions. This component of the Plan has the potential to address 1,622 provisionals but the actions taken for each title cannot be determined until after the analysis is complete, making it impossible to forecast the actual provisional reduction effect.

Titles will be analyzed at a rate of approximately 15 to 20 titles per month. For each of the six progress reports DCAS will have completed analysis and made recommendations on approximately 60 – 70 titles. Recommendation will be for: Classify title in the Competitive Class, Classify title in the Non-Competitive Class, or Broadband/Consolidate. As part of its progress reporting DCAS will provide a list of titles analyzed during the reporting period and our recommended action, if any.
