### ***Improving Fleet Efficiency Through Electrification***


The core values of DCAS Fleet Management are efficiency, sustainability, safety, and preparedness. These commitments are not pursued in isolation but reinforce and support one another.

By local law, DCAS must report on the fuel economy of new light-duty city vehicles, equivalent to the Federal Corporate Fuel Economy (CAFE) standards. [Local Law 38](#) requires reporting on EPA equivalent sticker miles per gallon (MPG). Additionally, Local Law 75 requires reporting on the actual MPG when vehicles operate on roads, such as using air conditioning, heating, radios, while stuck in traffic, and other real-world impacts on vehicle emissions.


DCAS has completed the latest [Local Law 75](#) report, and, by both measures, fuel efficiency is increasing dramatically through the introduction of hybrid, plug-in hybrid, and electric vehicle (EV) solutions.

Some findings of the report:



- DCAS has achieved an EPA fuel economy of over 100 MPG for six of the last seven years. For comparison, the previous [report](#) of nationwide MPG was 27.1 MPG.



- The light-duty fleet's actual, use-based fuel economy also achieved a new record, demonstrating that these vehicles perform as well, if not better in reality than as advertised.



- In the past year, DCAS fleet doubled the miles driven with electric light-duty units, contributing to fuel economy improvements. Last year, 8.5 million miles were driven with electric units covered by this reporting, compared to 4.3 million in FY23. The city's electric fleet continues to grow, with over 5,400 EV fleet units and 2,200 EV ports—the most extensive programs in New York State.



- Diesel medium-duty units are 33% more fuel efficient than gasoline units. While electric is our preferred option through [Local Law 140](#), DCAS will implement diesel models where electric options are not yet viable—for example, snow plowing. Diesel models are more fuel efficient than gasoline and will use [renewable](#) diesel, a more sustainable, non-fossil fuel.
- Hybrid and plug-in hybrid light-duty vehicles achieve significantly better actual fuel economy than gasoline units.

DCAS has also reported that [maintenance](#) costs for EVs are dramatically lower than those for gas or hybrid vehicles. Electric units achieve both fuel and maintenance savings. These units also provide greater resiliency—for example, on hot summer days, they are not at risk of overheating like gas cars.

Through [Executive Order 53](#), DCAS is advancing fuel efficiency, electrification, and improved safety. These combined efforts will reduce costs and enhance health and safety for our drivers and the general public. Among various initiatives, the intelligent speed assistance (ISA) safety program and our driver alerts and automatic braking initiatives were led through EVs.

Efficiency and sustainability reinforce each other daily for the city fleet, helping us perform critical emergency and public health missions 24/7.
