Car-Free Earth Day, April 26, 2025, And Other Sustainability Events

On April 3, 2025, Department of Transportation (DOT) Commissioner Ydanis Rodriguez joined public and non-profit officials, as well as members of the general public, at Times Square to [announce](#) that Saturday, April 26, would be [Car-Free Earth Day](#).

From 10 a.m. to 4 p.m., streets in 54 locations citywide will be closed to cars, opening space for walking, bicycling, public art, community programming, and sustainability education. DCAS has partnered with DOT on this event since its first launch in 2016 by then-Council member and Transportation Chair Rodriguez. DCAS will be out at Times Square and other locations to promote sustainable modes of transport, including zero emission and safer vehicles. DCAS will be passing out updated brochures on [safe](#) and [clean](#) fleet design. Citi Bike will [offer](#) free bike rides for the whole day as part of the event.



On April 26, we will celebrate walking, biking, public transportation, and expanding free and open spaces. Everyone is encouraged to get outside, enjoy car-free streets, and participate in the activities.

Cars and trucks remain a significant part of our world, however, and DCAS is committed to making them cleaner and safer. The fleet industry is international in scope. Changes in vehicle and truck design, such as electrification, intelligent speed assistance, high vision and side guards for trucks, automatic braking, and driver alerts, all require advocacy throughout the industry.


DCAS will be partnering far and wide to achieve these goals.

The [**36th annual NYC Fleet Show**](#), hosted by DCAS and NYC Parks, will be on May 15, from 9 a.m. to 2 p.m., and is free and open to all. The show is at the Unisphere in Flushing Meadows Corona Park, Queens, and will feature over 200 vendors from throughout North America.

Prior to that, the City of Philadelphia will host a fleet [**showcase**](#) on May 13, and the Port Authority will host a fleet event on [**May 14**](#). The following week, the NY State Office of General Services will host an electrification [**forum**](#) on May 21. DCAS will be present to promote a clean and safe fleet at all of these events.
