Federal CMAQ Funds Support Fleet Electrification

In a [fleet newsletter from Sept. 2021](#), we discussed the support received from the New York State Department of Environmental Conservation and Con Edison towards our fleet electrification program. The largest grant program by far aiding our fleet sustainability efforts has been the Congestion Mitigation and Air Quality Improvement Program (CMAQ). This week, CMAQ funding has helped the City complete its first order of seven all-electric garbage trucks for the City of New York Department of Sanitation (DSNY).



CMAQ is administered by the Federal Highway Administration at the U.S. Department of Transportation (DOT). In NYC, the Alternative Fuels Unit at NYC DOT administers the program for fleet, working with New York state DOT, DCAS, and our major fleet agencies. Director of Alt. Fuel Programs Susan McSherry and Director of EV Policy Mark Simon have led the CMAQ initiative at NYC DOT since coming over from the NYC Department of Environmental Protection (DEP) in 1997, directing more than \$90 million in federal funds to support the City's Clean Fleet initiative and other clean transport initiatives. Among other provisions, CMAQ only supports technologies that are made in America and require matching support from the recipient agency.

CMAQ has been the largest and longest supporter of our fleet electrification and sustainability efforts, with CMAQ fleet grants going back to early natural gas efforts in 1994. DCAS, the NYC Parks Department, the NYC Fire Department, DSNY, DOT, DEP, and other city agencies have all benefitted from CMAQ support.

Among many earlier projects, CMAQ supported the retrofitting of over 1,000 City trucks with diesel particulate filters to reduce harmful air quality emissions. These retrofits were required by Local Law 39 of 2005 and 77 of 2003. CMAQ supplied support to our earliest efforts to introduce all-electric light-duty vehicles including Honda EV Plus vehicles for NYPD in Central

Park, Nissan Leafs for citywide use through DCAS, and installation of our early ChargePoint charging network.



More recently, CMAQ funding has been critical to the rollout of hybrid plug-in alternative power units on FDNY ambulances. CMAQ provided \$4 million to support the electrification of our City ambulances. Currently, 479 ambulances operate with the hybrid plug-in technology with an additional 136 on order. This technology has reduced fuel use and maintenance costs and lessened harmful emissions from idling. CMAQ has helped offset the entire cost of this project.

This week, CMAQ funds helped DSNY and DCAS complete the first order of seven all-electric garbage trucks for DSNY. CMAQ supplied \$1.078 million to complete this project following the successful demonstration of an electric truck conducted in partnership between Mack Trucks and DSNY. These seven will be the first City-owned all-electric garbage trucks; CMAQ is also supporting DCAS's purchase of light-duty all-electric vehicles for agencies citywide.

As per NYC DOT Director Susan McSherry, “this is exactly what we should be doing with these federal funds. Keep helping to advance technology in order to achieve our climate goals, and work toward parity with conventional fuels.”

DCAS thanks federal, state, and NYC DOT for this longstanding, essential, and continuing partnership as we strive toward a zero-emissions and more efficient fleet.


