## The Falcons Watching Over the Fleet

Fleet is doing everything it can to watch over the natural environment. Nature, as represented by a family of peregrine falcons, is also keeping a close watch on us.

DCAS Fleet offices are located on the 21st and 23rd floors at the David N. Dinkins Municipal Building at 1 Centre Street, in Manhattan. Peregrine Falcon pairs, which typically mate for life, have been spotted around 1 Centre Street for the better part of a decade.

Fleet's 21st floor office was previously visited by a falcon chick in 2018. More recently, falcon eggs were laid directly outside the fleet windows on the 21st floor and have now hatched.

Falcons do not build nests. The eggs were out in the open, at risk of rolling off the building ledge if the mother bird was frightened away.

To keep this from happening, fleet staff, with guidance from the NYC Department of Environmental Protection (DEP) put up posters in front of the windows to give the birds their privacy, and also hung signs nearby letting others know to not disturb the mother as she sat on her clutch. After the eggs hatched, DEP Research Scientist Christopher Nadareski, who is known colloquially as the Falcon Whisperer, visited our office to tag the chicks and to do a general checkup on their health. He was happy to report that all is well, and the chicks are expected to live well into adulthood.

Just as DDT threatened wildlife in the 20th Century, fossil fuel usage threatens wildlife in the 21st. Scientists forecast that up to a third of all animal species could become extinct by the end of this century due to global climate change caused by greenhouse gas emissions. The banning of DDT is a reminder that we can make changes and turn the tide on environmental damage, as we must do with fossil fuels.

These falcons deserve no less.

Peregrine Falcons very nearly went extinct decades ago. The use of pesticides such as DDT (dichloro-diphenyl-trichloroethane) harmed wildlife at all levels of the ecosystem. For falcons, DDT caused their eggshells to thin and easily break before the hatchlings had developed. As a result, the falcons were placed on the federal endangered species list in 1973, one year after DDT was banned in the United States.

With DDT outlawed, peregrine falcons made a slow but steady comeback and were removed from the federal endangered list in 1999. The falcons returned to their wild habitats and also moved into urban environments with incredible success. Falcons can fly at speeds of over 200 MPH, which assists them in the search for food. The city's buildings also provided ideal egg-laying sites, which functionally aren't much different from the cliffsides and mountains which falcons use in non-urban settings.
