Spotlight: Gary Prasad, Fleet Field Services Unit

DCAS Fleet launches many initiatives in safety and sustainability. These programs are devised in our building, but they get implemented in the field, working with over 50 agencies and offices. This week's spotlight is on Principal Administrative Associate Gary Prasad, who plays a critical field role in improving the City fleet.

A Queens native, Gary graduated from City College of the City University of New York, with a major in economics and a minor in business administration. He earned a master's degree from the CUNY School of Professional Studies in 2017. Gary started with Hertz in 2012 as a fleet manager before joining DCAS in August 2014. Gary's mother is also a civil servant, working at the Department of Finance.

DCAS currently live tracks over 23,000 fleet units through the Fleet Office of Real-Time Tracking (FORT).

This is the largest public fleet telematics project in the United States, and installing and maintaining the tracking units was an enormous challenge. Gary has spent much of the last two years coordinating and installing tracking units that work with the FORT at 50 different City agencies and 40 separate school bus companies. Gary has personally installed over 1,000 units. He also follows up on disconnect and maintenance issues for the system.

In 2014, DCAS launched a truck side-guards safety initiative. This effort is now subject to two different local laws and the largest truck side-guard program in North America, with 4,300 side-guard installations completed so far. In addition to Gary's work with the FORT, Gary also works with agencies and vendors that DCAS and Volpe have qualified to install side-guards.

He coordinates the retrofits, works with our mechanic inspectors to ensure quality installations, and does the citywide side-guard tracking. Gary will soon play a new and equally critical role as we expand this initiative from City fleet trucks to trucks working under private City contractors.

Gary also coordinated our fleet share program. In 2021, our previous fleet share vendor announced they were discontinuing the service due to business changes. DCAS was given one year to find, vet, and contract a new service in this unique area. After the DCAS Systems team found a new vendor for this service, Gary led a time-sensitive installation and training process for nearly 500 units shared across and within agencies.

DCAS Fleet has recently created a field services unit to focus on these critical field projects. Implementing Mayor Adam's fleet reduction initiative and resolving pending salvage issues will be a focus of the unit in the next six months for Gary and the field services team.

Gary has received multiple honors and awards during his time at DCAS. In 2017, he represented DCAS at an Insurance Institute for Highway Safety (IIHS) roundtable discussion on side-guards, and in 2019, he was invited to the Mayor's State of the City address due to his exemplary customer service and his work on sustainability. In January, Gary also received a COVID-19 Hero award for his work in the field and in the office throughout the pandemic. Gary follows a simple and powerful idea, "dedication makes dreams come true."
