**DCAS, Parks, and Together for Safer Roads Announce Truck of Future Initiative at United Nations**

The greatest safety risk faced by the City fleet is visual impairment with large emergency and public works trucks. In a conventionally designed truck, a driver may not be able to see the road for over 20 to 25 feet.

DCAS is taking various steps to address visual impairment, including investing in high vision trucks, where available, and installing surround cameras and telematics. U.S. DOT Volpe has conducted computer simulations that show high vision trucks greatly reduce risk to pedestrians, bicyclists, and children.

That said, we need more real-world understanding of what interventions are most successful in improving truck safety. In partnership with the Department of Parks and Recreation and DCAS, [Together for Safer Roads \(TSR\)](#) will analyze cab driver alerts, telematics, and surround truck cameras in action to determine how and under what circumstances these technologies are most effective. The assessment will use artificial intelligence technology to develop a *near-misses* indicator; a type of reporting that we are not capable of today. We would much rather report and reduce *near-misses* than wait for actual crashes and injuries to happen.

At the UN meetings on road safety on June 30 and July 1, Parks, DCAS, and TSR displayed a Parks Department garbage truck which has been outfitted to be part of the initiative. In addition to NYC government, [TSR is working with Anheuser Busch InBev, PepsiCo, Republic Services, Humanising Autonomy, Streamax, and Vision Track](#) on the Truck of

the Future initiative. New York City along with Guadalajara, Mexico are the two cities in which this pilot technology integration will be tested.

"New York City's speed and nimbleness on the Truck of the Future pilot program is a demonstration of the City's commitment to Vision Zero," said Executive Director Noah Budnick of Together for Safer Roads. "The scale of New York's fleets creates opportunities to innovate and understand how to prevent traffic casualties from occurring. This is critically important when it comes to the largest vehicles on the road and the protection of the most vulnerable road users."

We look forward to sharing more about the results of the Truck of the Future program during the 2022 Vision Zero Fleet Forum on October 25.
