DCAS, Public Schools, and Agency Fleets Celebrate this Summer's Automotive Interns

On August 16, DCAS Commissioner Louis Molina joined representatives from DCAS Fleet Management, NYC Public Schools, NYPD, FDNY, DSNY, Parks, and

DOT to celebrate this year's class of 43 high school automotive interns. The annual luncheon and recognition ceremony took place at NYPD's Shop 4 in Queens.

Each year, DCAS, NYC Public Schools Career and Technical Education (CTE), and the major fleet agencies partner to offer hands-on and paid summer internships for students at automotive high schools, and the summer program has been our mainstay. In 2024, we also hosted our first spring internship program.

The automotive interns perform hands-on repair work on police cars, sanitation trucks, and fire equipment. They learn from City mechanics and supervisors about garage operations and workplace safety, preventive maintenance, and alternative fuel systems. A DCAS installed electric fast charger is at the entrance to Shop 4, making clear the zero emission change that has begun in our fleet and garage services.



On July 24, DCAS hosted a full day safety training for nearly half the automotive interns. As we train the mechanics and technicians of the future, we want safety and sustainability to be core values they bring with them throughout their careers.

DCAS expects many of these interns to join NYC City government in the fleet program. Since 2015, DCAS has supported 470 automotive interns, many of whom now work at City agencies. In June 2024, DCAS issued the latest civil service test for auto service worker, the entry-level automotive repair title. An automotive high school diploma satisfies the two year experience requirement and enables a direct pathway into City employment. The next auto service worker exam will be in January 2025.

DCAS support for automotive education goes beyond internships. DCAS donates over 20 vehicles and additional engines to the schools, including electric and hybrid vehicles for driver's education and automotive repair training. DCAS and the MTA also co-host the Public School Automotive Commission, which aims to support automotive high schools and link the schools to public and private sector support.

"DCAS plays a critical role in the success of student pathways across the city. Through your partnership this summer, you've engaged over 40 students, providing them with invaluable real-world experiences and insights that help shape the future workforce of New York City. NYC Public Schools is proud of our continuing cross-agency partnerships and grateful for the impact of your efforts, empowering students and creating lasting opportunities that will benefit both their careers and our community," said a representative from the NYCPS Office of Student Pathways.

According to Fleet Safety Supervisor, Nate Koszer, "I have been a supervisor for our summer interns for the past four years, and they have never once failed to impress. Jonsly and Fernando did incredible field work last year doing safety retrofits on trucks. This year, Tyler and Lucas assisted in the review of collision reports, and their hard work was directly responsible for our data for the MMR being submitted on time. Over and over, our interns have demonstrated a unique brilliance and a driven work ethic. It makes me more confident in our future, knowing that the fleet world will be in their very capable hands."



Back at the Intern BBQ, intern Jonsly Sanchez spoke at the event, representing all the students. He mentioned that this was one of his first work experiences, and that learning to work with, and getting to know others, was as important as learning specific automotive repair skills. All interns received certificates and models of our new NYPD electric police cars in recognition. The NYPD also grilled up a great lunch and provided a tour of the garage facility.
