

## **DCAS Recognizes Fleet's Safest Drivers at 9th Annual Safety Forum**

Last week, DCAS recognized the fleet's three safest drivers at the 9th Annual Fleet Safety Forum held at Queens Theater. The winners were Felix Zeygeril, DOT; Miguel Guy, Buildings; and Peter Pollara, FDNY.

At the DCAS Fleet Office of Real-Time Tracking (FORT), 18,994 city fleet vehicles are tracked 24 hours a day. FORT also tracks the city's school buses. There are 53 agencies and offices in the FORT which captures over 92 million miles annually. Many, but not all, agencies use driver FOBs to record not just the vehicles but the driver's name and information for each trip. From this universe of

22,542 fleet operators using FOBS, DCAS began the analysis to determine the fleet's safest drivers.

Often, the FORT is busy looking for vehicle issues and concerns: misuse or under-use, a vehicle not where it's supposed to be, crash investigation, or even addressing auto theft. We regularly monitor speeding, seatbelt violations, and the ABCs: hard acceleration, braking, or cornering.



The awards review was a happier task. We looked for drivers with over 8,000 miles in FY 24, no crashes or traffic violations, 100% seatbelt compliance, little to no speeding, a 95% or higher safety score through telematics tracking, and strong employee performance records. For those meeting this safe driving criteria, we searched deeper in the telematics data to find our safest drivers.

Feliz Zeyerial is a Supervisor for Electrical Installations and Maintenance at DOT. He had a 98.8 safety score over FY24, only 7 times going 11 miles over the speed limit, even for a short period, and hitting the accelerator hard only 4 times in almost 10,000 miles. From Felix, "I was truly honored by being nominated for this award and being recognized as one of the safest drivers in New York City. Being a safe driver protects the lives of all New Yorkers."



Miguel Guy is a Plumbing Inspector at the Department of Buildings. He only once exceeded 11 miles over the speed limit in nearly 9,000 miles. Miguel said, "I was very surprised at winning the Safe Driver Award. It is a very humbling experience and is very much appreciated. I will always try while operating a vehicle in the city to keep myself and the citizens of New York City safe."

Peter Pollara is a Communications Electrician at the Fire Department. In nearly 12,000 miles, he only needed to press down hard on the brake 16 times. Peter states, "It was truly an honor to be recognized as one of the top 3 inaugural safe driving award recipients. Driving is a major part of my job, and I take it very seriously; I consider myself a representative of The City of New York and the FDNY. I realized that if you practice safe driving habits, they become second nature. What I do isn't anything extraordinary; I drive at the speed limit. I don't use

electronic devices; most importantly, I pay close attention to the other drivers around me. Anyone can do it. In closing, I would like to thank you, the DCAS team, for putting this terrific symposium together; well done!"

By always driving in a controlled, alert, and safe manner, these fleet operators set the standard and remind us that you can drive carefully and still get your work done.

DCAS will look to expand the recognition of safe driving in future forums and elsewhere.


