WHEN TO APPLY: From: July 1, 2009 To: July 7, 2009 APPLICATION FEE: \$60.00 Payable by mail by money order to DCAS (EXAMS) or payable online by credit card, bank card or debit card.

THE TEST DATE: Practical testing is expected to begin on Monday, October 12, 2009.

This Notice of Examination is amended to reopen the filing from July 1, 2009 to July 7, 2009. There is no change in the expected start date of the practical test of October 12, 2009. Candidates who filed previously need not file again.

The eligible list resulting from this examination may also be used to fill vacancies in the title of Road Car Inspector. The names of eligibles accepting or declining appointments either as a Car Inspector or a Road Car Inspector will be removed from the eligible list.

WHAT THE JOB INVOLVES: Car Inspectors, under supervision, maintain, inspect, test, examine, lubricate, troubleshoot and make repairs and adjustments on any part of the New York City Transit Authority's multiple-unit subway cars and subway service cars in the car shops, terminals, yards and on the road, including subway car, body electrical, electronic, mechanical and pneumatic equipment, truck equipment, body and truck brake rigging, electrical and pneumatic brake equipment, subway car bodies and associated fixtures, air conditioning and heating equipment, and electrical and electronic control and motor equipment; they maintain and repair subway car washers and shop equipment; operate and maintain lifting and carrying equipment associated with the placement and removal of subway cars and subway car parts; keep records and prepare reports; and perform related work.

Some of the physical activities performed and environmental conditions experienced by Car Inspectors are: working outdoors in all kinds of weather; crouching under subway cars in maintenance pits; reaching into dark spaces and making tactile inspections; making visual inspections of equipment; distinguishing colors; reading gauges and prints; climbing into and out of maintenance pits; using hand tools; hearing warnings (bell, whistle and vocal); and carrying heavy tools and equipment.

**Road Car Inspectors**, under supervision, detect trouble on any part of the New York City Transit Authority's multiple-unit subway cars and subway service cars on the road and in terminals, including subway car body and truck equipment, subway car body and truck brake rigging, electrical and pneumatic brake equipment, and electrical and electronic control and motor equipment; make necessary repairs to keep subway cars in service or enable them to be moved to sidings or terminals; drive a motor vehicle; keep records and prepare reports; and perform related work.

Some of the physical activities performed and environmental conditions experienced by Road Car Inspectors are: working outdoors in all kinds of weather; crouching under subway cars along trackways; reaching into dark spaces and making tactile inspections; making visual inspections of equipment; distinguishing colors; reading gauges and prints; using ladders to climb up to and descend from trackways; working on elevated structures; operating heavy machinery and equipment; using hand tools; hearing warnings (bell, whistle and vocal); communicating verbally with crew and passengers regarding train troubles experienced on the road; and carrying heavy tools and equipment.

**Special Working Conditions**: Car Inspectors and Road Car Inspectors may be required to work rotating shifts including nights, Saturdays, Sundays, and holidays.

(This is a brief description of what you might do in these positions and does not include all the duties of these positions.)

### **READ CAREFULLY AND SAVE FOR FUTURE REFERENCE**

- **THE SALARY**: The current minimum salary is \$27.6550 per hour for a 40-hour week. The current minimum salary for Road Car Inspector is \$30.6800 per hour for a 40-hour week. These rates are subject to change. In addition, incumbents receive night and weekend differentials, paid holidays, vacations and sick leave, a comprehensive health plan and a pension plan.
- **HOW TO APPLY**: If you believe that you meet the requirements in the "How to Qualify" section, there are two ways to apply for this examination;
  - (1) **Online at the DCAS WEBSITE**: If you wish to apply online, go to the Online Application System (OASys) at <u>www.nyc.gov/examsforjobs</u> and follow the onscreen application instructions for electronically submitting your application and completing any required forms. The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or prepaid debit card which you may purchase online or at various retail outlets.
  - (2) **By mail**: refer to the "Required Forms" section below for the forms that you must fill out. Return the completed forms and the application fee to DCAS Application Unit, 1 Centre Street, 14th floor, New York, NY 10007.

DCAS will not accept applications in person from candidates.

### HOW TO QUALIFY:

# Education and Experience Requirements: By the last day of the Application Period you must have:

Two years of full-time satisfactory experience as a mechanic at the journeyman/journeywoman level (i.e., a fully trained, knowledgeable, experienced, proficient and competent mechanic), working from drawings, performing troubleshooting, repair or maintenance of large heavy duty electromechanical, electric or electronic equipment and machinery; or the electrical inspection, maintenance, troubleshooting and repair of multiple-unit electrical railroad cars or diesel-electric locomotives.

For the above journey level experience to be credited, it must be preceded by one of the following:

- (1) two years of full-time satisfactory experience as a mechanic's helper, apprentice or trainee performing or assisting in the work described above; or
- (2) graduation from a trade school, technical school or vocational high school, approved by a state's Department of Education or comparable agency, with a major course of study in electromechanical, electrical or electronic technology, or a closely related field, totaling 600 hours; or
- (3) graduation from an accredited college or university with an A.A.S. degree, or a higher degree, in electromechanical, electrical or electronic technology or a closely related field.

The following are examples, but not all inclusive, of acceptable types of experience: air-craft/avionics technician; power-plant technician; automotive/diesel mechanic/technician; commercial/industrial electrician; electronic systems technician; commercial/industrial HVAC technician; and elevator/escalator mechanic.

The following are examples of types of experience that are **not** acceptable: machinist; CNC machine operator; assembler; basic electrical work such as residential/commercial lighting and wiring; electronic bench technician; auto-body and fender mechanic; auto or truck assembly mechanic; dealership make-ready mechanic; gas station attendant; salvage or junkyard mechanic; automotive specialty work such as changing mufflers, windshield wipers, tires, oil, etc.; and repair of personal computers.

You may be given the practical test before we verify your qualifications. You are responsible for determining whether or not you meet the qualification requirements for this examination prior to submitting your application. If you are marked "Not Qualified," your application fee will not be refunded and you will not receive a score.

**Driver License Requirement**: (For Road Car Inspector appointment only) At the time of appointment, you must possess a motor vehicle driver license valid in the State of New York. If you have serious moving violations, license suspension or accident record you maybe disqualified. This license must be maintained for the duration of your employment. Some assignments may require a Class B Commercial Driver License.

**Medical Requirement**: Medical guidelines have been established for the positions of Car Inspector and Road Car Inspector. You will be examined to determine whether you can perform the essential functions of the position of Car Inspector or Road Car Inspector. Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable him or her to take the examination, and /or to perform the essential functions of the job.

Drug Screening Requirement: You must pass a drug screening in order to be appointed.

**Residency**: City residency is not required for this position.

English Requirement: You must be able to understand and be understood in English.

**Proof of Identity**: Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with the City of New York.

### **REQUIRED FORMS:**

- (1) Application for Examination: Make sure that you follow all instructions included with your application form, including payment of fee. Save a copy of the instructions for future reference.
- (2) Education and Experience Test Paper: Write your social security number in the box at the top right side of the cover page, and the examination title and number in the box provided. Fill out Sections A, B and C. This form must be filled out completely and in detail for you to receive your proper rating. Keep a copy of your completed Education and Experience Test Paper for your records.
- (3) Foreign Education Fact Sheet (Required <u>only</u> if you need credit for your foreign education to meet the education and experience requirements): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Fact Sheet included with your application packet. When you contact the evaluation service, ask for a "document-by-document" (general) evaluation of your foreign education. You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight weeks from the last date for applying for this examination.
- ADMISSION CARD: You should receive an Admission Card in the mail about 10 days before the date of the test. If you do not receive an Admission Card at least 4 days before the test date, you must go to the Examining Service Section, 1 Centre Street, 14th floor, New York, NY 10007, to obtain a duplicate card.
- **THE TEST**: You will be given a practical test. Your score on this test will be used to determine your place on the eligible list. You must receive a score of 70% to pass the test. The practical test may require you to perform tasks that demonstrate your knowledge of electrical, electronic, mechanical and pneumatic principles and devices by: installing, testing and repairing of such devices; reading and understanding electrical and mechanical manuals and drawings; performing safe work practices and procedures; and other related tasks.
- **THE TEST RESULTS:** If you meet the education and experience requirements, and pass the practical test, your name will be placed in final score order on an eligible list and you will be given a list number. You will be notified by mail of your test results. If you meet all requirements and conditions, you will be considered for appointment when your name is reached on the eligible list.

### ADDITIONAL INFORMATION:

**Promotion Test**: A promotion examination for this title is being held for eligible City employees. The names appearing on the promotion list will be considered first in filling vacancies.

- **SPECIAL TEST ACCOMMODATIONS**: If you plan to request special testing accommodations due to disability or an alternate test date due to your religious belief, and you are applying
  - (1) **online**, follow the onscreen instructions; or
  - (2) **by mail**, follow the instructions included with the "Application for Examination."
