Candidates who applied for Computer Specialist (Software), Exam No. 6020, which was canceled, should follow instructions on "Next Steps" in the letter that was sent to them by DCAS.

WHAT THE JOB INVOLVES: Computer Specialists (Software), under supervision, with considerable latitude for independent action or the exercise of independent judgment, are responsible for the analysis, design, development, implementation, enhancement, maintenance and security of database management systems, operating systems, data communications systems, applications, mobile applications, websites, and/or related software functions; may supervise a unit engaged in work related to these areas or may independently perform related work of a highly complex, technical nature. All Computer Specialists (Software) perform related work.

Special Working Conditions: Computer Specialists (Software) may be required to work shifts including nights, Saturdays, Sundays, and holidays.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

THE SALARY: The current minimum salary is \$76,288 per annum. This rate is subject to change. There are four assignment levels within this class of positions. Appointments will generally be made to Assignment Level I. After appointment, employees may be assigned to the higher assignment levels at the discretion of the agency.

HOW TO APPLY: If you believe you meet the requirements in the "How to Qualify" section, submit an application on the Online Application System (OASys) at www.nyc.gov/examsforjobs. Follow the onscreen application instructions for electronically submitting your application and payment, and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. **All new OASys accounts require verification before a candidate can submit an application to ensure the accuracy of candidate information. Verification is instantaneous for most accounts, but some accounts may require up to 24 hours to be reviewed by a staff member and resolved. Email notification will be sent to those creating accounts that require additional documentation before they can be resolved. Please keep this information and the application period deadline in mind when creating your account.** The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets.

If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. Special Circumstances Guide: This guide is located on the DCAS website at www.nyc.gov/html/dcas/downloads/pdf/misc/pdf_c_special_circumstances_guide.pdf and available at the DCAS Computer-based Testing & Applications Centers. This guide gives important information about claiming Veterans' or Legacy credit, and notifying DCAS of a change in your mailing address. Follow all instructions on the Special Circumstances Guide that pertain to you when you complete your "Application for Examination."

HOW TO QUALIFY: You are responsible for determining whether or not you meet the qualification requirements for this examination prior to submitting your application. If you are marked "Not Qualified," your application fee will not be refunded and you will not receive a score.

Education and Experience Requirements:

1. A baccalaureate degree from an accredited college or university, including or supplemented by 24 semester credits in computer science or a related computer field **and** two years of satisfactory, full-time computer software experience in computer systems development and analysis, applications programming, database administration, maintenance and support, systems programming, data communications, mainframe development, mobile development and/or web development and design, one year of which must have been in a project leader capacity or as a major contributor on a complex project in one or more of the acceptable areas; or
2. A four-year high school diploma or its educational equivalent **and** six years of satisfactory, full-time computer software experience as described in "1" above, one year of which must have been in a project leader capacity or as a major contributor on a complex project in one or more of the acceptable areas; or
3. Education and/or experience equivalent to "1" or "2" above. College education may be substituted for up to two years of the required experience in "2" above on the basis that 60 semester credits from an accredited college or university is equated to one year of experience. A masters degree from an accredited college or university in computer science or a related computer field, or a certificate of at least 625 hours in computer programming from an accredited technical school (post high school), may be substituted for one year of the required experience in "1" or "2" above. However, all candidates must have at least a four-year high school diploma or its educational equivalent **and** at least one year of satisfactory full-time experience in a project leader capacity or as a major contributor on a complex project in one or more of the acceptable areas.

- Note:**
- (1) To receive credit, all semester credits in computer science or a related computer field from an accredited college or university **must** be entered in **Section A.6** of the Education and Experience Test.
 - (2) To receive credit, the certificate of at least 625 hours in computer programming from an accredited technical school (post high school) **must** be entered in **Section A.3** of the Education and Experience Test.
 - (3) In order to have your experience as a Project Leader or Major Contributor on a complex project accepted, you **must** explain in detail the duties/tasks/functions you performed as a project leader or as a major contributor on a complex project in one or more of the acceptable areas.
 - (4) Some examples of unacceptable experience are:
 - a. end users of: a computer system, program or software package; productivity software products (e.g., word processing, spreadsheet, presentation, and database software, etc.); preprogrammed software without complex programming, design and implementation.
 - b. experience in the areas of: computer technical support, computer operations, data entry/data retrieval, pure quality assurance (QA) auditing and analysis, hardware installation, call center, teaching and/or telecommunications.

The education requirement must be met by January 31, 2017. The experience requirement must be met by the last day of the Application Period (September 27, 2016).

The high school diploma or its educational equivalent must be approved by a State's Department of Education or a recognized accrediting organization. The technical school (post high school) must be approved by a State's Department of Education or a recognized accrediting organization. The college or university must be accredited by regional, national, professional, or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education and by the Council for Higher Education Accreditation (CHEA).

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required only if you need credit for your foreign education in this examination.

You must clearly specify in detail all of your relevant education and experience on your Education and Experience Test and submit it by the end of the Application Period. If you are currently employed by the City of New York, do not assume that persons reviewing your Education and Experience Test will know information which you do not provide on your Education and Experience Test, including information about your current job. If you have applied for a previous examination, do not assume that persons reviewing your Education and Experience Test will know about information you provided on a previous Education and Experience Test.

You will not receive credit for education which you obtain after January 31, 2017 or experience which you obtain after the end of the Application Period.

Residency Requirement: City residency is not required for this position.

English Requirement: You must be able to understand and be understood in English.

Proof of Identity: Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with the City of New York.

REQUIRED INFORMATION:

- 1. **Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. **Education and Experience Test:** Fill out **Sections A.1 (if applicable), A.2, A.3 (if applicable), A.4 (if applicable), A.5 (if applicable), A.6 (if applicable), B and D (if applicable).** This test must be filled out completely and in detail for you to receive your proper rating. Follow the online instructions.
- 3. **Foreign Education Evaluation Guide (Required only if you need credit for your foreign education in this examination):** If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Evaluation Guide located on the DCAS website at www.nyc.gov/html/dcas/downloads/pdf/misc/foreigneducation.pdf. When you contact the evaluation service, ask for the evaluation as follows:
 - (A) If you wish to claim a diploma/degree **only** and do not wish to claim any semester credits in the subject area(s) described in the *How to Qualify* section on page 2 and/or *The Test* section on pages 3-4, ask for a "**document-by-document**" evaluation of your foreign education.
 - (B) If you wish to claim a diploma/degree **and/or** semester credits in the subject area(s) described in the *How to Qualify* section on page 2 and/or in *The Test* section on pages 3-4, ask for a "**course-by-course**" evaluation (which includes a "document-by-document" evaluation) of your foreign education.
 - (C) If you wish to claim a certificate of at least 625 hours in computer programming described in the *How to Qualify* section on page 2, then ask the Evaluation Service to recommend the appropriate type of evaluation and ensure that the evaluation states the number of hours completed.
 - (D) If you wish to claim continuing education course(s) described in *The Test* section on page 3-4, ask the Evaluation Service to recommend the appropriate type of evaluation.

You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight weeks from the last date for applying for this examination.

THE TEST: Your score will be determined by an education and experience test. You will receive a score of 70 points for meeting the education and experience requirements listed above. After these requirements are met, you will receive credit **for up to four additional years of experience**, up to a maximum of 100 points, on the following basis:

Experience:

If you have satisfactory full-time computer software experience in a project leader capacity or as a major contributor on a complex project in at least one of the following areas: computer systems development and analysis; applications programming; database administration; maintenance and support of software, database, operating or data communication systems; systems programming; data communications; mainframe development; mobile development; web development and design, for (see notes 1 and 2 below):

You will receive:

At least 6 months but less than 1 year	6 points
At least 1 year but less than 2 years	12 points
At least 2 years but less than 3 years	18 points
At least 3 years but less than 4 years	24 points
4 years of experience	30 points

If you have satisfactory full-time computer software experience in at least one of the following areas: computer systems development and analysis; applications programming; database administration; maintenance and support of software, database, operating or data communication systems; systems programming; data communications; mainframe development; mobile development; web development and design, for (see notes 1 and 2 below):

You will receive:

At least 6 months but less than 1 year	3 points
At least 1 year but less than 2 years	6 points
At least 2 years but less than 3 years	9 points

At least 3 years but less than 4 years	12 points
4 years of experience	15 points

Notes:

- 1. The type of acceptable experience listed above includes work performed in configuring Commercial off-the-shelf (COTS) applications, systems and security products in the areas of applications programming, applications development and systems programming.
- 2. Some examples of unacceptable experience are:
 - a. end users of: a computer system, program or software package; productivity software products (e.g., word processing, spreadsheet, presentation, and database software, etc.); preprogrammed software without complex programming, design and implementation.
 - b. experience in the areas of: computer technical support, computer operations, data entry/data retrieval, pure quality assurance (QA) auditing and analysis, hardware installation, call center, teaching and/or telecommunications.

Education: Ten (10) points is the maximum amount of additional points for education that may be credited for graduate credit(s), undergraduate credit(s), and continuing education course(s) combined.

If you have graduate semester credits completed at an accredited college or university in computer science, computer information systems and/or science, technology, engineering and mathematics (STEM) course areas such as physics, engineering, logic/proof-based mathematics, and/or statistics, for the completion of (see notes 1 and 2 below):

You will receive:

3 to 8 graduate semester credits	2 points
9 to 14 graduate semester credits	4 points
15 to 20 graduate semester credits	6 points
21 to 26 graduate semester credits	8 points
27 or more graduate semester credits	10 points

If you have undergraduate semester credits completed at an accredited college or university in computer science, computer information systems and/or science, technology, engineering and mathematics (STEM) course areas such as physics, engineering, logic/proof-based mathematics, and/or statistics, for the completion of (see notes 1 and 2 below):

You will receive:

3 to 8 undergraduate semester credits	1 point
9 to 14 undergraduate semester credits	2 points
15 to 20 undergraduate semester credits	3 points
21 to 26 undergraduate semester credits	4 points
27 or more undergraduate semester credits	5 points

If you have completed continuing education course(s) in computer programming, computer science, computer information systems, project management, business analysis and/or science, technology, engineering and mathematics (STEM) course areas such as physics, engineering, logic/proof-based mathematics, and/or statistics at an accredited college or university or at a professional training center, for the completion of (see note 2 below):

You will receive:

One (1) continuing education course	1 point
Two (2) continuing education courses	3 points
Three (3) continuing education courses	5 points

Notes:

- 1. Any course(s) completed as part of a baccalaureate degree program or masters degree program, including those in STEM course areas, which will be applied toward the qualification requirement, cannot receive additional credit. If the twenty-four (24) semester credits in computer science or a related computer field are applied toward the qualification requirement, they cannot receive additional credit.
- 2. You must list each and every undergraduate, graduate, and/or continuing education course for which you wish to be evaluated for credit in Section A.6 of the Education and Experience Test.

You will receive a maximum of one year of experience credit for each year you worked. If you have any of the above experience on a part-time basis, it will be credited according to the equivalent percent of full-time experience. Each year of experience will be credited under only one category which will be the highest appropriate category. **Education and experience used to meet the minimum requirements cannot be used to gain additional credit.**

You must clearly specify in detail all of your relevant education and experience on your Education and Experience Test and submit it by the end of the Application Period. If you are currently employed by the City of New York, do not assume that persons reviewing your Education and Experience Test will know information which you do not provide on your Education and Experience Test, including information about your current job. If you have applied for a previous examination, do not assume that persons reviewing your Education and Experience Test will know about information you provided on a previous Education and Experience Test.

Education must be obtained **by January 31, 2017** and experience must be obtained by **the last day of the Application Period (September 27, 2016).**

THE TEST RESULTS: If you pass the education and experience test, your name will be placed in final score order on an eligible list and you will be given a list number. You will be notified by mail of your test results. If you meet all requirements and conditions, you will be considered for appointment when your name is reached on the eligible list.

CHANGE OF MAILING AND/OR EMAIL ADDRESS: It is critical that you promptly notify DCAS of any change to your mailing address and/or email address. You may miss important information about your exam(s) or consideration for appointment, including important information that may require a response by a specified deadline, if we do not have your correct mailing and/or email address. Change of mailing and/or email address requests submitted to any place other than DCAS, such as your Agency or to the United States Postal Service will NOT update your records with DCAS. ADDITIONAL INFORMATION:

Selective Certification for Certification and/or Special Experience: If you have the certification and/or experience listed in one or more of the areas listed below, you may be considered for appointment to positions requiring a certification and/or experience through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this certification and/or experience. **Your certification(s) and/or experience will be checked by the appointing agency at the time of appointment.**

Note: In **Section D** of the Education and Experience Test, please enter the 3-digit code which corresponds to the Selective Certification(s) you wish to be considered for, and separate each with a comma and no space. There should be no more than ten (10) Selective Certification entries per line. For example, if you wish to select Selective Certifications #1 and #2, enter the following in **Section D** of the Education and Experience Test: NED,NEC.

1. **.NET Middle Tier Developer:** At least three (3) years of satisfactory, full-time experience working with the .NET development stack. Experience should include, but is not limited to: designing and implementing an Entity Domain Model; utilizing ADO.NET and ORM tools such as Entity Foundation, Nhibernate, Dapper, etc.; Domain-Driven Design; and Command Query Response Segregation (CQRS). **To add Selective Certification for .NET Middle Tier Developer, enter "NED" in Section D of the Education and Experience Test.**
2. **.NET MVC Developer:** At least three (3) years of satisfactory, full-time experience working with .NET web applications leveraging the ASP.NET MVC Architecture. The experience should include, but is not limited to: ASP.NET MVC, Kendo UI, TypeScript, Javascript, Web API, etc. **To add Selective Certification for .NET MVC Developer, enter "NEC" in Section D of the Education and Experience Test.**
3. **ADABAS Systems Engineering:** At least five (5) years of satisfactory, full-time Data processing experience as a systems programmer/engineer installing and administering Software AG products including, but not limited to: ADABAS, NATURAL, PREDICT, Event Replication, Entirex, SQL Gateway, and webMethods Integration Server. **To add Selective Certification for ADABAS Systems Engineering, enter "ADB" in Section D of the Education and Experience Test.**
4. **Agile Scrum Certification:** A valid SCRUM certification (e.g., Certified Scrum Professional (CSP) from any institution, PMI Agile Certified Practitioner (PMI-ACP) from the Project Management Institute (PMI), Certified Scrum Master (CSM) from any institution) **and** at least two (2) years of satisfactory, full-time experience implementing Scrum to manage IT projects using the Agile software development methodology by conducting daily Scrum meetings as the Scrum master with complex project teams. **To add Selective Certification for Agile Scrum Certification, enter "SUM" in Section D of the Education and Experience Test.**
5. **Agile Scrum Project Management Experience:** At least four (4) years of satisfactory, full-time IT project management experience which must include: at least two (2) years of satisfactory, full-time experience implementing packaged or custom built applications, systems, major system components, or integrations between multiple applications or system components; including deployment to, or provisioning of, physical, virtual or cloud-based hosting **and** at least two (2) years of satisfactory, full-time experience implementing Scrum to manage projects using the Agile software development methodology by conducting daily Scrum meetings as the Scrum master with multi-disciplinary teams (e.g., Business Analysts, and/or Developers, and/or Server Engineers, and/or Network Engineers, and/or Security Engineers, and/or Quality Assurance Testers, and/or Support Engineers).

Acceptable application development projects include enterprise-class technologies such as, but not limited to, HTML5, Java, Spring, .Net, Oracle, SQL server, MQ, Web Services, ETL, and specific product stacks such as Oracle WebLogic, JBOSS, Azure, AWS Elastic Beanstalk, Docker, OBIEE, Informatica, Socrata, Documentum, Law Manager, MS Dynamics CRM, MS Sharepoint, and mobile technologies such as iOS and Android development.

All candidates must have gained, as part of the required four (4) years of experience, at least one (1) year of experience with project management, project portfolio management and IT Service Management tools, including, but not limited to Rally, Jira, MS Project, CA Clarity, and BMC Remedy.

To add Selective Certification for Agile Scrum Project Management Experience, enter "SUP" in Section D of the Education and Experience Test.

- 6. **AIX Server Administration:** At least three (3) years of satisfactory, full-time experience in AIX System administration. The experience should include, but is not limited to: configuration and administration of enterprise-class servers including IBM AIX 4.x, AIX 5.1, AIX 5.2, AIX 5.3, or AIX 6.1.4 or higher version in a large scale data center operations support function. **To add Selective Certification for AIX Server Administration, enter "363" in Section D of the Education and Experience Test.**
- 7. **API Development:** At least three (3) years of satisfactory, full-time experience in the design, development, implementation, maintenance and enhancement of Application Program Interfaces (APIs). The experience should include, but is not limited to: SOA, SOAP, REST, XML, Java, .NET, Test-Driven Development (TDD), Git, Subversion, CVS, Eclipse, Apache Xerces, Tomcat, Jboss, Oracle WebLogic, DOM and Unix. **To add Selective Certification for API Development, enter "API" in Section D of the Education and Experience Test.**
- 8. **Application Development:** At least five (5) years of satisfactory, full-time experience in the analysis, design, implementation, maintenance and enhancement of applications using VB.Net, VBA, C#, VBScript, ASP.NET, PHP and/or other languages. **To add Selective Certification for Application Development, enter "APD" in Section D of the Education and Experience Test.**
- 9. **Back-end Application Development:** At least three (3) years of satisfactory, full-time experience in backend mainframe application development. The experience should include, but is not limited to: Adabas/Natural or DB2. **To add Selective Certification for Back-end Application Development, enter "BED" in Section D of the Education and Experience Test.**
- 10. **BMC Remedy Development:** At least three (3) years of satisfactory, full-time experience in analysis, design, development, implementation and maintenance of applications including BMC Remedy ITSM 7.x/8.x and/or in installation, configuration and administration of Remedy ARS 8.x, Mid-tier 8.x, ITSM 8.x, CMDB 8.x and/or higher versions. **To add Selective Certification for BMC Remedy Development, enter "BMC" in Section D of the Education and Experience Test.**
- 11. **Browser-Based Client-Side Development:** At least three (3) years of satisfactory, full-time experience in the design, development, implementation, maintenance and enhancement of browser-based client-side web applications. The experience should include, but is not limited to: HTML, CSS, JavaScript, AJAX, XML, JSON, Flash, Bootstrap or a similar framework, Google Maps and AngularJS. **To add Selective Certification for Browser-Based Client-Side Development, enter "BAD" in Section D of the Education and Experience Test.**
- 12. **Business Analysis Management:** At least five (5) years of satisfactory, full-time experience employing User-Centered Analysis techniques (interviews, direct observations, requirement work sessions, etc.) in a variety of systems development life cycle (SDLC) methodologies, including Agile, to understand business needs and clearly define the requirements package for IT applications, two (2) years of which must have been leading a team of business analysts, working on eliciting business needs and defining requirements for IT applications, and developing and formalizing software development methodology. **To add Selective Certification for Business Analysis Management, enter "BAM" in Section D of the Education and Experience Test.**
- 13. **Business Analysis:** At least two (2) years of satisfactory, full-time experience employing User-Centered Analysis techniques (interviews, direct observations, requirement work sessions, etc.) in a variety of systems development life cycle (SDLC) methodologies, including Agile, to understand and elicit business needs and clearly define the requirements package for IT applications. **To add Selective Certification for Business Analysis, enter "BNA" in Section D of the Education and Experience Test.**

14. **Business Intelligence (BI) Analysis:** At least two (2) years of satisfactory, full-time experience in the analysis, design and implementation of Business Intelligence (BI) applications and reporting solutions that includes tasks and activities utilizing BI concepts and Data Warehousing methodologies (e.g., Star Schemas, Dimensional Models, and Data marts), analyzing and designing solutions using BI Tools and/or data modeling, data copying/ETL (Extract, Transform and Load) design and developing and employing functional artifacts. Examples include, but are not limited to:
- BI Tools: OBIEE, Jasper, Tableau, Crystal Report, SSRS, Cognos
 - Data Copying: Informatica, SSIS, Talend, Pentaho, iWay
 - Functional artifacts: Requirements Definitions, Report Mockups, Report Designs, Data Dictionary, Conceptual data models, Glossary.

To add Selective Certification for Business Intelligence (BI) Analysis, enter "BIA" in Section D of the Education and Experience Test.

15. **Business Intelligence/Analytics Systems Administration:** At least one (1) year of satisfactory, full-time experience in administering, supporting, designing, developing, installing, configuring, implementing, maintaining and/or enhancing Business Intelligence or Analytics systems. Examples include, but are not limited to: OBIEE, DAC, Informatica Power Exchange, Power Center, SSIS, Data Warehouse, SAS, PL/SQL, BI Publisher, Actuate and/or BI Publisher reports, Visual Studio, IIS, WebLogic, WebTrend, SQL Server, SSRS, XML/XSL/Web Services, Unix, Linux and SQL. **To add Selective Certification for Business Intelligence/Analytics Systems Administration, enter "BIS" in Section D of the Education and Experience Test.**
16. **Business Intelligence/Analytics Systems Development:** At least two (2) years of satisfactory, full-time experience in designing, developing, configuring, implementing, integrating, maintaining and/or enhancing Business Intelligence or Analytics systems.
