#### WHAT THE JOB INVOLVES:

Certified IT Developers (Applications), under supervision, with latitude for independent action and the exercise of independent judgment, are responsible for performing highly technical and supervisory responsibilities in applications development, including planning, designing, configuring, installing, testing, troubleshooting, integrating, performance monitoring, maintaining, enhancing, security management, and support of complex computer applications programs. Certified IT Developers (Applications) may supervise a small unit engaged in the above duties; may serve as a project leader of projects involving computer applications programs, or may independently perform development, testing or maintenance work of a highly technical nature. In the temporary absence of the supervisor, they may perform the duties of that position. All Certified IT Developers (Applications) perform related work, including end user support and dispersor recovery and when pages and perform the duties of related or lower titles and Assignment Levelopers. disaster recovery and, when necessary, perform the duties of related or lower titles and Assignment Levels.

## **Special Working Conditions:**

Certified IT Developer (Applications) may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

#### **EDUCATION AND EXPERIENCE REQUIREMENTS:**

In addition to meeting the professional/vendor certification requirement above, all candidates must also have the following:

- A baccalaureate degree from an accredited college or university, and two years of satisfactory fulltime (not classroom based) experience in computer applications development planning, design, installation, troubleshooting, integration, performance monitoring, maintenance, configuration. enhancement, and security management; or
- A four-year high school diploma or its educational equivalent and six years of satisfactory full-time (not classroom based) information technology experience of which at least 2 years must have been computer applications development experience as described in "1" above;or
- Education and/or experience equivalent to "1" or "2" above. A masters degree in computer science or a related field from an accredited college or university may substitute for one year of computer applications development experience as described in "1" above. However, all candidates must have at least one year of satisfactory full-time (not classroom based) computer applications development experience as described in "1" above.

Some examples of acceptable information technology experience include experience in the areas business/systems analysis, database administration/modeling/design, analysis/mapping, testing, and other related areas.

Note: In addition to meeting the minimum Qualification Requirements incumbents may be required to update existing and/or obtain additional professional industry standard certification(s) for current and future technical environment(s) in which they may be assigned to work, as determined by the employing agency.

The education requirement must be met by June 30, 2018. The professional/vendor certification and/or experience requirements must be met by the last day of the Application Period (June 26, 2018).

The high school diploma or its educational equivalent must be approved by a State's Department of Education or a recognized accrediting organization. The college or university must be accredited by regional, national, professional, or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education and by the Council for Higher Education Accreditation (CHEA). If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. You must be able to understand and be understood in English.

## **Proof of Identity:**

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services.

Follow the onscreen application instructions for electronically submitting your application and payment, and completing any required information. A unique and valid email address is required to file online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. All new OASys accounts require verification before a candidate can submit an application to ensure the accuracy of candidate information. Verification is instantaneous for most accounts, but some accounts may require up to two (2) business days to be reviewed by a staff member and resolved. Email notification will be sent to those creating accounts that require additional documentation before they can be resolved. Please keep this information and the application period deadline in mind when creating your account. The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets.

If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. #### **REQUIRED INFORMATION:**

**Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.

Affirmation Form: The Affirmation Form, which is found online, must be printed, signed, dated and sent by mail to the address on the form. If DCAS does not receive your completed Affirmation Form, your application will not be considered complete, and your name will not appear on the eligible list for this examination

Education and Experience Test: Fill out Sections A.1 (if applicable), A.2, A.4 (if applicable), A.5 (if applicable), B and D (if applicable). This test must be filled out completely and in detail for you to receive your proper rating. Follow the onlineinstructions.

Foreign Education Evaluation Guide (Required only if you need credit for your foreign education in this examination): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Evaluation Guide located on the DCAS website at <a href="www.nyc.gov/html/dcas/downloads/pdf/misc/foreigneducation.pdf">www.nyc.gov/html/dcas/downloads/pdf/misc/foreigneducation.pdf</a>. When you contact the evaluation service, ask for a "document-by-document" (general) evaluation of your foreign education. You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight weeks from the last date for applying for this examination.

#### THE TEST:

Your score will be determined by a professional/vendor certification, education and experience test. You will receive a score of 70 points for meeting the minimum professional/vendor certification, education and experience requirements listed above. After these requirements are met, you will receive additional credit up to a maximum of 100 points on the following basis:

If you have full-time (not classroom based) satisfactory experience in computer applications development planning, You will receive: designing, configuring, installation, troubleshooting,

integration, performance monitoring, maintenance, enhancement, and/or security management for:

At least 1 year but less than 2 years

You will receive a maximum of one year of experience credit for each year you worked. If you have any of the above experience on a part-time basis, it will be credited according to the equivalent percent of full-time experience. **Experience used to meet the minimum requirements cannot be used to gain additional credit.** 

### THE TEST RESULTS:

If you pass the Professional/Vendor Certification, Education and Experience test, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by mail of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. Selective Certification for Professional/Vendor Certifications: If you have professional/vendor certification(s) listed in the HOW TO QUALIFY section, you may be considered for appointment to positions requiring these professional/vendor certifications through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring these professional/vendor certifications. You will be eligible for Selective Certification for the professional/vendor certification that you used to meet the minimum qualification requirements. Your certification(s) will be checked by the appointing agency at the time of appointment.

To add Selective Certification for Geosupport Development, enter "316" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.

Selective Certification for Human Centered Design: At least three (3) years of satisfactory, full-time experience in the application of human-centered methodologies such as customer journey mapping, user research, customer interviews, visual design, contextual inquiry, and other research methods. To add Selective Certification for Human Centered Design, enter "HCD" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.

Selective Certification for Municipal Experience: At least one (1) year of satisfactory, full-time experience working within a municipal government in a similar position, which provides services for a city with over 1 million in population. To add Selective Certification for Municipal Experience, enter "MGE" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.

Selective Certification for Open Source Development: At least three (3) years of satisfactory, full-time experience in the analysis, design, implementation, maintenance, customization, and enhancement of systems including, but not limited to, the following Open Source technologies: Node, JS, Ruby, Python, PHP, PostgreSQL, MySQL, Drupal, WordPress, and/or JavaScript Frameworks. To add Selective Certification for Open Source Development, enter "OSD" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.

Selective Certification for Positions Requiring Information Technology Systems Experience in an Education Setting: At least one (1) year of full-time satisfactory experience operating, monitoring, troubleshooting and/or developing information technology and/or electronic records systems for an educational program(s) and/or institution(s). To add Selective Certification for Positions Requiring Information Technology Systems Experience in an Education Setting, enter "EIT" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.

Selective Certification for Positions Requiring Microsoft Azure Development Experience: At least three (3) years of full-time satisfactory experience as a certified Microsoft Azure developer. To add Selective Certification for Positions Requiring Microsoft Azure Development Experience, enter "45M" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.

Selective Certification for Positions Requiring Amazon Web Services (AWS) Development Experience: At least three (3) years of full-time satisfactory experience as a certified Amazon Web Services (AWS) developer. To add Selective Certification for Positions Requiring Amazon Web Services (AWS) Development Experience, enter "AWS" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.

Selective Certification for Positions Requiring Information Technology Systems Experience in a Public Health or Health Services Setting: At least one (1) year of full-time satisfactory experience operating, monitoring, troubleshooting and/or developing information technology and/or electronic records systems for a laboratory, hospital, community health center, private medical practice, patient care facility, or in a public health, environmental health, or mental hygiene program. To add Selective Certification for Positions Requiring Information Technology Systems Experience in a Public Health or Health Services Setting, enter "PIT" in Section D of the Education and Experience Test. Your experience will be checked by the appointing agency at the time of appointment.
