**This is a Qualified Incumbent Exam. See the *HOW TO QUALIFY* section to see if you meet the Minimum Qualification and New York City Employment Requirements.**

**THE SALARY:** The current minimum incumbent salary is \$63,014 per annum. This rate is subject to change.

**HOW TO QUALIFY:** This is a computer-based Qualified Incumbent Examination. Your qualifications and New York City employment will be evaluated online and you will receive immediate tentative results. You are responsible for determining whether or not you meet the Minimum Qualification and New York City Employment Requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive a score.

All experience used to meet the Minimum Qualification Requirements and New York City Employment Requirements must have been obtained **by the last day of the Application Period (June 22, 2021)**.

**READ CAREFULLY AND SAVE FOR FUTURE REFERENCE**

**Minimum Qualification and New York City Employment Requirements:** You must be currently employed by New York City as a provisional ASSISTANT CAPTAIN (FERRY) and have served as a provisional ASSISTANT CAPTAIN (FERRY) for at least two (2) years and you must meet the following Minimum Qualification Requirements:

1. One year of satisfactory service on a municipal ferry in one or a combination of the titles of Mate (Ferry) or Deckhand; **or**
2. Six months of satisfactory full-time experience piloting a large ferry or comparable vessel in New York Harbor and/or its contiguous waters.

**License and Training Requirements:** At the time of appointment to Assistant Captain (Ferry), you must have:

1. A valid United States Coast Guard License as Master of Steam or Motor Vessels of any gross tons upon oceans, inland or coastwise waters, with an endorsement as First Class Pilot of Steam and Motor Vessels of any gross tons with the following extensions of routes: Upper New York Bay; the East River from the Battery to Execution Rock; the Hudson River from the Battery to the George Washington Bridge; and Kill Van Kull to Mariner's Harbor; and
2. An endorsement as Radar Observer; and
3. A Federal Communications Commission Marine Radio Operator permit (Radio-telephone operator certificate - restricted); and
4. Completion of the Department of Transportation (DOT) on-the-job training course in operating and/or piloting of Staten Island Ferry vessels in accordance with the Safety Management System. Satisfactory completion of this course must be attested to in writing by at least two Captains (Ferry) responsible for training the candidate.

These credentials must be maintained for the duration of employment.

**Medical/Physical Requirements:**

Medical guidelines established by the U.S. Coast Guard apply to the position of Assistant Captain (Ferry). Candidates will therefore be required to undergo a medical examination prior to appointment and yearly thereafter pursuant to Coast Guard regulations. Candidates must also pass a drug screening to be appointed. Assistant Captains (Ferry) are subject to random drug and alcohol testing during their employment.

**You must select the applicable Qualification and New York City Employment options on your Qualified Incumbent Examination. You have until midnight Eastern time on the last day of the Application Period (June 22, 2021) to complete and Final Submit your Qualified Incumbent Examination in the Online Application System (OASys).** Once your Qualified Incumbent Examination is final submitted, it will be rated based on the information you provided and saved. All experience used to meet the Minimum Qualification Requirements must have been obtained by the last day of the Application Period (June 22, 2021).

**If you do not Final Submit your Qualified Incumbent Examination in OASys by midnight Eastern time on the last day of the Application Period (June 22, 2021), your examination will be considered incomplete, you will not be entitled to the appeals process, you will not receive a score, and your application fee will not be refunded.**

**Residency:** City residency is not required for this position.

**English Requirement:** You must be able to understand and be understood in English.

**Proof of Identity:** Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with the City of New York.

**REQUIRED INFORMATION:**

- 1. Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. Education and Experience Exam:** Follow the instructions displayed onscreen to answer the questions. You will have until midnight Eastern time on the last day of the Application Period (June 22, 2021) to clearly specify in detail all of your relevant experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (June 22, 2021), your examination will be considered incomplete, you will not be entitled to the appeals process, you will not receive a score, and your application fee will not be refunded.

**HOW TO APPLY:** If you believe you meet the Qualification and New York City employment requirements in the "How to Qualify" section, submit an application in the Online Application System (OASys) at [www.nyc.gov/examsforjobs](http://www.nyc.gov/examsforjobs). Follow the onscreen application instructions for electronically submitting your application and payment, and completing any required information. A unique and valid email address is required to file online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. **All new OASys accounts require verification before a candidate can submit an application to ensure the accuracy of candidate information. Verification is instantaneous for most accounts, but some accounts may require up to two (2) business days to be reviewed by a staff member and resolved. Email notification will be sent to those creating accounts that require additional documentation before they can be resolved. Please keep this information and the application period deadline in mind when creating your account.**

The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets.

If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. You may come to the DCAS Computer-based Testing & Applications Centers to apply for this examination online. However, you must schedule a customer service appointment prior to your visit. Due to the COVID-19 pandemic, DCAS no longer permits walk-ins at DCAS sites.

**THE TEST: This is a computer-based Qualified Incumbent Examination.** Your score will be determined by a Qualified Incumbent Examination consisting of an evaluation of your qualifications and New York City employment status. You will receive a score of 100 points for meeting the Qualification and New York City employment requirements listed above.

**You must select the applicable Qualification and New York City Employment options on your Qualified Incumbent Examination. You have until midnight Eastern time on the last day of the Application Period (June 22, 2021) to complete and Final Submit your Qualified Incumbent Examination.** Once your Qualified Incumbent Examination is final submitted, it will be rated based on the information you provided and saved.

If you do not Final Submit your Qualified Incumbent Examination in OASys by midnight Eastern time on the last day of the Application Period on June 22, 2021, your examination will be considered incomplete, you will not be entitled to the appeals process, you will not receive a score, and your application fee will not be refunded.

Legacy and Veterans' Preference credits are not permitted for Qualified Incumbent Examinations.

All experience used to meet the Minimum Qualification Requirements and New York City Employment Requirements must have been obtained by the last day of the Application Period (June 22, 2021).

**THE TEST RESULTS:** Immediately after you have final submitted the examination online, you will be informed of the results. If you are found Qualified, you will receive a tentative score of 100.000. At the time of establishment of the eligible list for this examination, your score will become final, your name will be placed in the final score order on the eligible list, and you will be given a list number. You will be notified by mail of your final test results. If you meet all requirements and conditions, you will be considered for permanent appointment when your name is reached on the eligible list. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

1. Navigate to the Dashboard for the Appeals tab.
2. Click the NEW APPEAL button to create and submit your appeal.
3. Select the exam from the Exam drop-down list, and
4. Select the exam part from the Exam Part drop-down list.
5. Select the reason for your appeal from the Appeal Reason drop-down list (if applicable).
6. Enter the details of your appeal by providing specific reasons why your score should be higher.

**ADDITIONAL INFORMATION:**

**Application Receipt:** You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check “Junk”, “Trash”, or “Spam” folders for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.

**PENALTY FOR MISREPRESENTATION:** Any intentional misrepresentation on the application or examination may result in disqualification, even after appointment, and may result in criminal prosecution.
