### WHAT THE JOB INVOLVES:

Steam Fitters (NYC Health + Hospitals), under supervision, perform work relating to installing, maintaining, and repairing piping, controls, and equipment for heating systems, compressed air systems, refrigerating systems, air conditioning systems, steam and hot water systems, fire suppression systems, cooling systems, and sprinkler systems. They install boilers, feedwater, vacuum and condensate equipment, fuel oil piping, and related auxiliary equipment; lay out work from plans, specifications, and sketches; may work with welding and brazing equipment; supervise the work of Steam Fitter's Helpers (NYC Health + Hospitals); and may drive a motor vehicle during work. All Steam Fitters (NYC Health + Hospitals) perform

Some of the physical activities performed by Steam Fitters (NYC Health + Hospitals) and the environmental conditions experienced are: working in hot, uncomfortable environments; working with steam leaks; using 6 inch to 4 foot pipe wrenches; using combination wrenches with a 60 pound pull; climbing ladders and scaffolds to reach equipment 25 feet above the ground; moving large and heavy sections of pipe; and lifting heavy objects.

# **Special Working Conditions:**

Steam Fitters (NYC Health + Hospitals) may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

# THE SALARY:

The current minimum salary is \$61.50 per hour for a 35-hour work week. This rate is subject to change.

# **HOW TO QUALIFY:**

You may be given the test before we verify your qualifications. You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive an Admission Notice or score. (For more information, see Exam Site Admission section.)

## **EDUCATION AND EXPERIENCE REQUIREMENTS:**

- 1. Five years of full-time satisfactory experience as a Steam Fitter; or
- 2. Not less than two and one-half years of such experience plus sufficient full-time experience as a helper or apprentice or relevant education or training to make up a total of five years of acceptable experience. Six months of experience will be credited for each year of apprenticeship or helper experience or for each year of completed approved trade or vocational school training in the steam fitting field.

The education requirement must be met by June 30, 2023. The experience requirement must be met by the last day of the Application Period (April 25, 2023).

The trade or vocational school must be approved by a State's Department of Education or a recognized accrediting organization.

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required only if you need credit for your foreign education in this examination.

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

(number of hours worked per week/35) x (number of months worked)

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation:  $21/35 \times 12 = 7.2$  months.

You have until midnight Eastern time on the last day of the Application Period (April 25, 2023) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (April 25, 2023), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

You will not receive credit for education which you obtain after June 30, 2023 or experience which you obtain after the end of the Application Period (April 25, 2023).

### **Driver License Requirement:**

For appointment to certain facilities, candidates must possess a Motor Vehicle Driver License valid in the State of New York. The license must be maintained for the duration of employment.

**Residency:** City residency is not required for this position.

**Medical Requirement:** Medical guidelines have been established for the position of Steam Fitter (NYC Health + Hospitals). Candidates will be examined to determine whether they can perform the essential functions of the position of Steam Fitter (NYC Health + Hospitals). Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable him or her to take the examination, and/or to perform the essential functions of the job.

**Vaccination Requirement:** As of September 27, 2021, all new hires must be vaccinated against the COVID-19 virus. If you are offered employment with NYC Health + Hospitals, all new hires must be fully vaccinated by your date of hire.

### **English Requirement:**

You must be able to understand and be understood in English.

## **Proof of Identity:**

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with NYC Health + Hospitals.

# **HOW TO APPLY:**

If you believe you meet the requirements in the "How to Qualify" section, apply using the Online Application System (OASys) at <a href="https://www.nyc.gov/examsforjobs">www.nyc.gov/examsforjobs</a>. Follow the onscreen application instructions for electronically submitting your application and payment and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. All new OASys accounts require verification before a candidate can apply to ensure the accuracy of candidate information. Verification is instantaneous for most accounts and you will receive a confirmation email with instructions to activate your account. For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.

The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets. If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. To schedule a customer service appointment through OASys for an exam-related or eligible list-related inquiry, find **Exam #1889**, click **Apply**, and follow the instructions provided to reserve your appointment location, date, and time.

You must complete the entire application by midnight, Eastern Time, of the last day of the application period. If you have questions about applying for this examination, you may contact DCAS at OASys@dcas.nyc.gov.

**Special Circumstances Guide:** This guide is located on the DCAS website at https://www1.nyc.gov/assets/dcas/downloads/pdf/employment/pdf\_c\_special\_circumstances\_guide.pdf and available at the DCAS Computer-based Testing & Application Centers. This guide gives important information about requesting an alternate test date because of religious observance or a special test accommodation for disability, claiming Veterans' or Legacy credit, and notifying DCAS of a change in your mailing address. Follow all instructions on the Special Circumstances Guide that pertain to you when you complete your "Application for Examination."

### **REQUIRED INFORMATION:**

- 1. **Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. **Education and Experience Exam:** Follow the instructions displayed onscreen to answer the questions. You will have until midnight Eastern time on the last day of the Application Period (April 25, 2023) to clearly specify in detail all of your relevant license, education, and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (April 25, 2023), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

3. Foreign Education Evaluation Guide (Required only if you need credit for your foreign education to meet the education and experience requirements): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Evaluation Guide which is located on the DCAS website at <a href="https://www1.nyc.gov/assets/dcas/downloads/pdf/employment/foreigneducation.pdf">https://www1.nyc.gov/assets/dcas/downloads/pdf/employment/foreigneducation.pdf</a>. When you contact the evaluation service, ask for a "document-by-document" (general) evaluation of your foreign education. You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight weeks from the last day of the Application Period (April 25, 2023).

#### THE TEST:

The multiple-choice test will be given at a computer terminal. Your score on this test will be used to determine your place on an eligible list. You must achieve a score of at least 70% to pass the test.

The multiple-choice test is designed to assess the extent to which candidates have certain knowledge and abilities determined to be important to the performance of the tasks of a Steam Fitter (NYC Health + Hospitals). Task areas to be tested are as follows: installation, maintenance and repair of piping, controls and equipment for heating systems, compressed air systems, refrigerating systems, air conditioning systems, steam and hot water systems, fire suppression systems, cooling systems and sprinkler systems; installation of boilers, feedwater systems, vacuum and condensate equipment, fuel oil piping and related auxiliary equipment; use of plans, specifications and sketches to lay out work; welding and brazing procedures, including tools and equipment; supervision of subordinates.

The multiple-choice test may include questions on the knowledge of basic principles of heating systems, air conditioning systems, refrigeration systems, compressed air systems, sprinkler systems, cooling systems, welding, soldering, rigging and hoisting; materials and equipment including installation and repair of pipes, hoses, fittings, pumps, steam traps, valves, strainers, fixtures, and other related equipment; selection, use and operation of hand and power tools; safe work practices; reading and interpreting plans, blueprints, and sketches; standards of employee ethical conduct; and other related areas.

The test may also include questions requiring the use of any of the following abilities:

**Written Comprehension**: Understanding written sentences and paragraphs. **Example**: A Steam Fitter (NYC Health + Hospitals) may use this ability when reviewing written task assignments and notes.

**Written Expression**: Using English words or sentences in writing so that others will understand. **Example**: A Steam Fitter (NYC Health + Hospitals) may use this ability when writing notes on work orders.

**Problem Sensitivity**: Determining when something is wrong or likely to go wrong. It includes being able to identify the whole problem, as well as elements of the problem. **Example**: A Steam Fitter (NYC Health + Hospitals) may use this ability when assessing and diagnosing mechanical issues on a piece of equipment.

**Number Facility**: Adding, subtracting, multiplying, and dividing quickly and correctly. **Example**: A Steam Fitter (NYC Health + Hospitals) may use this ability when adding different pipe sizes.

**Deductive Reasoning**: Applying general rules to specific problems to come up with logical answers. **Example**: A Steam Fitter (NYC Health + Hospitals) may use this ability when troubleshooting problems and determining a solution.

**Information Ordering**: Following correctly a rule or set of rules or actions in a certain order. The rule or set of rules used must be given. The things or actions to be put in order can include numbers, letters, words, pictures, procedures, sentences and mathematical or logical operations. **Example**: A Steam Fitter (NYC Health + Hospitals) may use this ability when repairing or replacing a mechanical device following predetermined steps.

Certain questions may need to be answered on the basis of documents or other information supplied to the candidates on the date of the multiple-choice exam.

# **EXAM SITE ADMISSION:**

Your Admission Notice will be available on your Dashboard in OASys 14 days before the first date on which testing is expected to begin. You can print or display your Admission Notice on your phone or personal

device to gain entry to the test site. Test site assignments will take your address into consideration, but nearness to your address cannot be guaranteed.

<u>Warning</u>: After gaining entry to the test site, you are not permitted to enter the testing area with electronic devices. Electronic devices include, but are not limited to, cellular phones, smart watches, recording devices, beepers, pagers, cameras, or portable media players. You are not permitted to use any type of headphones or ear buds. Calculators are permitted; however, they must be hand-held, battery or solar powered, and numeric only. Calculators with functions **other than** addition, subtraction, multiplication and division are prohibited. Electronic devices with an alphabetic keyboard or with word processing or data recording capabilities such as planners, organizers, etc. are prohibited. If you use any of these devices anywhere at any test site, whether in the testing area, restroom, hallway, or other location, at any time before, during or after the test or Protest Review Session, your test score will be nullified, you will be disqualified from taking any civil service tests for up to five years, and your application fee will not be refunded.

You may not have any other person, including children, present with you while you are being processed for or taking the test, and no one may wait for you inside of a Computer-based Testing & Application Center while you are taking the test.

Required Identification: You are required to bring one (1) form of valid (non-expired) signature and photo bearing identification to the test site. The name that was used to apply for the exam must match the first and last name on the photo ID. A list of acceptable identification documents is provided below. If you do not have an acceptable ID, you may be denied testing. Acceptable forms of identification (bring one) are as follows: State issued driver's license, City or State issued identification card, IDNYC, US Government issued Passport, US Government issued Military Identification Card, US Government issued Alien Registration Card, Employer ID with photo, or Student ID with photo.

**Leaving**: You must leave the test site once you finish the test. If you leave the test site after being fingerprinted but before finishing the test, you will not be permitted to re-enter. If you disregard this instruction and re-enter the test site, you may not receive your test results, your test score may be nullified, and your application fee will not be refunded.

# THE TEST RESULTS:

If you meet the education and experience requirements and pass the multiple-choice test, your name will be placed in final score order on a NYC Health + Hospitals eligible list, you will be given a list number and you will be notified by email of your test result The eligible list determines the order by which candidates will be considered for appointment If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list.

If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

To access the appeal portal of OASys, please log into your OASys account at www.nyc.gov/examsforjobs and use the following steps:

- 1. Navigate to the Dashboard for the Appeals tab.
- 2. Click the NEW APPEAL button to create and submit your appeal.
- 3. Select the exam from the Exam drop-down list, and
- 4. Select the exam part from the Exam Part drop-down list.
- 5. Select the reason for your appeal from the Appeal Reason drop-down list (if applicable).
- 6. Enter the details of your appeal by providing specific reasons why your score should be higher.

## **SPECIAL ARRANGEMENTS:**

# Make-up Test:

You may apply for a make-up test if you cannot take the test on the regular test date(s) for any of the following reasons:

- 1. compulsory attendance before a public body;
- 2. on-the-job injury or illness caused by municipal employment where you are an officer or employee of the City or NYC Health + Hospitals;
- 3. absence from the test within one week after the death of a spouse, domestic partner, parent, sibling, child or child of a domestic partner where you are an officer or employee of the City or NYC Health + Hospitals:
- 4. absence due to ordered military duty;
- 5. a clear error for which the Department of Citywide Administrative Services is responsible; or
- a temporary disability, pregnancy-related, or child-birth-related condition preventing you from taking the test.

To request a make-up test, contact Administration, Customer, and Exam Support by mail at 1 Centre Street, 14th Floor, New York, NY 10007, or by email at *testingaccommodations@dcas.nyc.gov*, as soon as possible, and include documentation of the special circumstances that caused you to miss your test.

#### **ADDITIONAL INFORMATION:**

Selective Certification For Driver License (MVO): If you have a motor vehicle Driver License that is valid in the State of New York, you may be considered for appointment to positions requiring this license through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this license. Follow the instructions given to you on the day of the multiple-choice test to indicate your interest in such Selective Certification. Your Driver License will be verified by the appointing facility at the time of appointment. If you are appointed through Selective Certification, you must maintain your motor vehicle Driver License for the duration of your employment.

Selective Certification for Fire Department Certificate of Fitness (CFM): If you have a Fire Department Certificate of Fitness for Citywide Sprinkler Systems (S-12) and/or for Citywide Standpipe Systems (S-13), you may be considered for appointment to positions requiring this certificate through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this certificate. Follow the instructions given to you on the day of the multiple-choice test to indicate your interest in such Selective Certification. Your Certificate of Fitness will be checked by the appointing facility at the time of appointment. If you are appointed through Selective Certification, you must maintain your Certificate of Fitness for the duration of your employment.

Selective Certificate of Fire Department Certificate of Fitness for Torch Use of Flammable Gasses (G38): If you have a Fire Department Certificate of Fitness for Torch Use of Flammable Gasses (G-60), you may be considered for appointment to positions requiring this certificate through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this certificate. Follow the instructions given to you on the day of the multiple-choice test to indicate your interest in such Selective Certification. Your Certificate of Fitness will be checked by the appointing facility at the time of appointment. If you are appointed through Selective Certification, you must maintain your Certificate of Fitness for the duration of your employment.

The above Selective Certification requirements may be met at any time during the duration of the list. If you meet these Selective Certification requirements at some future date, please submit a request by email to: LMACustomerService@dcas.nyc.gov or by mail to: DCAS Bureau of Examinations - Exam Development Group, 1 Centre Street, 14th Floor, New York, NY 10007. Please include the examination title and number, your full name, OASys Profile ID number, and the selective certification(s) you are requesting in your correspondence.

# **Reemployment Of Public Service Retirees:**

NYC Health + Hospitals has issued rules regarding the reemployment of persons who have already retired from public service. Any such retired person is advised to consult with NYC Health + Hospitals, Human Resources, Office of Civil Service Administration (212) 788-3568 to determine whether he or she would be eligible for appointment from an eligible list established for this examination.

## **List Termination:**

The eligible list resulting from this examination will be terminated one year from the date it is established, unless extended by NYC Health + Hospitals.

**Promotion Test:** A promotion examination for this title is being held for eligible employees. The names appearing on the promotion list will be considered first in filling vacancies.

This examination is for NYC Health + Hospitals and not for all City agencies and City University of New York (CUNY). If you would like to apply for Steam Fitter with all City agencies, you must submit a separate application and fee for Exam No. 3104 from April 5, 2023 through April 25, 2023. If you would like to apply for Steam Fitter with CUNY, you must submit a separate application and fee for Exam No. 3105 from April 5, 2023 through April 25, 2023.

# **Application Receipt:**

You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folders for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification emailed to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.
