## WHAT THE JOB INVOLVES:

At Assignment Level I, Instrumentation Specialists, under general supervision, install and set-up instruments, controls and telemetering equipment and related equipment; make periodic inspections of instrumentation and metering equipment and controls and report unusual malfunctions, perform routine preventive maintenance; dismantle and reassemble equipment for corrective maintenance or for replacement in whole or in part, may work with other personnel to facilitate the repair and replacement of components; operate testing and calibrating equipment such as the following: analog and digital multimeters, frequency meters, signal simulators for resistive temperature devices, millivolt, milliamp, frequency oscilloscope and pressure transmitters, chlorine residual analyzers, pH meters, vehicle exhaust emissions analyzers, and other diagnostic equipment; install, maintain, repair and perform other servicing routines required to assure continuous radio, phone and telemetry system operations; troubleshoot and configure equipment and systems; troubleshoot and repair communications systems including, but not limited to telephone systems; troubleshoot and repair communications systems including, but not limited to telephone systems, public address systems, walkie talkies, repeaters and radio base stations; troubleshoot and repair control system equipment such as automatic chemical feed equipment, dissolved oxygen control equipment and automatic flow control devices; troubleshoot and repair fire alarm and security systems; make modifications and improvements in equipment, instrumentation and controls; read and interpret flow and wiring diagrams, plans and specifications, work on energized circuits, operating equipment and/or control systems; prepare instrumentation and control maintenance schedules and spare parts lists; act as liaison with vendors concerning replacement parts and system operation, modification and upgrading; install small piping and tubing where necessary; attend training to keep current with technology an

#### Special Working Conditions:

Instrumentation Specialists may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

Some of the physical activities performed by Instrumentation Specialists and environmental conditions experienced are: being around hazardous gases; wearing protective clothing; climbing and descending ladders and stairways; standing for long periods of time; walking to and from repair sites; bending, crouching and kneeling; working on scaffolds; lifting and carrying heavy equipment; working in confined areas; working outdoors in all kinds of weather; working in areas that have high noise levels and may be damp, dark, dusty, dirty and/or acrid; and using equipment for fecal testing.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

### THE SALARY:

The current minimum salary is \$58,615 per annum. This rate is subject to change. There are three assignment levels within this class of positions. Appointments will be made to Assignment Level I. After appointment, employees may be assigned to the higher assignment levels at the discretion of the agency.

You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive a score.

# EDUCATION AND EXPERIENCE REQUIREMENTS:

- 1. An Associate degree in electrical construction and instrumentation, electrical engineering technology, mechanical engineering technology, electromechanical engineering technology, or electronic engineering technology from an accredited college or university **and** one (1) year of full-time satisfactory experience within the last ten years in the installation, maintenance and repair of electronic instrumentation and control systems, including microprocessors, and electrical and pneumatic instrumentation and control systems; **or**
- 2. Graduation from a trade, technical or vocational school approved by a State's Department of Education or a recognized accrediting organization with a major course of study in electrical, electronic, electromechanical or mechanical technology and three (3) years of full-time satisfactory experience as described in "1" above; or
- 3. A four-year high school diploma or its educational equivalent approved by a State's Department of Education or a recognized accrediting organization **and** four (4) years of full-time satisfactory experience as described in "1" above.

College education leading to a degree in one of the areas of study described in "1" above may be substituted only in "2" or "3" above for a maximum of three years of experience at the rate of 30 semester credits for one year of full-time satisfactory experience.

# The education requirement must be met by June 30, 2024. The experience requirement must be met by the last day of the Application Period (March 26, 2024).

The high school diploma or its educational equivalent, trade school, technical school, or vocational school must be approved by a State's Department of Education or a recognized accrediting organization. The college or university must be accredited by regional, national, professional, or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education and by the Council for Higher Education Accreditation (CHEA).

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required <u>only</u> if you need credit for your foreign education in this examination. For more information see the Foreign Education Evaluation Guide in the Required Information section.

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. (number of hours worked per week/35) x (number of months worked)

# You will not receive credit for education which you obtain after June 30, 2024 or experience which you obtain after the end of the Application Period (March 26, 2024).

**Driver License Requirement**: At the time of appointment, you must possess a motor vehicle driver license valid in the State of New York. If you have moving violations, license suspension(s) or an accident record, you may be disqualified. This license must be maintained for the duration of your employment.

# **Residency Requirement Advisory:**

Under New York City Administrative Code Section 12-120, you might need to be a resident of the City of New York within 90 days of the date you are appointed to this position. Since residency requirements vary by title, appointing agency and length of service, consult the appointing agency's personnel office at the time of the appointment interview to find out if City residency is required.

# Proof of Identity:

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services.

# HOW TO APPLY:

If you believe you meet the requirements in the "How to Qualify" section, apply using the Online Application System (OASys) at *www.nyc.gov/examsforjobs*. Follow the onscreen application instructions for electronically submitting your application, payment, and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. All new OASys accounts require verification before a candidate can apply to ensure the accuracy of candidate information. Verification is instantaneous for most accounts and you will receive a confirmation email with instructions to activate your account. For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.

- 1. Application for Examination: Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. Education and Experience Exam: Follow the instructions displayed onscreen to answer the questions. You will have until midnight Eastern Time on the last day of the Application Period (March 26, 2024) to clearly specify in detail all of your relevant education, registration, and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys).

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern Time on the last day of the Application Period (March 26, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

3. Foreign Education Evaluation Guide (Required only if you need credit for your foreign education to meet the education and experience requirements): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. #### THE TEST:

Your score will be determined by an Education and Experience Exam. You will receive a score of 70 points for meeting the education and experience requirements listed above. After these requirements are met, you will receive additional credit up to a maximum of 100 points on the following basis:

If you have satisfactory full-time experience, within the last ten years, in the installation, maintenance and repair of electronic instrumentation and control systems (including microprocessors, and electrical and pneumatic instrumentation and control systems) for:	You will receive up to:
At least 6 months but less than 1 year	7.5 points
At least 1 year but less than 1 year and 6 months	15 points
At least 1 year and 6 months but less than 2 years	22.5 points
2 or more years	30 points

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

(number of hours worked per week/35) x (number of months worked)

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation:  $21/35 \times 12 = 7.2$  months.

#### Experience used to meet the minimum requirements cannot be used to gain additional credit.

You must clearly specify in detail all of your relevant experience on your Education and Experience Exam and Final Submit it by the end of the Application Period. You will not receive credit for experience which you obtain after the end of the Application Period (March 26, 2024).

You have until midnight Eastern Time on the last day of the Application Period (March 26, 2024) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern Time on the last day of the Application Period (March 26, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

Experience must be obtained by the last day of the Application Period (March 26, 2024).

#### THE TEST RESULTS:

If you pass the Education and Experience Exam, your name will be placed in final score order on an eligible list, you will be given a list number, and you will be notified by email of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

- 1. Navigate to the Dashboard for the Appeals tab.
- 2. Click the NEW APPEAL button to create and submit your appeal.

- 5. Select the reason for your appeal from the Appeal Reason drop-down list (if applicable).
- 6. Enter the details of your appeal by providing specific reasons why your score should be higher.

#### ADDITIONAL INFORMATION:

Selective Certification for Federal Communications Commission License for Radio Repairs (FCR): If you have a Federal Communications Commission License for Radio Repairs, you may be considered for appointment to positions requiring this license through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this license. If you wish to apply for this Selective Certification, follow the onscreen instructions when completing the Education and Experience Exam to indicate your interest in such Selective Certification and Final Submit it in the Online Application System (OASys). Your license will be checked by the appointing facility at the time of appointment. This license must be maintained for the duration of your

#### employment.

The above Selective Certification requirement may be met at any time during the duration of the list. You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folders for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.
