THE TEST DATE: Multiple-choice testing is expected to begin on Friday, May 24, 2024.

WHAT THE JOB INVOLVES:

Supervising Housing Groundskeepers, under supervision, serve as a working supervisor in charge of gardening and grounds maintenance work in a public housing project. They plan and supervise the work of housing caretakers and other employees engaged in gardening, tree care, and grounds maintenance; ensure that work is carried out in an efficient and effective manner and that all safety rules/regulations are followed; prepare work schedules and assignments. Supervising Housing Groundskeepers supervise the care, cleaning, and maintenance of landscaped areas, walks, driveways, parking areas, playgrounds, and fixtures thereon; train subordinates in gardening techniques, grounds maintenance, and in making minor repairs on grounds and fixtures; ensure the proper maintenance of all assigned materials, tools and equipment; prepare requisitions for material and supplies; and check repair work being performed by contractors on grounds and landscaped areas and reports on completion of work. All Supervising Housing Groundskeepers perform related work.

Special Working Conditions:

Supervising Housing Groundskeepers will be required to work various shifts including nights, Saturdays, Sundays, and holidays.

Some of the physical activities performed by Supervising Housing Groundskeepers and environmental conditions experienced are: inspecting developments in extreme weather conditions, prolonged walking to police the grounds and heavy lifting, including sand/salt delivery and the use of motorized power tools, such as backpack power blowers and power saws.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

THE SALARY:

The current minimum salary is \$43,780 per annum. This rate is subject to change.

HOW TO QUALIFY:

You may be given the test before we verify your qualifications. You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive an Admission Notice or score. (For more information see Exam Site Admission section.)

EDUCATION AND EXPERIENCE REQUIREMENTS:

A four-year high school diploma or its educational equivalent, **and** three years of satisfactory full-time gardening experience, at least one year of which must have been in a supervisory capacity.

The education requirement must be met by June 30, 2024. The experience requirement must be met by the last day of the Application Period (February 27, 2024).

The high school diploma or its educational equivalent must be approved by a State's Department of Education or a recognized accrediting organization.

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

(number of hours worked per week/35) x (number of months worked)

READ CAREFULLY AND SAVE FOR FUTURE REFERENCE

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation: $21/35 \times 12 = 7.2$ months.

You have until midnight Eastern time on the last day of the Application Period (February 27, 2024) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (February 27, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

You will not receive credit for education which you obtain after June 30, 2024 or experience which you obtain after the end of the Application Period (February 27, 2024).

Drivers License:

By the time of appointment, all candidates must possess a Motor Vehicle Driver License valid in the State of New York. If you have moving violations, license suspension(s), or an accident record, you may be disqualified. This license must be maintained for the duration of employment.

English Requirement:

You must be able to understand and be understood in English.

Proof of Identity:

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with the New York City Housing Authority.

HOW TO APPLY:

If you believe you meet the requirements in the "How to Qualify" section, apply using the Online Application System (OASys) at *www.nyc.gov/examsforjobs*. Follow the onscreen application instructions for electronically submitting your application, payment, and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. All new OASys accounts require verification before a candidate can apply to ensure the accuracy of candidate information. Verification is instantaneous for most accounts and you will receive a confirmation email with instructions to activate your account. For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.

The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets. If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. Effective January 2020, the Online Application System is no longer supported on Windows 7 or earlier versions of Windows operating systems.

You may come to the DCAS Computer-based Testing & Application Centers to apply for this examination online. However, you must schedule a customer service appointment prior to your visit. Due to the COVID-19 pandemic, DCAS no longer permits walk-ins at DCAS sites.

You will have until midnight Eastern time on the last day of the Application Period (February 27, 2024) to clearly specify in detail all of your relevant education and experience on your Education and Experience Exam and submit it in the Online Application System (OASys). If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (February 27, 2024), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.
- 3. Foreign Education Evaluation Guide (Required only if you need credit for your foreign education to meet the education and experience requirements): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. THE TEST:

The multiple-choice test will be given at a computer terminal. Your score on this test will be used to determine your place on an eligible list. You must achieve a score of at least 70% to pass this test.

The multiple-choice test is designed to assess the extent to which candidates have certain knowledge and abilities determined to be important to the performance of the tasks of a Supervising Housing Groundskeeper. Task areas to be tested are as follows: Supervision, Office Procedures, Equipment Maintenance, Grounds Maintenance, and Landscaping.

The test may include questions on landscaping, tools and equipment, standards of proper employee ethical conduct; and other related areas.

The test may also include questions requiring the use of any of the following abilities:

Analytical Thinking: Analyzing information and using logic to address specific work-related issues and problems; involves the identification of problems, not implementation of solutions. **Example**: A Supervising Housing Groundskeeper may use this ability when establishing and revising work priorities.

Attention to Detail: Being careful about detail and thorough in completing work tasks. **Example**: A Supervising Housing Groundskeeper may use this ability when inspecting assigned areas to identify any emergency or dangerous conditions.

Coaching & Mentoring: Identifying the developmental needs of others and coaching, mentoring, or otherwise helping others to improve their knowledge and skills. **Example**: A Supervising Housing Groundskeeper may use this ability when training subordinates in work procedures and equipment use.

Conflict Resolution: Negotiating with others to resolve grievances or conflicts and handle complaints by developing a constructive solution. **Example**: A Supervising Housing Groundskeeper may use this ability when conflict arises between coworkers, subordinates, or tenants.

Judgment & Decision Making: Reviewing information to develop and evaluate the relative costs and benefits of potential solutions to problems and choosing the most appropriate one; implementing a course of action determined by thinking analytically. **Example**: A Supervising Housing Groundskeeper may use this ability when identifying the best subordinates to complete specific work tasks.

Management of Material Resources: Obtaining and seeing to the appropriate use of equipment, facilities and materials needed to do certain work; managing the things needed for work to be accomplished. **Example**: A Supervising Housing Groundskeeper may use this ability when maintaining records of assigned equipment, including date and nature of last service.

Management of Personnel Resources: Motivating, developing, and directing people as they work, identifying the best people for the job; managing employees needed to accomplish tasks. **Example**: A Supervising Housing Groundskeeper may use this ability when verifying that subordinates are completing assigned work in an efficient and timely manner.

Planning & Organizing: Establishing a method of execution to accomplish a specific goal over an extended period of time; determining appropriate assignments and allocation of resources. **Example**: A Supervising Housing Groundskeeper may use this ability when delegating work assignments to certain subordinates.

Written Comprehension: Understanding the information and ideas presented in written sentences and paragraphs in work-related documents. **Example**: A Supervising Housing Groundskeeper may use this ability when addressing work tickets that have been assigned to them.

Written Expression: Appropriately communicating information and ideas in written words and sentences so intended audience will understand. **Example**: A Supervising Housing Groundskeeper may use this ability when submitting periodic Grounds Plans to the Superintendent or the Assistant Superintendent.

Certain questions may need to be answered on the basis of documents or other information supplied to the candidates on the date of the multiple-choice exam.

EXAM SITE ADMISSION:

Your Admission Notice will be available on your Dashboard in OASys 14 days before the first date on which testing is expected to begin. You can print or display your Admission Notice on your phone or personal device to gain entry to the test site. Test site assignments will take your address into consideration, but nearness to your address cannot be guaranteed.

<u>Warning</u>: After gaining entry to the test site, you are not permitted to enter the testing area with electronic devices. Electronic devices include, but are not limited to, cellular phones, smart watches, recording devices, beepers, pagers, cameras, or portable media players. You are not permitted to use any type of headphones or ear buds. Calculators and electronic devices with an alphabetic keyboard or with word processing or data recording abilities such as planners, organizers, etc. are not permitted. If you use any of these devices anywhere at any test site, whether in the testing area, restroom, hallway, or other location, at any time before, during or after the test or Protest Review Session, your test score will be nullified, you will be disqualified from taking any civil service tests for up to five years, and your application fee will not be refunded.

You are also not permitted to use on site any medical assistive devices, including those that give notifications or alerts, or that vibrate, without the prior express written authorization of DCAS. You can contact DCAS by email at: *testingaccommodations@dcas.nyc.gov*.

You may not have any other person, including children, present with you while you are being processed for or taking the test, and no one may wait for you inside of a Computer-based Testing & Application Center while you are taking the test.

<u>Required Identification</u>: You are required to bring one (1) form of valid (non-expired) signature and photo bearing identification to the test site. The name that was used to apply for the exam must match the first and last name on the photo ID. A list of acceptable identification documents is provided below. If you do not have an acceptable ID, you may be denied testing. Acceptable forms of identification (bring one) are as follows: State issued driver's license, City or State issued identification card, IDNYC, US Government issued Passport, US Government issued Military Identification Card, US Government issued Alien Registration Card, Employer ID with photo, or Student ID with photo.

Leaving: You must leave the test site once you finish the test. If you leave the test site after being fingerprinted but before finishing the test, you will not be permitted to re-enter. If you disregard this instruction and re-enter the test site, you may not receive your test results, your test score may be nullified, and your application fee will not be refunded.

THE TEST RESULTS:

If you meet the education and experience requirements and pass the multiple-choice test, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by email of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

- 1. Navigate to the Dashboard for the Appeals tab.
- 2. Click the NEW APPEAL button to create and submit your appeal.

- 6. Enter the details of your appeal by providing specific reasons why your score should be higher.

SPECIAL ARRANGEMENTS:

Make-up Test:

You may apply for a make-up test if you cannot take the test on the regular test date(s) for any of the following reasons:

- 1. being ordered to military duty; or
- 2. compulsory attendance before a court or other public body or official having the power to compel attendance: or
- 3. on-the-job injury or illness caused by municipal employment where you are an officer or employee of the City; or
- 4. absence from the test within one week after the death of a spouse, domestic partner, parent, parentin-law, sibling, child or child of a domestic partner where you are an officer or employee of the City; or 5. a clear error for which the Department of Citywide Administrative Services or the examining agency
- is responsible; or
- 6. a temporary disability; or
- 7. pregnancy, childbirth or a related medical condition

ADDITIONAL INFORMATION:

Selective Certification for Commercial Driver License (CDL): If you have a Class B Commercial Driver License with no restrictions valid in the State of New York, you may be considered for appointment to positions requiring this license through a process called Selective Certification. If you have moving violations, license suspensions, or an accident record, you may not be qualified for positions requiring this license. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this license. Follow the instructions given to you on the day of the test to indicate your interest in such Selective Certification. Your Class B Commercial Driver License will be checked by the New York City Housing Authority at the time of appointment. If you are appointed through Selective City Housing Authority at the time of appointment. If you are appointed through Selective Certification, you must maintain your Class B Commercial Driver License for the duration of your employment.

Drug/Alcohol Screening Requirement: Candidates who are considered for appointment to positions through the above Selective Certification must pass a drug/alcohol screening in order to be appointed. If appointed, you will be subject to random drug and alcohol testing for the duration of your employment.

Selective Certification for Positions Requiring Certification as a Commercial Pesticide Applicator in Selective Certification for Positions Requiring Certification as a Commercial Pesticide Applicator in Ornamentals, Shade Trees, and Turf (3A) issued by the New York State Department of Environmental Conservation (CPL): If you have certification as a Commercial Pesticide Applicator in ornamentals, shade trees, and turf (3A) issued by the New York State Department of Environmental Conservation, you may be considered for appointment to positions requiring this certification through a process called Selective Certification. Follow the instructions given to you on the day of the test to indicate your interest in such Selective Certification. Your certification will be checked by the New York City Housing Authority at the time of appointment. If you are appointed through Selective Certification, you must maintain your Certification for the duration of your employment.

The above Selective Certification requirements may be met at anytime during the duration of the list. Application Receipt:

You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folder for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.

Promotion Test: A promotion examination for this title is being held for eligible employees. The names appearing on the promotion list will be considered first in filling vacancies.

PENALTY FOR MISREPRESENTATION:

Any intentional misrepresentation on the application or examination may result in disgualification, even after appointment, and may result in criminal prosecution.
