WHAT THE JOB INVOLVES:

Emergency Medical Specialists - EMTs, under general supervision, perform tasks such as the following: provide timely, professional, pre-hospital emergency medical care/Basic Life Support (BLS) to anyone who requests/requires it; provide transportation to the appropriate medical facility; operate department vehicles; receive, prioritize and dispatch calls for emergency medical assistance; and provide patient care under the authorization of the Medical Director. All work is performed in accordance with FDNY policies and procedures and as legislatively prescribed in the requisite curriculum and allowed by Federal/New York State/Regional BLS Protocols and in accordance with the level of training, New York State designated scope of practice and New York State and Regional BLS Protocols. Emergency Medical Specialists - EMTs also prepare and submit reports as required and may be assigned to work in any FDNY facility, as needed. All Emergency Medical Specialists - EMTs perform related work.

Special Working Conditions:

Emergency Medical Specialists - EMTs may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

Some of the physical activities performed by Emergency Medical Specialists - EMTs and environmental conditions experienced are: working outdoors in all kinds of weather; climbing stairs; using such devices as stair chair or ambulance stretcher; treating patients who may have infectious and communicable diseases; working for extended periods during the day or night in ambulances; driving an ambulance in all kinds of weather; working in confined spaces such as under vehicles, trains, and buildings; working at hazardous material scenes such as a chemical spill or an industrial fire or accident; treating patients at heights such as rooftops, bridges or elevated highways; and reading a Mobile Data Terminal for call information and instructions in varying light conditions.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

THE SALARY:

The current minimum salary is \$39,386 per annum. This rate is subject to change.

HOW TO QUALIFY:

You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive a score.

As per Section 54(2) of the Civil Service Law, the education requirement needed to qualify must be met by November 25, 2026. The certification requirement needed to qualify must be met by May 31, 2026.

EDUCATION AND CERTIFICATE REQUIREMENTS:

A four-year high school diploma or its educational equivalent; and

- 1. a valid NYS Department of Health EMT Basic Certification; or
- 2. a valid NYS Department of Health EMT Paramedic Certification

The high school diploma or its educational equivalent must be approved by a State's Department of Education or a recognized accrediting organization.

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required <u>only</u> if you need credit for your foreign education in this examination. For more information see the Foreign Education Evaluation Guide in the Required Information section.

You must also possess the above certificate(s) at the time of your appointment, and they must be maintained for the duration of your employment.

You must clearly specify in detail all of your relevant education and certificate(s) on your Education and Experience Exam and submit it by the end of the Application Period.

You have until midnight Eastern time on the last day of the Application Period (November 25, 2025) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (November 25, 2025), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

REQUIREMENTS TO BE APPOINTED:

Certificate Requirements:

As stated in the "HOW TO QUALIFY" section, you must possess a valid NYS Department of Health EMT - Basic Certification or a valid NYS Department of Health EMT - Paramedic Certification by the end of the application period. You must also possess a valid NYS Department of Health EMT - Basic Certification or a valid NYS Department of Health EMT - Paramedic Certification at the time you are appointed to this position and must maintain them for the duration of your employment. You will be responsible for payment of any fees associated with the maintenance of certifications.

Driver License Requirement:

You must have a motor vehicle driver license valid in the State of New York at the time of appointment. If you have moving violations, license suspension(s) or an accident record, you may be disqualified. This license must be maintained for the duration of your employment.

Respirator Equipment Requirement:

Because you must be able to wear a NIOSH-certified respirator, you are not permitted to have facial hair that interferes with the sealing surface of the respirator and the face or interferes with the valve function of the respirator.

Medical and Psychological Assessment:

Medical and psychological guidelines have been established for the position of Emergency Medical Specialist - EMT. You will be examined to determine whether you can perform the essential functions of an Emergency Medical Specialist - EMT. Additionally, you will be expected to continue to perform the essential functions of an Emergency Medical Specialist - EMT throughout your career, and may, therefore, be medically and psychologically tested periodically throughout your career. Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable him or her to take these medical and psychological examinations, and/or to perform the essential functions of the job.

Character and Background:

In accordance with the provisions of the State Emergency Medical Services (EMS) Code - Part 800, candidates for EMS certification or recertification must not have been convicted of certain misdemeanors or felonies. The New York State Department of Health (DOH) will review all criminal convictions from any federal, military or state and/or local jurisdiction to determine if such convictions fall within the scope of those specified in Part 800, and if the applicant represents an unreasonable risk to property or the safety or welfare of patients or the public at large. In addition to this provision of the State Emergency Medical Services Code, candidates for this position are advised that good character and satisfactory background are absolute prerequisites to appointment.

Drug Screening Requirement:

You must pass a drug screening in order to be appointed. Random drug screening may be conducted for the duration of your Emergency Medical Specialist - EMT career.

Qualifying Physical Test:

Physical standards have been established for the position of Emergency Medical Specialist - EMT. You will be required to pass a qualifying physical test, and may be required to undergo periodic physical testing throughout your career.

Note: If you are presently serving as a provisional Emergency Medical Specialist - EMT with the FDNY and have previously taken and passed the qualifying physical test, you will not be required to take it again

to qualify for appointment.

Residency Requirement: City residency is not required for this position.

English Requirement: You must be able to understand and be understood in English.

Proof of Identity: Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services.

HOW TO APPLY:

Apply through the Online Application System (OASys) at www.nyc.gov/examsforjobs. Follow the onscreen instructions to submit your application and payment. A valid email address is required. Free email accounts are available from Google, Yahoo!, AOL, Outlook.com, or Mail.com.

New OASys accounts must be verified to confirm your email address is valid and that you have access to the email account. You will receive a confirmation email from OASys to confirm your account upon registering for your OASys account. If any issues arise, contact DCAS at *nyc.gov/CivilServiceNowNYC* and select the applicable subject. If you do not receive the confirmation email, check your spam or junk mail folder before contacting DCAS.

You can pay with major credit cards, bank cards, or prepaid debit cards with a credit card logo. Veterans and individuals receiving certain public assistance may qualify for a fee waiver. The DCAS Computer-based Testing & Application Centers will be closed on Monday, October 13, 2025, Tuesday, November 4, 2025, and Tuesday, November 11, 2025.

You must complete the entire application by midnight, Eastern Time, of the last day of the application period. If you have questions about applying for this examination, you may contact DCAS via nyc.gov/CivilServiceNowNYC and select the applicable subject.

REQUIRED INFORMATION:

- 1. **Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. Education and Experience Exam: Fill out all the required sections displayed onscreen (if applicable). You will have until midnight Eastern time on the last day of the Application Period (November 25, 2025) to clearly specify in detail all of your relevant education and experience on your Education and Experience Exam and submit it in the Online Application System (OASys). Note: You must list the title of EMT certificate(s) you hold, the issuing organization, date issued, certificate number and expiration date of your EMT certificate(s) in your OASys Dashboard, under Profile and License/Professional Certifications.

 If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (November 25, 2025), your examination will be considered incomplete, you may not receive a score, you may not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.
- 3. Foreign Education Evaluation Guide (Required only if you need credit for your foreign education in this examination): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Evaluation Guide which is located on the DCAS website at https://www1.nyc.gov/assets/dcas/downloads/pdf/employment/foreigneducation.pdf. When you contact the evaluation service, ask for a "document-by-document" (general) evaluation of your foreign education. You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight

weeks from the last day of the Application Period (November 25, 2025).

THE TEST:

Your score will be determined by an Education and Experience Exam. You will receive a score of 70 points for meeting the education and certificate requirements listed above. After these requirements are met, you will receive additional credit up to a maximum of 100 points on the following basis:

Experience must be obtained by the last day of the Application Period (November 25, 2025).

If you have satisfactory, full-time experience in the NYC 911 system performing emergency medical service duties after obtaining, and while holding, a valid NYS Department of Health EMT - Basic certification or a valid NYS Department of Health EMT - Paramedic certification for:	You will receive up to:

At least 3 months, but less than 6 months	5.5 points
At least 6 months but less than 9 months	8.5 points

If you have satisfactory, full-time paid experience with a government-run ambulance system <u>outside of the NYC 911 system</u> or with a private ambulance company or satisfactory full-time experience with a volunteer ambulance company performing emergency medical service duties after obtaining, and while holding, a valid NYS Department of Health EMT - Basic certification or a valid NYS Department of Health EMT - Paramedic certification for:	You will receive up to:

Emergency Vehicle Operators Course (EVOC), consistent with the 1995 National Standard Curriculum	6.5 points
24 hours of HazMat Operations Level Training, consistent with the federal OSHA regulations at 29 CFR 1910.120(q)(6)(ii)	6.5 points

EVOC and/or HazMat Training must be successfully completed by the last day of the Application Period (November 25, 2025). HazMat Training must be on the Operations Level; you will not receive credit for entry-level training.

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

(number of hours worked per week/35) x (number of months worked)

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation: $21/35 \times 12 = 7.2$ months.

You have until midnight Eastern time on the last day of the Application Period (November 25, 2025) to clearly specify in detail all of your relevant education, certificate(s), and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (November 25, 2025), your examination will be considered incomplete, you may not receive a score, you may not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

You will not receive credit for certifications/training or experience which you obtain after November 25, 2025.

THE TEST RESULTS:

If you pass the Education and Experience Exam, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by email of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

To access the appeal portal of OASys, please log into your OASys account at www.nyc.gov/examsforjobs and use the following steps:

- 1. Navigate to the Dashboard for the Appeals tab.
- 2. Click the NEW APPEAL button to create and submit your appeal.

- 5. Select the reason for your appeal from the Appeal Reason drop-down list (if applicable).
- 6. Enter the details of your appeal by providing specific reasons why your score should be higher.

ADDITIONAL INFORMATION:

Investigation:

The position is subject to investigation before appointment. At the time of investigation, you will be required to pay a fingerprint screening fee of \$102.50 (\$75.00 for DCJS, \$13.25 for FBI plus a \$14.25 service fee). At the time of investigation and at the time of appointment, you must present originals or certified copies of all required documents and proof, including but not limited to proof of date and place of birth by transcript, or other satisfactory evidence, naturalization papers, if necessary, proof of any military service, and proof of meeting educational and experiential requirements, if applicable. You may be disqualified if your statements are found to be false, exaggerated, or misleading or if you fail to provide required documents. Investigation must be completed prior to appointment.

Application Receipt:

You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folders for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.

Selective Certification for Special Experience:

If you have the experience in the areas listed below, you may be considered for appointment to positions requiring this experience through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this experience. If you wish to apply for this Selective Certification, follow the onscreen instructions when completing your Education and Experience Exam to indicate your interest in such Selective Certification and Final Submit it in the Online Application System (OASys). Your experience will be checked by the appointing agency at the time of appointment.

- 1. **AmeriCorps (AMC):** Successful completion of at least ten (10) months of satisfactory, full-time experience as a NYC Service AmeriCorps member at a City agency or non-profit organization, which includes 100+ hours of workforce preparedness trainings.
- 2. Civil Service Pathways Fellowship (FEL): Successful completion of at least one (1) year of the Civil Service Pathways Fellowship program.
- Federal Government Experience (FGE): At least one (1) year of satisfactory, full-time experience working within the federal government of the United States in a similar position.
 Municipal Government Experience (MGE): At least one (1) year of full-time satisfactory experience
- 4. Municipal Government Experience (MGE): At least one (1) year of full-time satisfactory experience working within a municipal government in a similar position, which provides services for a city with over 1 million in population.

Probationary Period:

The probationary period is 12 months. As part of the probationary period, probationers will be required to successfully complete a prescribed training course. Probationers who fail to successfully complete the training course may be terminated by the agency head. Also, you must successfully complete the Emergency Vehicle Operations Course (EVOC) prior to the completion of one year in title.

EMS Academy Assessment:

As a condition of completing EMS Academy training, you must pass multiple choice exams, quizzes, scenarios and New York State written and practical exams.

Note: If you are presently serving as a Provisional Emergency Medical Specialist - EMT with the FDNY and have previously taken and passed the written and practical tests, you will not be required to complete the EMS Academy Assessment again.

PENALTY FOR MISREPRESENTATION:

Any intentional misrepresentation on the application or examination may result in disqualification, even after appointment, and may result in criminal prosecution.

The General Examination Regulations of the Department of Citywide Administrative Services (DCAS) apply to this examination and are part of this Notice of Examination. They are posted at nyc.gov/dcas and copies are available at the DCAS Computer-based Testing & Application Centers.
