#### WHAT THE JOB INVOLVES:

Under varying levels of supervision, Marine Engineers (Uniformed - Fire Department) operate the main propulsion engines, pumping and auxiliary equipment of diesel powered vessels of the New York City Fire Department to which Marine Engineers are assigned.

At Assignment Level 1: Marine Engineers (Uniformed - Fire Department) under supervision, assist in the operation, maintenance and repair of all machinery, auxiliaries, boilers, fire pumps, deck equipment, heating and ventilating equipment on diesel powered fireboats and report any deficiency or irregularity via official department channels; under direction, conduct all required tests and inspections of machinery, pumps and auxiliaries, and assist in the recording of the results in the Engine Room Log; perform related work as directed by the Marine Engineer in charge of the watch; when necessary, may be required to assume the duties of the Marine Engineer in charge of the watch; perform assignments equivalent to those described, and all other duties prescribed for this position in the Regulations of the Department. All Marine Engineers (Uniformed - Fire Department) perform related work.

#### **Special Working Conditions:**

Marine Engineers (Uniformed - Fire Department) may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

Some of the physical activities performed by Marine Engineers (Uniformed - Fire Department) and environmental conditions experienced are: working outdoors in all kinds of weather, walking on wet decks, working in engine rooms, working around fuel tanks and oil containers, lifting items weighing up to 60 pounds, climbing stairs, standing for long periods, stooping and bending, and other physical Marine Engineer related work.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

## THE SALARY:

The current minimum salary is \$113,795 per annum. This rate is subject to change. There are two assignment levels within this class of positions. Promotions will generally be made to Assignment Level I. After promotion, employees may be assigned to the higher assignment level.

## **ELIGIBILITY TO TAKE EXAMINATION:**

This examination is open to each employee of the New York City Fire Department who **on the last day of the application period**:

- 1. holds a permanent (not provisional) competitive appointment or appears on a Preferred List (see Note, below) for the title of Firefighter and has served permanently in such title for a period of not less than three years; **or**
- 2. holds a permanent (not provisional) competitive appointment or appears on a Preferred List (see note below) for the title of Pilot, Fire Marshal (Uniformed), or Wiper (Uniformed) and has served permanently in such title for a period of not less than one year; and
- 3. is not otherwise ineligible.

(Note: A "Preferred List" is a civil service list which is only for certain former permanent employees of the eligible title who have rehiring rights.)

This examination is also open to employees who were appointed to an eligible title pursuant to New York State Civil Service Law, section 55-a, and who meet all other eligibility requirements.

If you do not know if you are eligible, check with **your agency's personnel office**. You are responsible for determining whether or not you meet the eligibility requirements for this examination prior to submitting your application. If it is determined that you are not eligible to participate in this examination, your application fee will not be refunded.

#### **CREDENTIAL REQUIREMENT:**

By the last day of the application period, you must have:

- A valid U.S. Coast Guard Merchant Mariner Credential (MMC) with endorsement as an Assistant Engineer or Chief Engineer, New York City Motor Fireboats; or
   A valid U.S. Coast Guard Merchant Mariner Credential (MMC) with endorsement as an Assistant
- 2. A valid U.S. Coast Guard Merchant Mariner Credential (MMC) with endorsement as an Assistant Engineer (Limited), Designated Duty Engineer Unlimited Horsepower, Third Assistant Engineer Unlimited Horsepower, Second Assistant Engineer Unlimited Horsepower, Chief Engineer (Limited), First Assistant Engineer Unlimited Horsepower, or Chief Engineer Unlimited Horsepower.

#### **ELIGIBILITY TO BE PROMOTED:**

In order to be eligible for promotion, you must have completed your probationary period in the eligible title as indicated in the above "Eligibility To Take Examination" section, and you must be permanently employed in the eligible title or your name must appear on a Preferred List for the eligible title at the time of promotion. Additionally, you must have served permanently in the eligible title for at least one year, unless your probationary period in that eligible title has been waived pursuant to Rule 5.2.4 of the Personnel Rules and Regulations of the City of New York.

### **REQUIREMENT(S) TO BE PROMOTED:**

At the time of promotion, eligible candidates in the title of Firefighter, Pilot, Fire Marshal (Uniformed), or Wiper (Uniformed) must meet the following qualification requirements.

**Transportation Worker Identification Credential (TWIC) Requirement**: You must possess a TWIC issued by the U.S. Transportation Security Administration by the time of promotion. If you are engaged in an appeal or waiver process for the TWIC, you will not be considered for promotion until such process has been completed.

The TWIC must be maintained for the duration of your employment.

**Medical and Drug Screening Requirement:** You will be required to meet medical and drug testing requirements as per standard United States Coast Guard licensing procedures.

## **HOW TO APPLY:**

Apply through the Online Application System (OASys) at <a href="https://www.nyc.gov/examsforjobs">www.nyc.gov/examsforjobs</a>. Follow the onscreen instructions to submit your application and payment. A valid email address is required. Free email accounts are available from Google, Yahoo!, AOL, Outlook.com, or Mail.com.

New OASys accounts must be verified to confirm your email address is valid and that you have access to the email account. You will receive a confirmation email from OASys to confirm your account upon registering for your OASys account. If any issues arise, contact DCAS at *nyc.gov/CivilServiceNowNYC* and select the applicable subject. If you do not receive the confirmation email, check your spam or junk mail folder before contacting DCAS.

You can pay with major credit cards, bank cards, or prepaid debit cards with a credit card logo. Veterans and individuals receiving certain public assistance may qualify for a fee waiver. ## **REQUIRED INFORMATION:**

- 1. **Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. Education and Experience Exam: Fill out all the required sections displayed onscreen (if applicable). You will have until midnight Eastern time on the last day of the Application Period (December 23, 2025) to clearly specify in detail all of your relevant experience and credentials on your Education and Experience Exam and submit it in the Online Application System (OASys). If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (December 23, 2025), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

#### THE TEST:

You will be given an Education and Experience Exam. Your score on this test will be used to determine your place on an eligible list. On the Education and Experience Exam, you will receive a score of 70 points for meeting the eligibility requirements listed above. After these requirements are met, you will receive additional credit up to a maximum of 100 points on the following basis:

At least 2 years, but less than 3 years	12 points

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

(number of hours worked per week/35) x (number of months worked)

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation:  $21/35 \times 12 = 7.2$ 

You will receive a maximum of one year of experience credit for each year you worked. If you have any of the above experience on a part-time basis, it will be credited according to the equivalent percent of full-time experience.

You have until midnight Eastern time on the last day of the Application Period (December 23, 2025) to clearly specify in detail all of your relevant credentials and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (December 23, 2025), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

Credentials and experience must be obtained by the last day of the Application Period (December 23, 2025).

#### CHANGE OF MAILING ADDRESS, EMAIL ADDRESS, AND/OR TELEPHONE NUMBER:

#### THE TEST RESULTS:

If you pass the Education and Experience Exam and are marked eligible, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by email of your test results. The eligible list determines the order by which candidates will be considered for promotion. If you meet all requirements and conditions, you will be considered for promotion if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

- 1. Navigate to the Dashboard for the Appeals tab.
- 2. Click the NEW APPEAL button to create and submit your appeal.
- 3. Select the exam from the Exam drop-down list, and
- 4. Select the exam part from the Exam Part drop-down list.
- 5. Select the reason for your appeal from the Appeal Reason drop-down list (if applicable).
- 6. Enter the details of your appeal by providing specific reasons why your score should be higher.

## **ADDITIONAL INFORMATION:**

**Application Receipt:** You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folders for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.

## PENALTY FOR MISREPRESENTATION:

Any intentional misrepresentation on the application or examination may result in disqualification, even after promotion, and may result in criminal prosecution.
