# 1. Introduction and Objective

At the request of JrCruz Corp. and on behalf of the New York City Department of Design and Construction (DDC), Applemon Corporation (Applemon), developed the Public Participation Plan (plan) for the Reconstruction of Brooklyn Waterfront Greenway in Brooklyn, NY (NYCDDC Project ID HWK1048D) to comply with the New York State Department of Environmental Conservation (DEC) Commissioner Policy-29, Environmental Justice and Permitting (CP-29). The purpose of the plan was to address environmental justice concerns and ensure public participation in the DEC environmental permit review process by the impacted community. This Summary Report documents the implementation and completion of all activities pursuant to the plan which had been approved by the DEC on October 29, 2021 in support of DEC Application ID: 2-6102-00682/00001, 2, (NY0277126).

# 2. Project Description

The construction site consists of existing roadway and lawn area on the sidewalks or roadside. Land use in the vicinity of the corridor is primarily characterized by commercial facilities and a few multi-family residences and municipal facilities. The construction area is comprised of the following street segments in the Sunset Park section of Brooklyn:

- 3<sup>rd</sup> Avenue from 29<sup>th</sup> Street to 19<sup>th</sup> Street (on southbound side of road)
- Hamilton Avenue from 19<sup>th</sup> Street to Smith Street
- 17<sup>th</sup> Street from Hamilton Avenue to 3<sup>rd</sup> Avenue
- Intersection of Smith Street and Lorraine Street

The corridors are approximately one mile in length. Approximately 2.5 acres will be disturbed during the construction period. The topography of the project area consists of flat surfaces associated with small hills flattened during urbanization or regarding of the area. The site elevations range approximately from 9 feet to 16 feet. The site exhibits a downward slope toward the Gowanus Canal at the end of the side streets that intercept



with 3<sup>rd</sup> Avenue and Hamilton Avenue. The project site has a relatively flat topography with slopes generally ranging from 0% to 1%.

The site is now mostly paved with asphalt and concrete. The general excavation depth for the sewers and water mains is ranging approximately from 5 to 24 feet below grade surface (ftbg) and mostly between 5 and 9 ftbg. Excavation will expose fill deposits or pass through silty sands with some gravel. Based on the topographic elevations along the corridor and the results of a previous investigation, groundwater was encountered across the site at approximately from 7 to 15 feet below grade surface.




Figure 2: Groundwater Discharge Locations and Flow Diagram






Figure 3. Project Dewatering Plan

During construction, temporary dewatering to facilitate the installation of the sewers and water mains will be required for three segments located on 3<sup>rd</sup> Avenue (see Figure 1). The pumped and treated groundwater will be directed from a temporary construction dewatering and groundwater treatment system, consisting of sedimentation, filtration and carbon adsorption via three Points of Discharge (POD1, POD2 and POD3). POD1 and POD2 will lead to the New York City Department of Environmental Protection (NYCDEP) Outfall OH-006 and Outfall OH-617 requiring a New York State Pollutant Discharge Elimination System (SPDES) permit. The SPDES permit will not be required for POD3 since the discharge leads to a combined sewer that will be treated at an off-site wastewater treatment plant. See Figures 2 and 3 for more details about the dewatering activities.

#### 3. Stakeholders and Contact List

Per New York State Department of Environmental Conservation's recommendations and in collaboration with the New York City Department of Design and Construction, a contact list of interested and affected parties was developed (see Appendix A). The list included local government and elected officials; businesses, organizations, schools, residents and occupants who live or work within a 1-2 block distance (approximately 1000 feet) of the project area. This list was used to communicate and disseminate information about the project with the affected community and stakeholders.

4. Public Outreach Activities

In order to inform the public about the current phase of the project and to address the

applicability of Commissioner Policy-29, Environmental Justice and Permitting, the

following outreach activities were planned and conducted: 1) prepared and disseminated

a fact sheet about the project; 2) prepared and circulated a public meeting

notice/invitation encouraging the affected community and stakeholders to attend an

online public meeting; 3) conducted an online public meeting. See sections 4.1, 4.2 and

4.3 for more details. Since the project is located in an area with a sizable Hispanic-

American population, the public meeting notices and fact sheets were made available and

disseminated in both English and Spanish.

Furthermore, the DDC's appointed Community Construction Liaison (CCL), Tara

Figueroa, has been located in the vicinity of construction for the duration of the

construction. The CCL has been available to the community at all times for questions,

comments and requests related to the construction of the project. The CCL could be

# 4.2 Public Meeting Notice/Invitation

Two weeks in advance of the public meeting of November 16, 2021, JrCruz mailed the public meeting notice/invitation in both English and Spanish (Appendix B) to the community organizations, elected officials, schools, media, etc. listed on the project stakeholders and contact list (Appendix A). The public meeting notices (both English and Spanish) were also posted in some public areas visible to the community and/or hand delivered by the CCL throughout the construction site (see Appendix D). The public meeting notice (Appendix B) was also published on November 5, 2021 in the print edition of Courier Life (see Appendix D), a local paper distributed widely throughout the community. ### 4.3 Public Meeting

In collaboration and coordination with NYCDDC, JrCruz Corp., and the Office of Resident Engineer, Applemon Corporation facilitated and presented a public informational tele/videoconference meeting on Tuesday November 16, 2021 at 6:00 pm

At the public tele/videoconference meeting, representatives from NYCDDC, JrCruz Corp., Office of Resident Engineer and Applemon Corporation presented an overview of the construction project, project background, scope of dewatering work, community impact, SPDES permit application, and contact information. Fuad Adib of Applemon Corporation was the lead speaker at the meeting who explained the reason for dewatering, SPDES permit process, and how the impact of dewatering can be monitored. Ten people attended the meeting. Please see Appendix E for a recorded list of attendees and participants.

An in-meeting chat line was available throughout the meeting so the attendees could submit their questions and concerns during the meeting. There was also a dedicated Q&A



section at the end of the meeting for public questions, comments and concerns. No concerns or comments were raised about the project and its proposed dewatering activities during the public meeting. Only one attendee with late appearance had a couple of general questions about the meaning and location of dewatering. Applemon responded to the questions pointing out to the project dewatering location (Figure 1) where three separate excavation dewatering trenches will be needed on 3<sup>rd</sup> Avenue to manage groundwater during the sewer construction. The CCL also responded to these questions through the in-meeting chat and provided her contact information as well (see Appendix E for a copy of the meeting chat). Furthermore, attendees were informed of how they may submit formal comments on the permit application to the NYSDEC and obtain answers to questions after the meeting has concluded. Since the public meeting, DDC and contractor have not received any additional substantive concerns, questions or issues about the dewatering.

# 5. Document Repository

An online document repository has been established for the community to access and review information about the project. 

**Figure 1. Project Dewatering Locations**

# **Fact Sheet**

What is the Proposed Project? The Proposed Project will: improve approximately one mile of streets and sidewalk to current New York City Department of Transportation (NYCDOT) standards; install a new drainage collection system; and upgrade and replace existing sanitary sewers and water mains. To implement the proposed project, the New York City Department of Design and Construction (NYCDDC) has submitted an application to the New York State Department of Environmental Conservation (NYSDEC) for dewatering and groundwater pumping operations, which requires a New York State Pollutant Discharge Elimination System (SPDES) permit. This permit is to construct the Brooklyn Waterfront Greenway Infrastructure Upgrades (NYCDDC Project ID: HWK1048D) on 3<sup>rd</sup> Avenue/Hamilton Avenue and surrounding area, Brooklyn. A Public Participation Plan has been developed in accordance with NYSDEC Commissioner Policy 29, Environmental Justice and Permitting (CP-29). The purpose of this fact sheet is to inform the public about the project and to involve the community during the SPDES permit application review process.

Why does NYCDDC need to upgrade the infrastructure in Brooklyn Neighborhood? The existing infrastructure is old and insufficient. This project will provide much needed street drainage for the Proposed Project Area. The reconstructed streets and new infrastructure will improve vehicular and pedestrian conditions, while reducing the potential for future flooding impacts and will support neighborhood resiliency with respect to coastal storms, while providing enhanced infrastructure that will support post-storm recovery efforts.

How might the upgrades affect the surrounding community? Community impacts will be temporary in nature and all related to construction. NYCDDC and its contractors propose to control all dust, rodent, noise and vibration during the construction period. NYCDDC will be available to answer all questions for any issues related to special needs access, service delivery coordination (e.g. trash collection), and any property damage. Water service interruptions will only be during the day, and advance notice will be provided to all affected homeowners. Traffic impacts are expected during construction; however, NYCDDC will take all the necessary measures to minimize disruptions to property access, schools, as well as access to transportation facilities, community facilities, and emergency services.






