1. Introduction and Objective

At the request of HUICATAO Corp. and on behalf of the New York City Department of Design and Construction (DDC), Applemon Corporation (Applemon), developed the Public Participation Plan (plan) for the Construction of Storm and Sanitary Sewers and Appurtenances in Willow Avenue in the Borough of Staten Island, New York (Project ID SER20079) to comply with the New York State Department of Environmental Conservation (DEC) Commissioner Policy-29, Environmental Justice and Permitting (CP-29). The purpose of the plan was to address environmental justice concerns and ensure public participation in the DEC environmental permit review process by the impacted community. This Summary Report documents the implementation and completion of all activities pursuant to the plan which had been approved by the DEC on March 28, 2022 in support of DEC Application ID: 2-6404-01570/00002.

2. Project Description

The construction site consists of existing roadway and lawn area on the sidewalks or roadside. Land use in the vicinity of the corridor is primarily characterized by commercial properties. The properties beyond the immediate vicinity of the corridor are mostly used for residential or commercial purposes. The construction area is comprised of Willow Avenue between Tompkins Avenue and Bay Street in the Rosebank section of Staten Island, NY.

The project site is approximately 1,500 feet in length. The topography of the project area consists of flat surfaces associated with small hills flattened during urbanization or regarding of the area. The site elevations range approximately from 4 feet to 25 feet. Under natural conditions, surface runoff would be expected to follow the overall topography of the area and ultimately discharge into Upper New York Bay, the closest water body.



The site is now mostly paved with asphalt and concrete. The general excavation depth for the sewers and water mains is ranging approximately from 3 to 14 feet below grade surface (ftbg). Excavation will expose fill deposits or pass through silty sands and clay with some gravel. Based on the topographic elevations along the corridor and the results of a previous investigation, groundwater was encountered across the site at approximately from 1.5 to 3 feet below grade surface.

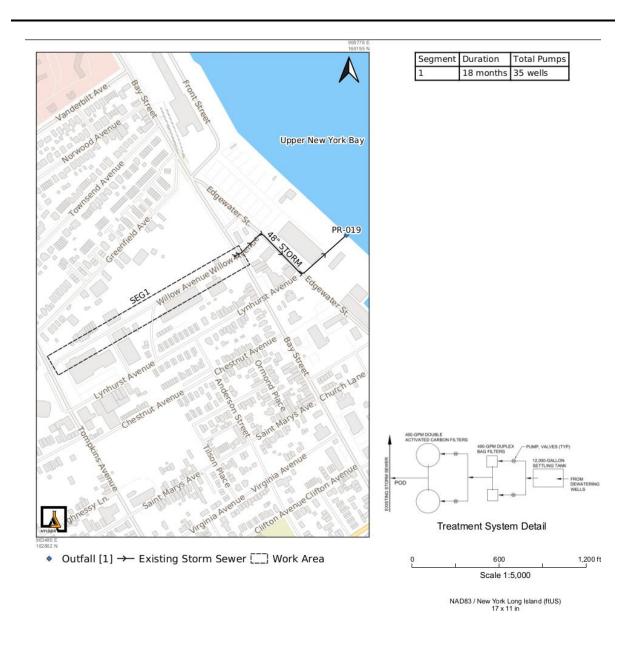


Figure 1. Project Dewatering Location

As shown on Figure 1, temporary dewatering to facilitate the installation of the sewers and water mains will be required during construction. The pumped and treated groundwater will be directed from a temporary construction dewatering and groundwater treatment system, consisting of a settling tank and activated carbon filtration system via one Point of Discharge (POD1). POD1 will lead to the New York City Department of Environmental Protection (NYCDEP) Outfall PR-019 requiring a New York State Pollutant Discharge Elimination System (SPDES) permit.

3. Stakeholders and Contact List

Per New York State Department of Environmental Conservation's recommendations and in collaboration with the New York City Department of Design and Construction, a contact list of interested and affected parties was developed (see Appendix A). The list included local government and elected officials; businesses, organizations, schools, residents and occupants who live or work within a 1-2 block distance (approximately 500 feet) of the project area. This list was used to communicate and disseminate information about the project with the affected community and stakeholders.

4. Public Outreach Activities

In order to inform the public about the current phase of the project and to address the applicability of Commissioner Policy-29, Environmental Justice and Permitting, the following outreach activities were planned and conducted: 1) prepared and disseminated

a fact sheet about the project; 2) prepared and circulated a public meeting notice/invitation encouraging the affected community and stakeholders to attend an online public meeting; 3) conducted an online public meeting. See sections 4.1, 4.2 and 4.3 for more details. Since the project is located in an area with a sizable Hispanic-American population, the public meeting notices and fact sheets were made available and disseminated in both English and Spanish.

Furthermore, the DDC's appointed Community Construction Liaison (CCL), Jeffrey Carlson, has been located in the vicinity of construction for the duration of the construction. The CCL has been available to the community at all times for questions, comments and requests related to the construction of the project. 4.2 Public Meeting Notice/Invitation

As shown in Appendix D, two weeks in advance of the public meeting of April 14, 2022, HUICATAO Corp. mailed the public meeting notice/invitation (Appendix B) to the entire list of stakeholders and contact list (Appendix A). The public meeting notices (both English and Spanish) were also hand delivered by the CCL throughout the construction site (see Appendix D). The public meeting notice was also published on March 30, 2022 in the print edition of Staten Island Advance (see Appendix D), a daily newspaper



circulated in Staten Island. Additionally, the public meeting notice has been available in the online repository via the following website:

4.3 Public Meeting

In collaboration and coordination with NYCDDC, HUICATAO Corp., and the Office of Resident Engineer, Applemon Corporation facilitated and presented a public informational tele/videoconference meeting on Thursday April 14 at 6:00 pm

At the public tele/videoconference meeting, representatives from NYCDDC, HUICATAO Corp., Office of Resident Engineer and Applemon Corporation presented an overview of the construction project, project background, scope of dewatering work, community impact, SPDES permit application, and contact information. Dara Adib of Applemon Corporation was the lead presenter at the meeting who explained the reason for dewatering, SPDES permit process, and how the impact of dewatering can be monitored. Twelve people attended the meeting. Please see Appendix E for a recorded list of attendees and a screenshot of the online meeting.

An in-meeting chat line was available throughout the meeting so the attendees could submit their questions and concerns during the meeting. There was also a dedicated Q&A section at the end of the meeting for public questions, comments and concerns. Attendees raised several questions during the Q&A section but all questions were mainly about the construction schedule, barricading and covering open trenches after excavation, shutoffs of the utilities, traffic and rodent control, connecting private storm system to the newly built NYCDEP storm sewers, closing roads during business hours, and the impact of dewatering operation on the foundation of the existing nearby structures. The DDC construction team, project RE, CCL and Applemon responded to these questions and encouraged the attendees to contact the CCL for any additional questions about the



construction. No substantive concerns, questions or issues about the dewatering activities and permit application were raised.

The CCL's contact information was announced throughout the meeting repeatedly. Furthermore, attendees were informed of how they may submit formal comments on the permit application to the NYSDEC and obtain answers to questions after the meeting has concluded.

5. Document Repository

An online document repository has been established for the community to access and review information about the project. The established online repository available at the https://www1.nyc.gov/site/ddc/contracts/public-participation-plan.page provides information and documents relating to the project and the SPDES permit application such as public notices and fact sheets related to the plan, as well as the draft SPDES permit and statement of basis, and the Notice of Complete Application once provided by the NYSDEC. NYCDDC continues maintaining the online repository.



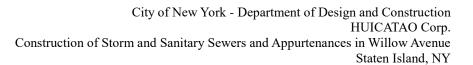

Fact Sheet

What is the Proposed Project? The Proposed Project will: improve approximately 1,500 feet of streets and sidewalk to current New York City Department of Transportation (NYCDOT) standards; install a new drainage collection system; and upgrade and replace existing sanitary sewers and water mains. To implement the proposed project, the New York City Department of Design and Construction (NYCDDC) has submitted an application to the New York State Department of Environmental Conservation (NYSDEC) for dewatering and groundwater pumping operations, which requires a New York State Pollutant Discharge Elimination System (SPDES) permit. This permit is to construct the Storm and Sanitary Sewers in Willow Avenue, Staten Island (NYCDDC Project ID SER20079). A Public Participation Plan has been developed in accordance with NYSDEC Commissioner Policy 29, Environmental Justice and Permitting (CP-29). The purpose of this fact sheet is to inform the public about the project and to involve the community during the SPDES permit application review process.

Why does NYCDDC need to upgrade the infrastructure in Staten Island Willow Avenue? The existing infrastructure is old and insufficient. This project will provide much needed street drainage for the Proposed Project Area. 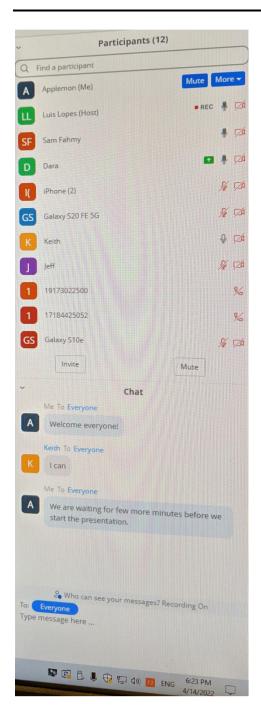
