Pre-Qualification Process



- All new bidders must submit pre-qualification forms through C2M Pre-Qualification. This process will take about 2 months. Includes the following documentation:
 - a) Financial Statements for company stability
 - b) Safety Records
 - c) Detailed list of Capabilities
 - d) Past Projects
 - e) Client References
- All workers must be paid according to the LL220 Prevailing Wage Schedule
- PLA Requirements
- All firms must submit an RFAS package to be approved by NYC DDC prior to official award
 - a) Registration on PASSPort System
 - b) PLA Letter of Assent,
 - c) Certificate of Registration with NYS DOL, etc.


