



Local Law 53 Annual Report Calendar Year 2022

This report details the number of noise inspections, with a focus on the number of noise complaints received by the Department of Environmental Protection (DEP) related to after-hours noise complaints and response time to those complaints as well as the number of summonses issued.

The answers below describe the status of the DEP’s implementation of the law and respond to the specific questions posed in the legislation.

1. What is the number of inspectors employed by the department?

There are 71 Air and Noise Inspectors.

3. What is the number of after-hours noise complaints responded to within the amount of time prescribed by rule as well as the number of duplicative after-hours noise complaints?

There were 4,447 duplicative after-hours noise complaints. All after-hours noise complaints follow the prescribed protocol contained in the attached rule.

4. What is the number of non-violation resolution to complaints?

Out of the 48,459 complaints, there were 595 summonses issued in CY 2022.

5. What is the number of noise related violations issued for after-hours complaints?

For after-hours, 123 summonses were issued.
