- Controlling and disposal of nearly 1 acre of phragmites and other invasive shoreline vegetation
- Controlling and disposal of water chestnut and other invasive floating aquatics within the lake
- NYSDEC and USACE Wetland Applications Submitted & Permits Received
- Contract Registered Steven Dubner Landscaping, Inc.
- Will include additional scope for floatable boom installation
- Work Scheduled to begin late spring/early summer 2024
- Total Cost: \$1.5M

# **CSX Acquisition Update**

- January 18, 2023: Purchase and Sale Agreement (PSA) Signed the City and CSX must follow the procedural steps established in the PSA:
  - April 11, 2023: CSX filed the Notice of Exemption to abandon the premises to the Surface Transportation Board (STB)
  - May 11, 2023: City request that the STB issue a Notice of Interim Trail Use (NITU)
  - May 26, 2023: STB approved the trail use agreement
  - CSX and DEP are working to finalize all requirements during the Due **Diligence** period
- August 2024: Closing for the City to acquire the property
