RESOLVED That the Design Commission, having considered designs for the reconstruction of Third Street Playground, Prospect Park, Prospect Park West between 3rd Street and 4th Street, adjacent to West Drive, Brooklyn, submitted by the Department of Parks & Recreation and the Prospect Park Alliance, represented by exhibits 3978-N, O, P, Q & R of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that the team will (1) expand the paved area beneath the benches to provide clear circulation around the mounds, ensuring users don't need to walk on the turf; (2) restudy the circulation to the west of the swings to allow users to access the benches comfortably, without interfering with children at play; and (3) simplify the design of the wooden deck to better integrate with the overall site geometry and facilitate easier construction.

RESOLVED That the Design Commission, having considered designs for the reconstruction of Harding Park, Bolton Avenue and Gildersleeve Avenue, Bronx, submitted by the Department of Parks & Recreation, represented by exhibits 5788-F, G, H, I & J of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that the team will (1) provide seating areas for larger group gatherings; (2) consider installing edging around the garden beds or signage to clearly delineate the landscape areas and pathways, preserve the woodlands, and prevent users from creating desire paths, particularly in the northern parcel; (3) provide a site horticulture maintenance strategy to ensure the eradication of the invasive plant species, ideally before construction begins; (4) consider a design for the basketball court paving that reflects the local culture; and (5) consider installing non-mechanical sound elements into the play equipment that mimic the sound of coqui frogs. The Commission commended the project, appreciating its strong site design that seamlessly connects various activities, while preserving the existing woodlands. Commissioners also appreciated the team's collaboration with local communities to incorporate cultural elements into the playground that are both inclusive and playful.
