RESOLVED That the Design Commission, having considered designs for the rehabilitation of two structures and construction of a two-story addition and adjacent site work, Pier 92 and Pier 94, Route 9A from West 52nd Street to West 55th Street at the Hudson River, Manhattan, submitted by the Economic Development Corporation, represented by exhibits 6696-Y, Z & AA, of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that (1) the Midtown Piers sign, which competes with the banners creating visual clutter, will be restudied, ideally eliminating the logo, running the text vertically, and relocating the sign, perhaps orienting it perpendicular to the east façade or moving it to the north elevation; (2) since it is difficult to determine the banner configurations in advance, because so much of their success is dependent on the quality of the graphic, a qualified graphic design firm, such as TwoTwelve, will be designated to make that determination, but under no circumstances should it be determined by the client(s); (3) the graphic designer will continue to study further breaking up the checkerboard, which was the most successful pattern with the negative space functioning as the unifying element; and (4) this information will be provided for committee review prior to submitting the project for final.



RESOLVED That the Design Commission, having considered designs for a prototypical bicycle rack, CityRacks Competition, for installation citywide, submitted by the Department of Transportation, represented by exhibits 6816-AI & AJ of record in this matter, hereby gives to the same final approval with the understanding that the Department of Transportation confirmed that (1) the bottom of the wheel will not exceed 1" from grade; (2) the jury was made aware of and is comfortable with the proposed material change from stainless steel to galvanized ductile iron, understanding the budgetary implications of stainless steel and finding the iron a suitable alternative; (3) it will ensure proper quality control in the application of the galvanizing, finishing, handling, packaging, storage and installation of the racks; and (4) a minimum six-month pilot study of roughly 100 racks (the exact number will be determined based upon receipt of bids for a small purchase order to be placed within one week) will be conducted to test the galvanized ductile iron finish and any maintenance methodologies, and it will submit photographs documenting the findings for committee review and approval before placing the larger order.
