



RESOLVED That the Design Commission, having considered designs for the reconstruction of Pier 15 as part of Phase II, East River Waterfront, Wall Street to Rutgers Slip, Manhattan, submitted by the Department of City Planning, the Economic Development Corporation and the Department of Small Business Services, represented by exhibits 5467-BJ, BK, BL & BM of record in this matter, hereby gives to the same unanimous final approval subject to (1) the resolution of the color of the underside of the upper level deck, which should extend through the pavilions to avoid looking like applied decoration; (2) reviewing the woodland plant list for the open area in the south to ensure it can take the blistering sun; (3) restudying the third area that is treated as a roof, but is not; and (4) the submission of drawings and other materials revised in response to the conditions noted above within one month, given the project's schedule. The commission commends the design, but expresses concern that, given the project schedule described at the meeting, this project was not submitted for review earlier, particularly since there was a significant change to the design that was approved at preliminary.
