



Cohan statue will be used; (2) the existing planters around the Cohan statue will be removed; (3) the alternate bollard alignment on block 42-43 at the NYPD building and on block 44-45 between the bench and the curb will be used; (4) the walls will be solid granite, as drawn, to match the benches; (5) the bollard sleeves will be custom, so the foldables and removables will match; and (6) bollard prototypes will be developed for review and approval by the committee prior to fabrication. While the Commission appreciates that an expert design advisory committee was convened to develop this proposal, which successfully retrofits the previously approved plaza design, it notes that security should have been addressed as part of the original scope, so it could have been more fully integrated into the design of this significant public space.
