

I will get right to the point. Your group didn't adhere to your own, or the NYC Charter, districting requirements in the newly drawn draft. See CD 4 & 5 specifically. It breaks up our communities, small businesses, and schools. This is akin to comparing Peoria, IL to Manhattan.

- 1. Keep neighborhoods and communities intact

 - The districting committee flatly ignored your own requirements and the NYC charter requirements for CD 4 & 5. In February of 2021, I moved from the UWS to the UES specifically to live in CD5.
 - Moving the hospitals to CD26 with Queens is also not in keeping with the district committee requirements & NYC charter.
 - Moving CD5 means having the actual East River in the middle of the district.
 - None of the above is keeping the neighborhoods intact, doesn't keep districts compact, doesn't limit crossover
 districts, doesn't avoid splitting voters of the same political party for purposes of diminishing effective
 representation of such voters
 - AND definitely does NOT avoid oddly shaped districts

Each community has their own identity (two examples congestion pricing and the 210 foot maximum building height in Manhattan - EULAR).

The UES has nothing in common with Queens. Not only do we lose our identity, but also appropriate representation. The hospitals are also part of our identity on the UES and have been part of our district for decades, if not generations. You are also proposing to separate the hospitals from the healthcare provider offices which would be in a different CD. Further, we lose the ability to govern what happens with hospitals just a block away from where we live.

As well, PS 158 & 217 will be negatively impacted being on the UES joining CD26 in Queens where again there are completely different needs of children in each of the neighborhoods.

Have you considered what happens to the parks and waterfront on the Eastside? How does this make any sense for these locations on the UES being governed by Queens?

Is the Queens representative going to go to the Manhattan borough president for needs when they split us up? How will the budget be fairly distributed e.g. participatory budgeting when the UES would only make up 27% of CD26? And logistically, will representatives have offices in both Queens and the UES? If you only care about money, this makes no sense financially.

Moreover, you upend the community boards, e.g. Community Board 8 would encompass three districts.

CD5 has nothing in common with CD26 and has completely different needs and issues. Moving CD5 to CD26 means that we will not have appropriate representation for our neighborhoods.

Finally, I envision that this will greatly disenfranchise voters, where NYC has notoriously low turnout for local elections. I fear it will be even worse if the district lines move forward as proposed.

None of this makes ANY sense.

I urge you to revisit the district lines for CD 4 & 5 and keep our communities intact per your committee and NYC Charter requirements.

As a resident of Roosevelt Island for over a decade, I'm writing to express my concern over and disagreement with the proposed redistricting of Roosevelt Island, moving it from Manhattan District 5 to Queens District 26.

Among the reasons I believe this to not be in the best interest of residents of Roosevelt Island are both property value and property taxes. Residents pay property taxes in Manhattan, and after years and years of waiting, many residents have finally been able to purchase their apartments, at prices which were certainly in part based on the buildings being in Manhattan. Should residents choose to sell at some point, for better or worse being part of the Manhattan district certainly fetches a better sale price, an understandable concern given that purchases were made with the district being part of Manhattan.

Another reason I'm opposed to the redistricting is that it would essentially be a type of reverse-gerrymandering, forced gentrification of District 26. While Roosevelt Island is quite diverse in population, in general the socioeconomic status of residents is largely different than that of District 26, and adding this population to that one would greatly change the face of that district, creating a possibly louder voice in local politics that doesn't quite represent the district as a whole. To whom it may concern,

Last Friday I was made aware of new maps that have been proposed for my council district, Council 5. I have lived on the Upper East Side for over 30 years. As long-term residents of this neighborhood, my husband and I have well-established ties of common interest and association. Our apartment is on East 73rd Street, just east of 1st Ave. If this proposed map is approved, our block would become the western edge of a district in Queens that is utterly unfamiliar to us. This makes no sense!

The proposed map breaking apart the UES is in clear violation of the New York City Charter. "A district shall not cross borough or county boundaries." How exactly would this work? Would my new CM open a second office in Manhattan? I don't know Queens terribly well, but what I do know, is that things are spread out and getting around in Queens is much easier if you have a car. I do not own a car.

I am a volunteer gardener with the Upper Greenside Association and a NY City Parks Department Tree Steward. The Upper Greenside has received funding from Council 5 in previous years. I help take care of trees and tree islands on First Avenue that are along the bike lane. I volunteer to help beautify the Upper East Side because I have a stake in my neighborhood. The new map would put my neighborhood volunteer work in a different neighborhood than the one I live in, even though it is literally just on the other side of First Avenue. My husband, a musician, regularly performes at the UES's most famous museum, and he programs one of their weekly music programs. He volunteers with me in tree care, and he frequently works as an Election Poll Worker on the UES because he also has a stake in our neighborhood, our community.

I strongly feel that our votes in a Queens district would be diluted and disenfranchised, especially when it comes to participatory budgeting. I can't envision a CM based in Queens making faraway blocks in Manhattan a priority for the allocation of resources. Quite frankly, I don't know why a district in Queens would want to take on the governance of neighborhood blocks in Manhattan or Roosevelt Island. Would Queens Council 26 want to take on the challenge of funding the renovations to our East River Esplanade? Would a Queens district be actively engaged with the senior citizens on the UES that rely on the John Jay Park and outdoor pool for exercise and socializing? I can't fathom that the iconic hospitals of the UES's hospital row would no longer be governed by the UES.

Lastly, I strongly believe that we should have a say in what happens on the UES, because we live on the UES. The blocks between 1st Avenue and York Avenue are where the least affluent residents of the UES are concentrated. By Cleaving these blocks from the UES, and dumping them on Queens, you are further consolidating wealth in Council 5.

How would this redistricting effect building height zoning laws for my block and neighboring blocks? What would be the impact on garbage collection, recycling, composting, rat abatement? Where would we go to vote? And what happens to the schools? I don't think the ramifications of this redistricting have not been thought out. I ask that you do not approve the redistricting map that would put the eastern edge of the UES and Rosevelt Island in to Queens Council 26.


