Good day Chair Walcott,

The plan presented for 54 blocks of the Upper East Side and Roosevelt Island is not acceptable to the residents of the East Sixties. We believe it violates the charter requirements of keeping neighborhoods compact and intact. This plan would make CD26 an oddly shaped district with practical difficulties: they are - would the Council Member have a district office in Manhattan as well as on Roosevelt Island; would the Council Member cover Community Board meetings in Board 8 & 6 and have full membership on both Borough Boards, and finally we believe this part of Community District 8 would have a diminution of representation. While other Districts have physical boundaries in more than one borough, they are directly adjacent to one another. They do not have a river separating them as in this proposed plan. The issues in CD26 are not the same as in CD5. And there are several well-established neighborhood associations whose membership would be torn asunder.

The issues that involve City Agencies such as Transportation, Sanitation, Parks etc. are different in the two council districts. Then there are two other major issues that would tear our community apart. The first is the hospital corridor with their buildings for the major institutions many of which would be in CD26 under the new plan. But many of their offices and allied buildings and staff and doctors would be located in/or live in CD5 making it difficult for discussing issues constantly arising. Not to mention the effect on "bench to bed" translational medicine research. The second is Community District 8 ranks 47th out of 59 Districts for the least amount of park space in the city. This plan would remove: from CD 5 24 Sycamores Park; ¾ of Honey Locust Park—with ¼ remaining in D5; most of our East River Esplanade and Andrew Haswell Green Park Phase 1 & 2A—2B is under construction at this time. Phase 3 has not yet started and will likely cost \$25 Million dollars to complete. Will a Council Member in CD26 spend that kind of money for an area that represents only 27% of the voters in her/his District? Most of the funding will probably be spent in the Queens part of the district.

We strongly recommend that you study and implement Community Board 8's resolution and plan, as it takes into account the number of residents in all the adjourning districts.

Our Neighborhood Association depends greatly on our Council Member and her office staff, which is easy to reach by a short bus ride. I strongly urge the New York City Districting Commission to reconsider this ill-conceived plan and not divide an indivisible and cohesive neighborhood.

Re: Queens Redistricting Feedback, Districts 24 & 27

Dear NYC Districting Commission:

I write to comment on the preliminary map for NYC Council Districts. If implemented as now envisioned, it appears that the downtown Jamaica shopping corridor—Jamaica Avenue, from Sutphin Boulevard to 169th Street, plus relevant cross streets—would be entirely eliminated from District 27 and reallocated to District 24. Currently, the corridor is represented by District 27 as well as District 24.

I believe that the districting commission has a responsibility to consider two crucial issues regarding these deeply problematic proposed boundaries. The first relates to safety and quality of life. The second relates to economic development, shopping boundaries and target markets.

Safety and Quality of Life

One of the top issues consistently raised to the Jamaica Center Business Improvement District by our merchants, property owners, local employees and shoppers is <u>safety and quality of life</u>, such as drug dealing, open-air drug use, harassment against merchants, vandalism, dangerous driving conditions, homeless encampments, and gun violence. The downtown Jamaica shopping corridor is represented by the 103rd Precinct, which mostly covers Council District 27's boundaries. Yet many of these issues are shared with the 113th precinct, too, which lies just south of the 103rd and also falls within District 27's boundaries. It is not uncommon for perpetrators to operate within the boundaries of both precincts, which means cross-pollination of information, pattern recognition, resource sharing, and other types of referrals and support is ongoing and crucial between the precincts, District 27's offices and our BID.

By contrast, much of District 24 is represented by the 107th Precinct. If the proposed redistricting goes through, District 24 will contain a slice, but not all, of the 103rd. The issues affecting the 107th are very different from those occurring in the neighborhoods that fall within the 103rd and 113th. Those safety and quality of life that affect the downtown Jamaica shopping corridor could, and most likely will, be watered down by the volume of constituent calls and reports directed to District 24 from the much larger boundaries of the 107th. Those pervasive and dangerous issues specific to the downtown Jamaica shopping environment and also occurring in South Jamaica won't rise to the top—not because District 24 wouldn't be concerned, but because police data and constituent calls will go to two different Council districts. This will distort these ongoing issues and we are absolutely certain that our BID, the NYPD and all of our local Council offices (that is, both District 24 and District 27) will inevitably become slower to identify patterns and problems, stifling the ability to rapidly and effectively address them. The proposed redistricting is an unmistakable recipe for a lack of coordination—for

those at the helm of the Council Districts, for our BID, for our businesses, for our precincts, and for our fellow citizens.


Indeed, while Council Districts do not supervise the precincts, they do have an intimate, bird's eye view of the issues in their districts; they serve as lynchpins and catalysts for coordination, issue awareness and resource allocation. The redistricting will achieve the opposite.

Most importantly, the Jamaica Task Force, which is an intergovernmental and neighborhood stakeholder group created to address safety and quality of life issues to improve the downtown Jamaica shopping corridor is cochaired by District 27 and the Borough President's Office. Much work has already been accomplished on this to date with many transformative projects "in-progress". Removing downtown completely from District 27 will stymie what has been a transformative collaboration for this community.

Economic Development

Shopping corridors are organic clusters of commerce defined by both physical and cultural boundaries. Downtown Jamaica, specifically Jamaica Avenue, is the natural shopping destination for residents of Jamaica, Rochdale, Laurelton, Springfield Gardens, Rosedale, St. Albans, Cambria Heights and Hollis. The Downtown Jamaica shopping corridor attracts residents through key routes, such as Merrick, Liberty and Guy Brewer boulevards, and through public transportation, walking routes, dollar-van routes, and more. By contrast, the Grand Central Parkway acts as a hard barrier that redirects a great majority of District 24 shoppers away from downtown Jamaica and toward other, more convenient shopping areas.

In our organization's recent shopper retail survey, 51% of respondents stated they were from South Jamaica—a neighborhood squarely inside District 27. This matters because Council Members hear from residents, local employees, and local entrepreneurs when they're unhappy with their shopping options or business conditions. Further, Council members are approached by national retailers when they consider opening in certain neighborhoods to serve certain populations. Further still, local churches, schools and civic groups expect Council members to connect their community to jobs and opportunities. To radically reconfigure District 27 to remove downtown Jamaica will stunt the community's ongoing efforts to work together on retail improvement and retail attraction, on retail retention, on support and growth of local neighborhood-owned businesses and workforce. Key connections, synergy and patterns will be missed.

Consider, too, that York College is one of downtown Jamaica's indispensable stakeholders. Its campus is still growing, drawing more students and employees to the area's commercial corridor—and for which York's Small Business Development Center is providing critical, free support to local businesses. Next year, the new soccer stadium at York will be built, delivering an influx of sports and entertainment fans to downtown Jamaica as well. And while this is all coming along, York's administrators are coordinating with our BID to address many

of the safety and quality of life issues cited earlier, plus such other social ills as illegal dumping and inappropriate pedestrian space infrastructure at the boundary of the York campus and downtown Jamaica.

The synergy of "town and gown"—the interplay between shopping corridors and universities—has already been well researched. Yet the proposed redistricting will wrest York from downtown Jamaica—akin to slicing the Apple anchor store away from the rest of a shopping center. The redistricting will force York and our BID to coordinate Council offices and precincts to tackle the safety and quality of life issues mentioned earlier in this letter. It will make opportunities for area beautification immeasurably harder.

I believe that District 27 must remain a prominent player in the commercial corridor of downtown Jamaica and that total removal of District 27 from downtown will cause irreparable harm to, and incalculable problems for, the businesses of our BID. I urge you, the members of the commission, to reconsider your position on this matter.


