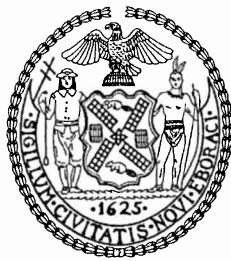

# **METES & BOUNDS**

## **First District**

New York City Council District 1 consists of both:

(1) all of that portion of New York County bounded and described as follows: Beginning at the point of intersection of West 8th Street and 6th Avenue, and proceeding easterly along West 8th Street to East 8th Street, and proceeding easterly along East 8th Street to Broadway, and proceeding southerly along Broadway to East 4th Street, and proceeding easterly along East 4th Street to Bowery, and proceeding southerly along Bowery to East Houston Street, and proceeding easterly along East Houston Street to Norfolk Street, and proceeding southerly along Norfolk Street to Stanton Street, and proceeding easterly along Stanton Street to Ridge Street, and proceeding southerly along Ridge Street to Rivington Street, and proceeding easterly along Rivington Street to Pitt Street, and proceeding southerly along Pitt Street to Williamsburg Bridge, and proceeding easterly along Williamsburg Bridge to FDR Drive, and proceeding southerly along FDR Drive to Grand Street, and proceeding westerly along Grand Street to Henry Street, and proceeding westerly along Henry Street to Gouverneur Street, and proceeding southerly along Gouverneur Street to Water Street, and proceeding easterly along Water Street to Jackson Street, and proceeding southerly along Jackson Street to South Street, and proceeding westerly along South Street to Montgomery Street, and proceeding southerly to a line extended southerly to the Kings/New York County line, and proceeding westerly along the Kings/New York County line to the New York County line, and proceeding northerly along the New York County line to a point where the New York County line crosses the westerly prolongation of a straight line drawn perpendicular to West Street from the intersection of West Street and Watts Street, and proceeding easterly along the westerly prolongation of a straight line drawn perpendicular to West Street from the intersection of West Street and Watts Street to West Street, and proceeding northerly along West Street to Canal Street, and proceeding easterly along Canal Street to unnamed I-78 Ramp (TLID<sup>1</sup>:59665150), and proceeding northerly along unnamed I-178 Ramp (TLID:59665150) to Watts Street, and proceeding easterly along Watts Street to Thompson Street, and proceeding northerly along Thompson Street to Bleecker Street, and proceeding westerly along Bleecker Street to 6th Avenue, and proceeding northerly along 6th Avenue to the point of beginning; and

(2) those areas known as Ellis Island and Liberty Island, each of which is a non-contiguous portion of New York County.

## **Second District**

New York City Council District 2 consists of all of that portion of New York County bounded and described as follows: Beginning at the point of intersection of East 35th Street and Madison

### **Ninth District**
